A RESOLUTION**

1 **Encouraging Congress to pass the Concealed Carry Reciprocity Act or a similar bill.**

2 **BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

3 **WHEREAS** the Second Amendment to the Constitution of the United States provides
4 that "the right of the people to keep and bear Arms, shall not be infringed"; and

5 **WHEREAS** the United States Supreme Court has a history of protecting the right of
6 individual citizens to bear arms as provided in the Second Amendment to the Constitution of
7 the United States; and

8 **WHEREAS**, in *District of Columbia v. Heller*, 554 U.S. 570 (2008), the United States
9 Supreme Court held that the Second Amendment protects an individual right to possess a
10 firearm unconnected with service in a militia, and to use that arm for traditionally lawful
11 purposes, such as self-defense within the home; and

12 **WHEREAS** art. I, sec. 19, of the Constitution of the State of Alaska provides that
13 "[t]he individual right to keep and bear arms shall not be denied or infringed by the State or a
14 political subdivision of the State"; and

15 **WHEREAS**, the Alaska State Legislature supports police, troopers, and other law
16 enforcement officials; and

17 **WHEREAS**, where it is legal to do so, a person who may legally possess a concealed

1 firearm may carry a concealed firearm in the state without a concealed carry permit; and

2 **WHEREAS** the state issues permits to carry a concealed handgun as provided in
3 AS 18.65.700 - 18.65.790; and

4 **WHEREAS** art. IV, sec. 1, of the Constitution of the United States provides that
5 every state shall give full faith and credit to the judicial proceedings and records of every
6 other state and that Congress may determine how those records will be proved, and the effect
7 of those records; and

8 **WHEREAS**, under art. IV, sec. 1, Constitution of the United States, states provide
9 reciprocity for legally issued driver's licenses from other states; and

10 **WHEREAS** states that issue concealed carry permits restrict eligibility to persons
11 who are eligible under federal and state laws to legally possess a firearm; and

12 **WHEREAS** states that issue concealed carry permits require the applicant to complete
13 a handgun competency course and display the applicant's ability and knowledge of related
14 responsibilities to legally operate a firearm; and

15 **WHEREAS** states that issue concealed carry permits require applicants to submit
16 fingerprints and pass a criminal background check; and

17 **WHEREAS** 38 states currently recognize valid Alaska concealed handgun permits;

18 **BE IT RESOLVED** that the Alaska State Legislature respectfully requests that the
19 United States Congress pass legislation that determines the manner in which a concealed carry
20 permit issued by one state may be proven in another state, so that an individual in possession
21 of a valid permit may lawfully carry a concealed firearm in another state in the same manner,
22 and to the same degree, that an individual in possession of a valid concealed carry permit
23 from that other state may legally do so; and be it

24 **FURTHER RESOLVED** that the Alaska State Legislature encourages the United
25 States Congress to pass a bill that accomplishes this, such as the Concealed Carry Reciprocity
26 Act (H.R. 38) from the 118th Congress, or a similar bill; and be it

27 **FURTHER RESOLVED** that the Alaska State Legislature respectfully requests that
28 the President of the United States sign into law legislation passed by Congress that
29 accomplishes this, such as the Concealed Carry Reciprocity Act (H.R. 38) from the 118th
30 Congress or a similar bill.

4 Senators, and the Honorable Mary Peltola, U.S. Representative, members of the Alaska
5 delegation in Congress.
