Second Reading

1 Amend reengrossed bill, page 4, after line 24, insert:

2 "(4) A LOCAL GOVERNMENT THAT ENACTS AN ORDINANCE,  
3 REGULATION, OR OTHER LAW PURSUANT TO THIS SECTION SHALL REPORT  
4 TO THE DIVISION OF CRIMINAL JUSTICE IN THE DEPARTMENT OF PUBLIC  
5 SAFETY THAT THE LOCAL GOVERNMENT ENACTED THE ORDINANCE,  
6 REGULATION, OR OTHER LAW."

7 Page 7, line 5, after "PROHIBITED." insert "A LOCAL GOVERNMENT OR  
8 GOVERNING BOARD THAT ENACTS AN ORDINANCE, RESOLUTION, OR OTHER  
9 REGULATION PURSUANT TO THIS SUBSECTION (1)(c) SHALL REPORT TO THE  
10 DIVISION OF CRIMINAL JUSTICE IN DEPARTMENT OF PUBLIC SAFETY THAT  
11 IT ENACTED THE ORDINANCE, RESOLUTION, OR OTHER REGULATION."

12 Page 7, after line 22, insert:

13 "SECTION 6. In Colorado Revised Statutes, add 24-33.5-525 as  
14 follows:

15 **24-33.5-525. Local firearms ordinances report.** THE DIVISION  
16 SHALL COMPILE CRIME STATISTICS FOR ANY LOCAL GOVERNMENT OR  
17 GOVERNING BOARD THAT REPORTS TO THE DIVISION THAT IT HAS ENACTED  
18 A LAW OR REGULATION GOVERNING THE SALE, PURCHASE, TRANSFER, OR  
19 POSSESSION OF A FIREARM PURSUANT TO SECTION 29-11.7-103 OR  
20 PROHIBITING CARRYING A CONCEALED HANDGUN PURSUANT TO SECTION  
21 18-12-214 (1)(c). THE DIVISION SHALL INCLUDE INFORMATION ABOUT  
22 LOCAL GOVERNMENTS OR GOVERNING BOARDS THAT HAVE ENACTED SUCH  
23 LAWS OR REGULATIONS AND THE CRIME STATISTICS FOR THEIR  
24 JURISDICTIONS IN THE DEPARTMENT'S REPORT TO THE COMMITTEES OF  
25 REFERENCE AS PART OF ITS "STATE MEASUREMENT FOR ACCOUNTABLE,  
26 RESPONSIVE, AND TRANSPARENT (SMART) GOVERNMENT ACT"  
27 PRESENTATION REQUIRED BY SECTION 2-7-203."
