2 before line 11, insert:

3 "Page 13 of the reengrossed bill, before line 7, insert:

4 "(6) IF THE REVISOR OF STATUTES RECEIVES NOTICE PURSUANT TO
5 SECTION 33-9-115 (6), THIS SECTION IS REPEALED, EFFECTIVE UPON THE
6 DATE OF THE NOTICE TO THE REVISOR OF STATUTES."."

7 Page 6 of the report, after line 12, insert:

8 "Page 15 of the bill, before line 20, insert:

9 "(6) (a) EACH YEAR, THE DIRECTOR OF LEGISLATIVE COUNCIL
10 SHALL DETERMINE WHETHER ANY REVENUE COLLECTED BY THE STATE
11 PURSUANT TO THIS SECTION OR SECTION 18-12-116 DIRECTLY RESULTS IN
12 A REDUCTION TO TAX REFUNDS TO TAXPAYERS MADE PURSUANT TO
13 SECTION 20 OF ARTICLE X OF THE STATE CONSTITUTION.

14 (b) THIS SECTION, SECTION 18-12-116, AND SECTION 24-35-122
15 WILL BE REPEALED IF ANY REVENUE COLLECTED BY THE STATE PURSUANT
16 TO THIS SECTION OR SECTION 18-12-116 DIRECTLY RESULTS IN A
17 REDUCTION TO TAX REFUNDS TO TAXPAYERS MADE PURSUANT TO SECTION
18 20 OF ARTICLE X OF THE STATE CONSTITUTION. THE DIRECTOR OF
19 RESEARCH OF THE LEGISLATIVE COUNCIL OF THE GENERAL ASSEMBLY
20 SHALL NOTIFY THE REVISOR OF STATUTES IN WRITING IF THE DIRECTOR
21 DETERMINES THAT ANY REVENUE COLLECTED BY THE STATE PURSUANT TO
22 THIS SECTION OR SECTION 18-12-116 DIRECTLY RESULTS IN A REDUCTION
23 TO TAX REFUNDS TO TAXPAYERS BY EMAILING THE NOTICE TO
24 REVISOROFSTATUTES.GA@COLEG.GOV. THIS SECTION, SECTION 18-12-116,
25 AND SECTION 24-35-112 ARE REPEALED, EFFECTIVE UPON THE DATE OF
26 THE NOTICE TO THE REVISOR OF STATUTES."."

27 Page 6 of the report, line 16, before "THE" insert "(1)".

28 Page 6 of the report, strike line 25 and substitute "APPLIES.

29 (2) IF THE REVISOR OF STATUTES RECEIVES NOTICE PURSUANT TO
30 SECTION 33-9-115 (6), THIS SECTION IS REPEALED, EFFECTIVE UPON THE
31 DATE OF THE NOTICE TO THE REVISOR OF STATUTES."."
