1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Repeal of relocated provisions in this act.** In
3 Colorado Revised Statutes, **repeal** article 2 of title 19.

4 **SECTION 2.** In Colorado Revised Statutes, **add with amended**
5 **and relocated provisions** article 2.5 to title 19 as follows:

10 **19-2.5-101. Legislative declaration.** (1) [Formerly 19-2-102 (1)]

11 (a) The general assembly hereby finds that the intent of this article
12 ARTICLE 2.5 is to protect, restore, and improve the public safety by
13 creating a system of juvenile justice that will appropriately sanction
14 juveniles who violate the law and, in certain cases, will also provide the
15 opportunity to bring together affected victims, the community, and
16 juvenile offenders for restorative purposes.

17 (b) The general assembly further finds that, while holding
18 paramount the public safety, the juvenile justice system ~~shall~~ MUST take
19 into consideration the best interests of the juvenile, the victim, and the
20 community in providing appropriate treatment to reduce the rate of
21 recidivism in the juvenile justice system and to assist the juvenile in
22 becoming a productive member of society.

23 (2) [Formerly 19-2-102 (2)] The general assembly hereby finds
24 that the public has the right to safe and secure homes and communities
25 and that when a delinquent act occurs, ~~such~~ safety and security is

1 compromised; and the result is harm to the victim, the community, and
2 the juvenile offender. The general assembly finds that the juvenile justice
3 system should seek to repair such harm and that victims and communities
4 should be provided with the opportunity to elect to participate actively in
5 a restorative process that would hold the juvenile offender accountable
6 for ~~his or her~~ THE offense.

17 Saturdays, Sundays, and legal holidays.

18 **19-2.5-208. [Formerly 19-2-302.5] Petty tickets - summons -**
19 **contracts - data.** (1) (a) If a law enforcement officer contacts a juvenile
20 ten years of age or older for a delinquent act that would be a petty offense
21 if committed by an adult or a municipal ordinance violation, the officer
22 may issue the juvenile a petty ticket that requires the juvenile to go
23 through an assessment process or procedure as designated by the
24 municipal, county, or district court, including assessment by a law
25 enforcement officer, assessment officer, or a screening team, referred to
26 in this section as the "screening entity". When a petty ticket is issued, an
27 assessment officer or screening team officer shall offer a petty offense

1 contract to the juvenile and the juvenile's parent or legal guardian if:

2 (I) The juvenile has no prior adjudication or non-traffic conviction
3 in a municipal, county, juvenile, or district court;

4 (II) The alleged offense would be a class 1, class 2, or unclassified
5 petty offense;

6 (III) The juvenile admits to the offense; and

7 (IV) The petty offense contract is in the best interests of the
8 juvenile.

9 (b) If the juvenile is otherwise eligible for a petty offense contract
10 pursuant to ~~the provisions of~~ this subsection (1), but the screening entity
11 finds that the issuance of a petty offense contract is not in the best
12 interests of the juvenile, the screening entity shall state the reasons in
13 writing. The screening entity shall provide a copy of the written statement
14 to the juvenile and shall maintain a copy of the written statement. If there
15 is no agreement resulting in a signed contract pursuant to this section, the
16 prosecuting attorney may file a petition of delinquency.

17 (2) Every contract entered into pursuant to this section must be in
18 writing and contain the following:

19 (a) Consent to the contract terms by the juvenile and the juvenile's
20 parent or legal guardian;

21 (b) An agreement to pay restitution, when applicable;

22 (c) An agreement to perform useful community service, when
23 applicable;

24 (d) An agreement to attend school unless the juvenile is in a
25 certified home study program or is otherwise legally excused from such
26 attendance;

27 (e) A requirement of restorative justice practices, when

1 appropriate;

2 (f) A requirement that the juvenile not commit a delinquent act
3 during the term of the contract; and

4 (g) Any other conditions determined appropriate by the screening
5 entity.

6 (3) The term of the contract may not exceed ~~ninety~~ NINETY-ONE
7 days; except that the contract may be extended for an additional ~~thirty~~
8 THIRTY-FIVE days for good cause.

9 (4) Upon the successful completion of the contract to the
10 satisfaction of the screening entity, the juvenile is released from any
11 further obligation, and the prosecuting attorney shall not file a petition in
12 delinquency for the admitted act. The completed contract remains
13 confidential except to the ticketing agency, the screening and supervisory
14 entity, the juvenile, and the juvenile's parent or legal guardian.

15 (5) (a) If a juvenile fails to comply with a written condition of the
16 contract within a specific time designated in the contract, the prosecuting
17 attorney may file charges with the court. The contract and any statements
18 contained in the contract or made by the juvenile to the screening entity
19 administering the contract ~~shall~~ MUST not be used against the juvenile.

20 (b) If there is no agreement resulting in a signed contract, any
21 statement made by the juvenile to the screening entity administering the
22 assessment ~~shall~~ MUST not be used against the juvenile.

23 (c) Notwithstanding ~~the provisions of paragraphs (a) and (b) of~~
24 ~~this subsection (5)~~ SUBSECTIONS (5)(a) AND (5)(b) OF THIS SECTION,
25 statements or admissions of a juvenile contained in the contract or made
26 by the juvenile to the screening entity are admissible into evidence, if the
27 juvenile makes any deliberate misrepresentations affecting the

1 applicability or requirements of this section.

2 (6) (a) Each law enforcement agency that issues petty offense
3 tickets pursuant to ~~the provisions of~~ this section shall maintain annual
4 data on the number of tickets issued and the age, ethnicity, gender, and
5 final disposition for each ticket.

6 (b) The data collected pursuant to ~~paragraph (a) of this subsection~~
7 ~~(6)~~ SUBSECTION (6)(a) OF THIS SECTION is public and must be made
8 available upon request.

9 **19-2.5-209. [Formerly 19-2-502] Taking juvenile into custody.**

10 (1) A juvenile may be taken into temporary custody by a law
11 enforcement officer without order of the court when there are reasonable
12 grounds to believe that ~~he or she~~ THE JUVENILE has committed a
13 delinquent act.

14 (2) A juvenile may be taken into temporary custody by a law
15 enforcement officer executing a lawful warrant taking a juvenile into
16 custody issued pursuant to ~~section 19-2-503~~ SECTION 19-2.5-204.

17 (3) A juvenile probation officer may take a juvenile into
18 temporary custody:

19 (a) Under the circumstances stated in subsection (1) of this
20 section; or

21 (b) If ~~he or she~~ THE JUVENILE has violated the conditions of
22 probation and is under the continuing jurisdiction of the juvenile court.

23 (4) A juvenile may be detained temporarily by an adult other than
24 a law enforcement officer if the juvenile has committed or is committing
25 a delinquent act in the presence of such adult. Any person detaining a
26 juvenile shall notify, without unnecessary delay, a law enforcement
27 officer, who shall assume custody of said juvenile.

1 (5) The taking of a juvenile into temporary custody ~~under~~
2 PURSUANT TO this section is not an arrest, nor does it constitute a police
3 record.

4 PART 3

5 DETENTION

6 **19-2.5-301. [Formerly 19-2-211.5] Legislative declaration.** The
7 general assembly declares that the placement of children AND JUVENILES
8 in a detention facility exacts a negative impact on the mental and physical
9 well-being of the child OR JUVENILE, and such detention may make it
10 more likely that the child OR JUVENILE will reoffend. Children AND
11 JUVENILES who are detained are more likely to penetrate deeper into the
12 juvenile justice system than similar children OR JUVENILES who are not
13 detained, and community-based alternatives to detention should be based
14 on the principle of using the least-restrictive setting possible and
15 returning a child OR JUVENILE to his or her home, family, or other
16 responsible adult whenever possible consistent with public safety. It is the
17 intent of the general assembly in adopting ~~section 19-2-507.5~~ SECTION
18 19-2.5-304 and amending ~~sections 19-2-212, 19-2-507, and 19-2-508~~
19 SECTIONS 19-2.5-303, 19-2.5-305, AND 19-2.5-1404 to limit the use of
20 detention to only those children AND JUVENILES who pose a substantial
21 risk of serious harm to others or that are a flight risk from prosecution.

22 **19-2.5-302. [Formerly 19-2-211] Local juvenile services**
23 **planning committee - creation - duties - identification and notification**
24 **of dually identified crossover youth.** (1) If all of the boards of
25 commissioners of each county or the city council of each city and county
26 in a judicial district agree, there may be created in the judicial district a
27 local juvenile services planning committee that is appointed by the chief

1 judge of the judicial district or, for the second judicial district, the
2 presiding judge of the Denver juvenile court, from persons recommended
3 by the boards of commissioners of each county or the city council of each
4 city and county within the judicial district. The committee, if practicable,
5 must include, but need not be limited to, a representative from ~~the~~ A
6 county department of human or social services, a local school district, a
7 local law enforcement agency, a local probation department, the division
8 of youth services, private citizens, the district attorney's office, ~~and~~ the
9 public defender's office, ~~and~~ a community mental health representative,
10 and a representative of the concerns of municipalities. The committee, if
11 created, shall meet as necessary to develop a plan for the allocation of
12 resources for local juvenile services within the judicial district for the
13 fiscal year. The committee is strongly encouraged to consider programs
14 with restorative justice components when developing the plan. THE STATE
15 DEPARTMENT OF HUMAN SERVICES SHALL APPROVE the plan. ~~must be~~
16 ~~approved by the state department of human services.~~ A local juvenile
17 services planning committee may be consolidated with other local
18 advisory boards pursuant to section 24-1.7-103.

19 (2) The plan must provide for the management of dually identified
20 crossover youth. The plan must contain descriptions and processes to
21 include: ~~the following:~~

22 (a) A process for the identification of dually identified crossover
23 youth at the earliest reasonable point of contact;

24 (b) A method for collaborating and exchanging information with
25 other judicial districts, including with the collaborative management
26 program described in section 24-1.9-102 and consistent with the
27 data-sharing policies of the collaborative management program;

1 (c) A process for promptly communicating information about the
2 youth's crossover status between the child welfare and juvenile justice
3 systems and to notify each other of the new involvement in the respective
4 system or information that may aid in the identification of dually
5 identified crossover youth. The following parties should be notified of a
6 ~~juvenile's~~ YOUTH'S status as a dually identified crossover youth if
7 applicable: Public defenders, district attorneys, local juvenile services
8 planning committee coordinators, human or social services DEPARTMENT
9 representatives, probation representatives, juvenile court representatives,
10 parents, and guardians ad litem.

11 (d) A process for identifying the appropriate services or
12 placement-based assessment for a dually identified crossover youth;

13 (e) A process for sharing and gathering information in accordance
14 with applicable laws, rules, and county policy;

15 (f) A process for the development of a single case management
16 plan and identification of the lead agency for case management purposes
17 and the engagement of dually identified crossover youth and their
18 caregivers;

19 (g) A process that facilitates the sharing of assessments and case
20 planning information and includes policies around sharing information
21 with other judicial districts;

22 (h) A process for a multidisciplinary group of professionals to
23 consider decisions that ~~include: Youth~~ INCLUDE YOUTH and community
24 safety, placement, provision of needed services, alternatives to detention
25 and commitment, probation, parole, permanency, education stability, and
26 case closure; and

27 (i) A requirement that dually identified crossover youth placed in

1 a secure detention facility who are deemed eligible for release by the
2 court be placed in the least restrictive setting whenever possible to reduce
3 the disparity between dually identified crossover youth and nondually
4 identified crossover youth in secure detention.

5 **19-2.5-303. [Formerly 19-2-507] Duty of officer - screening**
6 **teams - notification - release or detention.** (1) When a juvenile is taken
7 into temporary custody and not released pending charges, the officer shall
8 notify the screening team for the judicial district in which the juvenile is
9 taken into custody. The screening team shall notify the juvenile's parent,
10 guardian, or legal custodian without unnecessary delay and inform ~~him~~
11 ~~or her~~ THE JUVENILE'S PARENT, GUARDIAN, OR LEGAL CUSTODIAN that, if
12 the juvenile is placed in detention or a temporary holding facility, all
13 parties have a right to a prompt hearing to determine whether the juvenile
14 is to be detained further. Such notification may be made to a person with
15 whom the juvenile is residing if a parent, guardian, or legal custodian
16 cannot be located. If the screening team is unable to make such
17 notification, ~~it~~ THE NOTIFICATION may be made by any law enforcement
18 officer, juvenile probation officer, detention center counselor, or ~~common~~
19 ~~jailor~~ DETENTION FACILITY STAFF in whose physical custody the juvenile
20 is placed.

21 (2) (a) If the law enforcement officer does not release the juvenile
22 to the care of ~~such~~ THE juvenile's parents, legal guardian, kin, or other
23 responsible adult, the screening team shall administer a validated
24 detention screening instrument developed or adopted pursuant to ~~section~~
25 ~~19-2-212~~ SECTION 19-2.5-1404. The law enforcement officer, screening
26 team, or juvenile court shall not remove the juvenile from the custody of
27 the parent or legal guardian pursuant to this section unless the screening

1 team or the juvenile court:

2 (I) (A) First finds that a validated detention screening instrument
3 selected or adopted pursuant to ~~section 19-2-212~~ SECTION 19-2.5-1404
4 has been administered and the juvenile scored as detention-eligible; or

5 (B) There are grounds to override the results of the detention
6 screening instrument based on the criteria developed in accordance with
7 ~~section 19-2-212~~ SECTION 19-2.5-1404; and

8 (II) Finds that the juvenile poses a substantial risk of serious harm
9 to others or a substantial risk of flight from prosecution and finds that
10 community-based alternatives to detention are insufficient to reasonably
11 mitigate that risk. Flight from prosecution is distinguished from simple
12 failure to appear and must generally be evidenced by a demonstrated
13 record of repeat, recent willful failures to appear at a scheduled court
14 appearance.

15 (b) THE SCREENING TEAM SHALL ADMINISTER the detention
16 screening instrument ~~must be administered by the screening team~~ for each
17 juvenile under consideration for detention. ~~and~~ THE DETENTION
18 SCREENING INSTRUMENT must be administered by a screener who has
19 completed training to administer the detention screening instrument.

20 (c) Any information concerning a juvenile that is obtained during
21 the administration of the detention screening instrument must be used
22 solely for the purpose of making a recommendation to the court regarding
23 the continued detention of the juvenile. The information is not subject to
24 subpoena or other court process, for use in any other proceeding, or for
25 any other purpose.

26 (d) Court records and division of youth services records must
27 include data on detention screening scores and, if the score does not

1 mandate detention, the explanation for the override placing the juvenile
2 in detention.

3 (e) A juvenile who must be taken from ~~his or her~~ THE JUVENILE'S
4 home but who does not require physical restriction must be given
5 temporary care with ~~his or her~~ A grandparent, kin, or other suitable
6 person; in a temporary shelter facility designated by the court; or with the
7 county department of human or social services and must not be placed in
8 detention.

9 (f) The screening team and the juvenile court shall use the results
10 from the detentiohn screening instrument in making a release
11 determination. Release options include allowing a juvenile to return home
12 with no supervision, or with limited supervision such as a location
13 monitoring device, or a referral to a preadjudication alternative to
14 detention or service program established pursuant to ~~section 19-2-302~~
15 SECTION 19-2.5-606.

16 (3) (a) The juvenile must be released to the care of the juvenile's
17 parents, kin, or other responsible adult, unless a determination has been
18 made in accordance with subsection (2) of this section that the juvenile's
19 substantial risk of serious harm to others requires that the juvenile be
20 detained. The court may make reasonable orders as conditions of release
21 pursuant to ~~section 19-2-508 (5)~~ SECTION 19-2.5-305 (5). In addition, the
22 court may provide that any violation of such orders may subject the
23 juvenile to contempt sanctions of the court. The parent, kin, or other
24 person to whom the juvenile is released is required to sign a written
25 promise, on forms supplied by the court, to bring the juvenile to the court
26 at a time set or to be set by the court. Failure, without good cause, to
27 comply with the promise subjects the juvenile's parent or any other person

1 to whom the juvenile is released to contempt sanctions of the court.

2 (b) Parents or legal guardians of a juvenile released from
3 detention pursuant to this section shall complete the relative information
4 form described in ~~section 19-2-212 (1)(h)~~ SECTION 19-2.5-1404
5 (1)(b)(VIII) no later than the next hearing on the matter.

6 (4) (a) Except as ~~provided~~ REQUIRED in subsection (4)(b) of this
7 section, a law enforcement officer shall not detain a juvenile any longer
8 than is reasonably necessary to obtain basic identification information and
9 to contact ~~his or her~~ THE JUVENILE'S parents, guardian, or legal custodian.

10 (b) If ~~he or she~~ THE JUVENILE is not released as ~~provided~~
11 REQUIRED in subsection (3) of this section, ~~he or she~~ THE JUVENILE must
12 be taken directly to the court or to the place of detention, a temporary
13 holding facility, a temporary shelter designated by the court, or a
14 preadjudication service program established pursuant to ~~section 19-2-302~~
15 SECTION 19-2.5-606 without unnecessary delay.

16 (5) (a) As an alternative to taking a juvenile into temporary
17 custody pursuant to subsections (1), (3), and (4) of this section, a law
18 enforcement officer may, if authorized by the establishment of a policy
19 that permits such service by order of the chief judge of the judicial district
20 or the presiding judge of the Denver juvenile court, which policy is
21 established after consultation between such judge and the district attorney
22 and law enforcement officials in the judicial district, serve a written
23 promise to appear for juvenile proceedings based on any act that would
24 constitute a felony, misdemeanor, or petty offense upon the juvenile and
25 the juvenile's parent, guardian, or legal custodian.

8 resources to retain counsel or the juvenile's parent, guardian, or legal
9 custodian refuses to retain counsel for the juvenile;

10 (III) That, to determine if the juvenile is eligible for
11 court-appointed counsel, or to apply for court-appointed counsel, the
12 juvenile's parent, guardian, or legal custodian is advised to call the office
13 of the state public defender, visit the state public defender's office, or visit
14 the state public defender's internet website;

15 (IV) That, to avoid delay in obtaining counsel, the juvenile's
16 parent, guardian, or legal custodian is advised to apply for
17 court-appointed counsel at least five days, EXCLUDING SATURDAYS,
18 SUNDAYS, AND LEGAL HOLIDAYS, before the juvenile's promised date of
19 appearance; and

20 (V) The contact information for the local office of the state public
21 defender, including the office's telephone number and address, and the
22 address of the internet website of the office of the state public defender.

23 ~~(b.5)~~ (c) A law enforcement officer who serves a juvenile or a
24 juvenile's parent, guardian, or legal custodian with a written promise to
25 appear in a court that participates in the court reminder program
26 established in section 13-3-101 (14)(a)(I) shall notify the person served
27 that the juvenile and the juvenile's parent, guardian, or legal custodian can

1 elect to provide a mobile telephone number that will be used by the court
2 solely to provide text message reminders for future court dates and
3 unplanned court closures and shall provide the opportunity for the
4 juvenile and the juvenile's parent, guardian, or legal custodian to provide
5 a mobile telephone number or update a mobile telephone number for that
6 purpose.

7 ~~(c)~~ (d) THE JUVENILE SHALL SIGN the promise to appear. ~~shall be~~
8 ~~signed by the juvenile.~~ The promise to appear shall MUST be served upon
9 the juvenile's parent, guardian, or legal custodian by personal service or
10 by certified mail, return receipt requested. The date established for the
11 juvenile and the juvenile's parent, guardian, or legal custodian to appear
12 ~~shall~~ MUST not be earlier than seven days nor later than ~~thirty~~ THIRTY-FIVE
13 days after the promise to appear is served upon both the juvenile and the
14 juvenile's parent, guardian, or legal custodian.

15 **19-2.5-304. [Formerly 19-2-507.5] Limitations on detention.**

16 (1) Detention is not permitted for the following:

17 (a) Juveniles who have not committed, or have not been accused
18 of committing, a delinquent act unless otherwise found in contempt of
19 court;

20 (b) Delinquent and nondelinquent juveniles who have been placed
21 in the legal custody of a county department of human or social services
22 pursuant to a petition in dependency or neglect and are solely awaiting
23 out-of-home placement;

24 (c) Juveniles who at admission require medical care, are
25 intoxicated, or are under the influence of drugs, to an extent that custody
26 of the juvenile is beyond the scope of the detention facility's medical
27 service capacity;

1 (d) Juveniles who are solely assessed as suicidal or exhibit
2 behavior placing them at imminent risk of suicide; and

3 (e) Juveniles who have not committed a delinquent act but present
4 an imminent danger to self or others or appear to be gravely disabled as
5 a result of a mental health ~~condition~~ DISORDER or an intellectual and
6 developmental disability.

7 (2) A juvenile court shall not order a juvenile who is ten years of
8 age and older but less than thirteen years of age to detention unless the
9 juvenile has been arrested for a felony or weapons charge pursuant to
10 section 18-12-102, 18-12-105, 18-12-106, or 18-12-108.5. A
11 preadjudication service program created pursuant to ~~section 19-2-302~~
12 SECTION 19-2.5-606 shall evaluate a juvenile described in this subsection
13 (2). The evaluation may result in the juvenile:

14 (a) Remaining in the custody of a parent or legal guardian;

15 (b) Being placed in the temporary legal custody of kin, for
16 purposes of a kinship foster care home or noncertified kinship care
17 placement, as defined in ~~section 19-1-103 (71.3)~~ SECTION 19-1-103, or
18 other suitable person under such conditions as the court may impose;

19 (c) Being placed in a temporary shelter facility; or

20 (d) Being referred to a local county department of human or social
21 services for assessment for placement.

22 (3) A juvenile shall not be placed in detention solely:

23 (a) Due to lack of supervision alternatives, service options, or
24 more appropriate facilities;

25 (b) Due to the community's inability to provide treatment or
26 services;

27 (c) Due to a lack of supervision in the home or community;

- 1 (d) In order to allow a parent, guardian, or legal custodian to avoid
2 ~~his or her~~ legal responsibility;
- 3 (e) Due to a risk of the juvenile's self-harm;
- 4 (f) In order to attempt to punish, treat, or rehabilitate the juvenile;
- 5 (g) Due to a request by a victim, law enforcement, or the
6 community;
- 7 (h) In order to permit more convenient administrative access to the
8 juvenile;
- 9 (i) In order to facilitate further interrogation or investigation; or
- 10 (j) As a response to technical violations of probation unless the
11 results of a detention screening instrument indicate that the juvenile poses
12 a substantial risk of serious harm to others or if the applicable graduated
13 responses system adopted pursuant to ~~section 19-2-925~~ SECTION
14 19-2.5-1108 allows for such a placement.

15 **19-2.5-305. [Formerly 19-2-508] Detention and shelter -**
16 **hearing - time limits - findings - review - confinement with adult**
17 **offenders - restrictions.** (1) Unless placement is prohibited pursuant to
18 ~~section 19-2-507.5~~ SECTION 19-2.5-304, when a juvenile is placed in a
19 detention facility, in a temporary holding facility, or in a temporary
20 shelter facility designated by the court, the screening team shall promptly
21 notify the court, the district attorney, and the local office of the state
22 public defender. The screening team shall also notify a parent or legal
23 guardian or, if a parent or legal guardian cannot be located within the
24 county, the person with whom the juvenile has been residing and inform
25 ~~him or her~~ SUCH PERSON of the right to a prompt hearing to determine
26 whether the juvenile is to be detained further. The court shall hold the
27 detention hearing within forty-eight hours, excluding Saturdays, Sundays,

1 and legal holidays. For a juvenile being held in detention on a warrant for
2 violating a valid court order on a status offense, the court shall hold the
3 detention hearing within twenty-four hours, excluding Saturdays,
4 Sundays, and legal holidays.

5 (2) A juvenile who is detained for committing a delinquent act
6 must be represented at the detention hearing by counsel. If the juvenile
7 has not retained his or her own counsel, the court shall appoint the office
8 of the state public defender or, in the case of a conflict, the office of
9 alternate defense counsel to represent the juvenile. This appointment
10 continues if the court appoints the office of the state public defender or
11 the office of alternate defense counsel pursuant to ~~section 19-2-706 (2)(a)~~
12 SECTION 19-2.5-605 (2)(a) unless:

13 (a) The juvenile retains his or her own counsel; or

14 (b) The juvenile makes a knowing, intelligent, and voluntary
15 waiver of ~~his or her~~ THE right to counsel, as described in ~~section 19-2-706~~
16 ~~(2)(c)~~ SECTION 19-2.5-605 (2)(c).

17 (3) (a) (I) A juvenile taken into custody pursuant to this ~~article 2~~
18 ARTICLE 2.5 and placed in a detention or temporary shelter facility or a
19 temporary holding facility is entitled to a hearing within forty-eight hours
20 AFTER SUCH PLACEMENT, excluding Saturdays, Sundays, and legal
21 holidays, ~~of such placement~~ to determine if ~~he or she~~ THE JUVENILE
22 should be detained. The time of the detention hearing must allow defense
23 counsel sufficient time to consult with the juvenile before the detention
24 hearing. This consultation may be performed by secure electronic means
25 if the conditions under which the electronic consultation is held allow the
26 consultation to be confidential. The time in which the hearing must be
27 held may be extended for a reasonable time by order of the court upon

1 good cause shown.

2 (II) The law enforcement agency that arrested the juvenile shall
3 promptly provide to the court and to defense counsel the affidavit
4 supporting probable cause for the arrest and the arrest report, if the arrest
5 report is available, and the screening team shall promptly provide to the
6 court and to defense counsel results from the detention risk screening
7 prepared pursuant to the juvenile's arrest. Upon completion of the
8 detention hearing, the defense shall return any materials received pursuant
9 to this subsection (3)(a)(II) unless the appointment is continued at the
10 conclusion of the hearing.

11 (III) The only purposes of a detention hearing are to determine if
12 a juvenile should be detained further and to define conditions under
13 which ~~he or she~~ THE JUVENILE may be released, if ~~his or her~~ release is
14 appropriate. A detention hearing ~~shall~~ MUST not be combined with a
15 preliminary hearing or a first advisement. Due to the limited scope of a
16 detention hearing, the representation of a juvenile by appointed counsel
17 at a detention hearing does not, by itself, create a basis for disqualification
18 in the event that such counsel is subsequently appointed to represent
19 another individual whose case is related to the juvenile's case.

20 (IV) With respect to this section, the court may further detain the
21 juvenile only if the court finds from the information provided at the
22 hearing that:

23 (A) Probable cause exists to believe that THE JUVENILE
24 COMMITTED the delinquent act charged; ~~was committed by the juvenile;~~

25 (B) On and after ~~thirty~~ THIRTY-FIVE days after the screening
26 instrument has been developed or adopted pursuant to ~~section 19-2-212~~
27 SECTION 19-2.5-1404, the validated detention screening instrument has

1 been administered and the juvenile scored as detention-eligible; or there
2 are grounds to override the result of the detention screening instrument
3 based on the criteria developed in accordance with ~~section 19-2-212~~
4 SECTION 19-2.5-1404; and

5 (C) The juvenile poses a substantial risk of serious harm to others
6 or a substantial risk of flight from prosecution and community-based
7 alternatives to detention are insufficient to reasonably mitigate that risk.
8 Flight from prosecution is distinguished from simple failure to appear and
9 must generally be evidenced by a demonstrated record of repeat, recent
10 willful failures to appear at a scheduled court appearance.

11 (V) A court shall not order further detention for a juvenile who is
12 ten years of age and older but less than thirteen years of age unless the
13 juvenile has been arrested or adjudicated for a felony or weapons charge
14 pursuant to section 18-12-102, 18-12-105, 18-12-106, or 18-12-108.5.
15 The court shall receive any information having probative value regardless
16 of its admissibility under the rules of evidence. In determining whether
17 a juvenile requires detention, the court shall consider the results of the
18 detention screening instrument. There is a rebuttable presumption that a
19 juvenile poses a substantial risk of serious harm to others if:

20 (A) The juvenile is alleged to have committed a felony
21 enumerated as a crime of violence pursuant to section 18-1.3-406; or

22 (B) The juvenile is alleged to have used, or possessed and
23 threatened to use, a firearm during the commission of any felony offense
24 against a person, as such offenses are described in article 3 of title 18; or

25 (C) The juvenile is alleged to have committed possessing a
26 dangerous or illegal weapon, as described in section 18-12-102;
27 possession of a defaced firearm, as described in section 18-12-103;

1 unlawfully carrying a concealed weapon, as described in section
2 18-12-105; unlawfully carrying a concealed weapon on school, college,
3 or university grounds, as described in section 18-12-105.5; prohibited use
4 of weapons, as described in section 18-12-106; illegal discharge of a
5 firearm, as described in section 18-12-107.5; or illegal possession of a
6 handgun by a juvenile, as described in section 18-12-108.5.

7 (VI) Notwithstanding ~~the provisions of~~ subsection (3)(a)(IV) of
8 this section, there is no presumption ~~under~~ PURSUANT TO subsection
9 (3)(a)(V) of this section that a juvenile poses a substantial risk of serious
10 harm to others if the item in the possession of the juvenile is alleged to be
11 a BB gun, a pellet gun, or a gas gun.

12 (VII) Except as provided in subsection (3)(a)(IX) of this section,
13 at the conclusion of the hearing, the court shall enter one of the following
14 orders, while ensuring efforts are made to keep the juvenile with ~~his or~~
15 ~~her~~ A parent, guardian, or legal custodian:

16 (A) That the juvenile be released to the custody of a parent,
17 guardian, legal custodian, kin, or other suitable person without the posting
18 of bond;

19 (B) That the juvenile be placed in a temporary shelter facility;

20 (C) That bail be set and that the juvenile be released upon the
21 posting of that bail;

22 (D) That no bail be set and that the juvenile be detained without
23 bail upon a finding that ~~such~~ THE juvenile poses a substantial risk of
24 serious harm to others. ~~Any~~ A juvenile who is detained without bail must
25 be tried on the charges in the petition filed pursuant to subsection
26 (3)(a)(IX) of this section within the time limits set forth in ~~section~~
27 ~~19-2-108~~ SECTION 19-2.5-904, unless the juvenile is deemed to have

1 waived the time limit for an adjudicatory trial pursuant to ~~section~~
2 ~~19-2-107(4)~~ SECTION 19-2.5-610 (4).

3 (E) That no bail be set and that, upon the court's finding that the
4 juvenile poses a substantial risk of serious harm to others, the juvenile be
5 placed in a preadjudication service program established pursuant to
6 ~~section 19-2-302~~ SECTION 19-2.5-606. This subsection (3)(a)(VII)(E) does
7 not apply to any case in which the juvenile's alleged offense is one of the
8 offenses described in ~~subsection (3)(a)(IV)~~ SUBSECTION (3)(a)(V) of this
9 section.

10 (VIII) A preadjudication service program created pursuant to
11 ~~section 19-2-302~~ SECTION 19-2.5-606 shall evaluate a juvenile described
12 in subsection (8) of this section. The evaluation may result in the juvenile:

13 (A) Remaining in the custody of a parent, guardian, or legal
14 custodian; or

15 (B) Being placed in the temporary legal custody of kin, for
16 purposes of a kinship foster care home or noncertified kinship care
17 placement, as defined in ~~section 19-1-103 (71.3)~~ SECTION 19-1-103, or
18 other suitable person under such conditions as the court may impose; or

19 (C) Being placed in a temporary shelter facility; or

20 (D) Being referred to a local county department of human or
21 social services for assessment for placement.

22 (IX) When the court orders further detention of the juvenile or
23 placement of the juvenile in a preadjudication service program after a
24 detention hearing, the district attorney shall file a petition alleging the
25 juvenile to be a delinquent within seventy-two hours after the detention
26 hearing, excluding Saturdays, Sundays, and legal holidays. The juvenile
27 must be held or must participate in a preadjudication service program

1 pending a hearing on the petition. Upon a showing of good cause, the
2 court may extend such time for the filing of charges.

3 (X) Following the detention hearing, if the court orders that the

1 in a detention or temporary shelter facility pursuant to ~~the provisions of~~
2 this ~~article 2~~ ARTICLE 2.5 may have a ____ mental health disorder, as
3 provided in sections 27-65-105 and 27-65-106, the intake personnel or
4 other appropriate personnel shall contact a ____ mental health professional
5 to do a mental health hospital placement prescreening on the juvenile.
6 The court ~~shall~~ MUST be notified of the contact and may take appropriate
7 action. If a mental health hospital placement prescreening is requested, it
8 must be conducted in an appropriate place accessible to the juvenile and
9 the ____ mental health professional. A request for a mental health hospital
10 placement prescreening must not extend the time within which a

21 court finds, after a hearing held pursuant to subsection (3)(c)(IV),

24 (III) In determining whether an adult jail is the appropriate place
25 of confinement for the juvenile, the district court shall consider the

10 defense counsel;

11 (D) Whether detention in a juvenile facility will adequately serve
12 the need for community protection pending the outcome of the criminal
13 proceedings;

14 (E) Whether detention in a juvenile facility will negatively impact
15 the functioning of the juvenile facility by compromising the goals of
16 detention to maintain a safe, positive, and secure environment for all
17 juveniles within the facility;

18 (F) The relative ability of the available adult and juvenile
19 detention facilities to meet the JUVENILE'S needs, ~~of the juvenile~~;
20 including the juvenile's need for mental health and educational services;

21 (G) Whether the juvenile presents an imminent risk of serious
22 harm to others within a juvenile facility;

23 (H) The JUVENILE'S physical maturity; ~~of the juvenile~~; and

24 (I) Any other relevant factors.

25 (IV) After charges are filed directly in district court against a
26 juvenile pursuant to ~~section 19-2-517~~ SECTION 19-2.5-801 or a juvenile
27 is transferred to district court pursuant to ~~section 19-2-518~~ SECTION

1 19-2.5-802, the division of youth services may petition the district court
2 to transport the juvenile to an adult jail. The district court shall hold a
3 hearing on the place of pretrial detention for the juvenile as soon as
4 practicable, but no later than twenty-one days after the receipt of the
5 division's petition to transport. The district attorney, sheriff, or juvenile
6 may file a response to the petition and participate in the hearing. The
7 juvenile ~~shall remain~~ REMAINS in a juvenile detention facility pending

25 educational services to the juveniles in the jail or facility and the number
26 of hours for which school districts provided the educational services each
27 day;

1 (E) The number of juveniles in the jail or facility who were
2 exempt from receiving educational services pursuant to section 22-32-141
3 (2)(c), (2)(e), (2)(f), and (2)(g);

4 (F) The number of juveniles in the jail or facility who had
5 previously been determined pursuant to section 22-20-108 to be eligible
6 for special education services and had an individualized education
7 program; and

8 (G) The number of juveniles in the jail or facility who, while
9 receiving educational services at the jail or facility, were determined
10 ~~pursuant to section 22-20-108~~ to be eligible for special education services
11 PURSUANT TO SECTION 22-20-108 and had subsequently received an
12 individualized education program.

13 (IV) The official in charge of the jail or facility shall submit the
14 information collected pursuant to subsection (4)(c)(III) of this section to
15 the division of criminal justice in the department of public safety. The
16 division of criminal justice shall make the information available to a
17 member of the public upon request.

18 (d) The official in charge of a jail or other facility for the
19 detention of adult offenders shall immediately inform the court that has
20 jurisdiction of the juvenile's alleged offense when a juvenile who is or
21 appears to be under eighteen years of age is received at the facility, except

9 a condition that the released juvenile appear at any place and upon any

21 2.5, or disposition of a juvenile delinquent pursuant to ~~section 19-2-907~~
22 SECTION 19-2.5-1103, the district attorney may agree to allow a juvenile
23 to participate in a diversion program established in accordance with
24 ~~section 19-2-303~~ SECTION 19-2.5-402.

25 **19-2.5-402. [Formerly 19-2-303] Juvenile diversion program -**
26 **authorized - report - legislative declaration - definitions.** (1) (a) In
27 order to more fully implement the stated objectives of this title 19, the

1 general assembly declares its intent to establish a juvenile diversion
2 program that, when possible, integrates restorative justice practices to
3 provide community-based alternatives to the formal court system that will
4 reduce juvenile crime and recidivism and improve positive juvenile
5 outcomes, change juvenile offenders' behavior and attitudes, promote
6 juvenile offenders' accountability, recognize and support the rights of
7 victims, heal the harm to relationships and the community caused by
8 juvenile crime, and reduce the costs within the juvenile justice system.

9 (b) Research has shown that court involvement for juveniles not
10 identified as a risk of harm to others is harmful, and most low-risk
11 juveniles grow out of their behavior and stop reoffending without system
12 intervention.

13 (c) The goals of the diversion programs are to:

14 (I) Prevent further involvement of ~~the~~ A juvenile in the formal
15 legal system;

16 (II) Provide AN eligible ~~juveniles~~ JUVENILE with cost-effective
17 alternatives to adjudication that require the least amount of supervision
18 and restrictive conditions necessary consistent with public safety and the
19 juvenile's risk of reoffending;

20 (III) Serve the best interest of ~~the~~ A juvenile while emphasizing
21 acceptance of responsibility and repairing any harm caused to victims and
22 communities;

23 (IV) Reduce recidivism and improve positive outcomes for
24 ~~juveniles~~ EACH JUVENILE through the provision of services, if warranted,
25 that address ~~their~~ THE JUVENILE'S specific needs and are proven effective;
26 and

27 (V) Ensure appropriate services are available for all eligible

1 juveniles.

2 (2) The division of criminal justice of the department of public
3 safety, REFERRED TO IN THIS SECTION AS THE "DIVISION OF CRIMINAL
4 JUSTICE", is authorized to establish and administer a juvenile diversion
5 program that seeks to divert ~~youth~~ JUVENILES from the juvenile justice
6 system, and, when possible, integrates restorative justice practices. In
7 order to effectuate the program, the division shall allocate money to each
8 judicial district and may contract with district attorneys' offices,
9 governmental units, and nongovernmental agencies for reasonable and
10 necessary expenses and services to serve each judicial district to divert
11 juveniles and provide services, if warranted, for EACH eligible juveniles
12 JUVENILE through community-based programs providing an alternative to
13 a petition filed pursuant to ~~section 19-2-512~~ SECTION 19-2.5-502 or an

1 GENERAL COUNSELING AND COUNSELING DURING A CRISIS SITUATION,

13 district attorney's office shall conduct the risk screening or contract with

23 (e) Collect and submit data to the division of criminal justice
24 pursuant to subsection (5) of this section.

25 (5) The division of criminal justice, in collaboration with district
26 attorneys or diversion program directors who accept formula money and
27 programs providing juvenile diversion services, shall establish minimum

1 data collection requirements and outcome measures that each district
2 attorney's office, governmental unit, and nongovernmental agency shall
3 collect and submit annually for all juveniles referred to the district

11 **19-2.5-701 [Formerly 19-2-1300.2] Legislative declaration.**

- 12 (1) The general assembly finds and declares that:
13 (a) The juvenile justice system is civil in nature and focused on
14 rehabilitation rather than punishment;
15 (b) Juveniles differ in significant and substantive ways from
16 adults; therefore, different standards for competency are necessary for
17 juveniles and adults; and
18 (c) Notwithstanding the differences between adults and juveniles,
19 age alone is not determinative of incompetence without a finding that the
20 juvenile actually lacks the relevant capacities for competence.

21 **19-2.5-702. [Formerly 19-2-1301] Incompetent to proceed -**
22 **effect - how and when raised.** (1) ~~The provisions of this part 13 shall~~
23 ~~only apply~~ THIS PART 7 APPLIES ONLY to proceedings ~~under this title~~
24 BROUGHT PURSUANT TO THIS TITLE 19.

25 (2) A juvenile ~~shall~~ MUST not be tried or sentenced if the juvenile

3 juvenile referred for a competency examination, the court may declare a

16 plan is necessary, the court shall develop the management plan after

23 (1) "Minor offense" means any offense denominated a
24 misdemeanor in title 18 ~~C.R.S.~~, or violation of a municipal ordinance
25 where the maximum penalty authorized does not exceed imprisonment for

27 (2) "Supervising court" means the juvenile court for the city and

1 county of Denver, the district courts of the state other than that of Denver,
2 and any municipal court that establishes a teen court program pursuant to
3 this ~~part~~ PART 10.

4 (3) "Teen" means any person ~~over the age of twelve~~ THIRTEEN
5 years OF AGE OR OLDER and under ~~the age of nineteen~~ years OF AGE who
6 is enrolled in school.

7 (4) "Teen court judge" means a volunteer, licensed to practice law
8 in the state of Colorado, approved by and serving at the pleasure of the
9 chief judge of the supervising court.

10 (5) "Teen defendant" means a teen ordered to participate in a teen
11 court program ~~under this part~~ PURSUANT TO THIS PART 10.

12 (6) "Teen defense attorney" means a teen who is chosen by a teen
13 court judge to speak on behalf of a teen defendant.

14 (7) "Teen jury" means not less than three teens who have been
15 chosen by a teen court judge to decide what sentence should be imposed
16 against a teen defendant.

17 (8) "Teen prosecutor" means a teen who has been chosen by a teen
18 court judge to advocate on behalf of a school or community for any
19 sentence to be imposed.

20 **19-2.5-1003. [Formerly 19-2-1103] Teen court program -**
21 **supervising courts.** (1) Any supervising court is authorized to establish
22 a teen court program pursuant to the ~~provisions of this part~~ THIS PART
23 10. In any jurisdiction where a teen court program is established, a teen
24 charged with a minor offense may receive a deferred judgment, a
25 condition of which is successful participation in the teen court program.

26 (2) The procedure for determining the eligibility for and

11 crime, if the juvenile is in the custody of the division of youth services.
12 After such a pilot program is established, the division of youth services
13 may establish policies and procedures for the victim-offender conferences
14 using volunteers to facilitate the conferences. The volunteers shall
15 complete the division of youth services' volunteer and facility-specific
16 training programs and complete high-risk victim-offender training and
17 victim-advocacy training. The division of youth services shall not
18 compensate or reimburse a volunteer or victim for any expenses. If a pilot
19 program is available, and subsequent to the victim's or the victim
20 representative's request, the division of youth services shall arrange ~~such~~
21 a conference only after determining that the conference would be safe and
22 only if the juvenile agrees to participate. The purposes of the conference
23 are to enable the victim to meet the juvenile, to obtain answers to
24 questions only the juvenile can answer, to assist the victim in healing from
25 the impact of the crime, and to promote a sense of remorse and acceptance
26 of responsibility by the juvenile that may contribute to ~~his or her~~ THE
27 JUVENILE'S rehabilitation.

1 **19-2.5-1409. Juvenile intensive supervision program - creation**
2 **- elements - role of judicial department.** (1) [Formerly 19-2-306] The
3 judicial department may establish and operate, either directly or by
4 contracting with one or more private organizations, a juvenile intensive
5 supervision program, which may be utilized by any judge in sentencing
6 any juvenile who has been placed on probation and who presents a high
7 risk of future placement within juvenile correctional facilities according
8 to assessment criteria developed pursuant to ~~section 19-2-307 (2)~~ THIS

10 (2) [Formerly 19-2-307 (1)] The juvenile intensive supervision
11 program created by ~~section 19-2-306 shall~~ PURSUANT TO SUBSECTION (1)

13 utilization of any or all of the following elements:

- 14 (a) Increased supervision of the juvenile by probation officers;
- 15 (b) Utilization of specific youth case management approaches;
- 16 (c) Community service work assignments;
- 17 (d) Restitution programs;
- 18 (e) Structured group training regarding problem solving, social
19 skills, negotiation skills, emotion management, creative thinking, value
20 enhancement, and critical reasoning;
- 21 (f) Use of electronic or global position monitoring and substance
22 abuse testing to monitor THE JUVENILE'S compliance with the program by
23 ~~the juvenile~~ and providing sanctions for failure to comply with the
24 program; and
- 25 (g) Individual and family treatment.

26 (3) [Formerly 19-2-307 (2)] The judicial department, with the
27 assistance of a juvenile intensive supervision advisory committee, shall

1 develop assessment criteria for placement in the juvenile intensive
2 supervision program, including the results of a validated risk and needs
3 assessment tool, and judicial department guidelines for implementation of
4 the program and measurement of the outcome of the program. The

7 the availability of space in the program and the division of youth services'
8 determination of whether the juvenile's participation in the program is
9 appropriate. A juvenile may be denied participation in the program upon

11 mental HEALTH condition, including severe substance abuse, will prevent

24 (3) If feasible, the program may be established regionally, one in
25 each of the division of youth services' regions. The division OF YOUTH
26 SERVICES, through a competitive bid process, shall select one or more
27 private entities to operate the program.

1 (4) (a) The program consists of two integrated components. Each
2 selected entity shall provide both components within the contracted region
3 as follows:

5 sixty-day residential program, which may contain, but need not be limited

3 jointly establish guidelines for the program and for each of the
4 components thereof described in subsection (4) of this section. The

16 RETAINS with regard to juveniles housed at the facility and the
17 responsibilities the contractor shall exercise.

18 (4) The contractor shall require applicants for employment at the
19 facility to submit a set of fingerprints to the Colorado bureau of
20 investigation for a FINGERPRINT-BASED criminal ~~background~~ HISTORY
21 RECORD check, and the Colorado bureau of investigation may accept such
22 fingerprints. For the purpose of conducting ~~background checks~~ A

5 AS DEFINED IN SUBSECTION (1) OF THIS SECTION, BY ANY PERSON WHO IS
6 NOT A PARENT; STEPPARENT; GUARDIAN; LEGAL CUSTODIAN; SPOUSAL
7 EQUIVALENT, AS DEFINED IN SUBSECTION (130) OF THIS SECTION; OR ANY
8 OTHER PERSON NOT INCLUDED IN THE DEFINITION OF "INTRAFAMILIAL
9 ABUSE", AS DEFINED IN SUBSECTION (87) OF THIS SECTION.

10 (141) "TRAUMA-INFORMED" REFERS TO THE SERVICES TO BE
11 PROVIDED TO OR ON BEHALF OF A CHILD OR YOUTH UNDER AN
12 ORGANIZATIONAL STRUCTURE AND TREATMENT FRAMEWORK THAT
13 INVOLVES UNDERSTANDING, RECOGNIZING, AND RESPONDING TO THE
14 EFFECTS OF ALL TYPES OF TRAUMA IN ACCORDANCE WITH RECOGNIZED
15 PRINCIPLES OF A TRAUMA-INFORMED APPROACH AND TRAUMA-SPECIFIC
16 INTERVENTIONS TO ADDRESS TRAUMA'S CONSEQUENCES AND FACILITATE
17 HEALING.

18 (142) "TRUST FUND", AS USED IN ARTICLE 3.5 OF THIS TITLE 19,
19 MEANS THE COLORADO CHILDREN'S TRUST FUND CREATED IN SECTION
20 19-3.5-106.

21 (143) "UPDATED MEDICAL HISTORY STATEMENT" MEANS A
22 WRITTEN NARRATIVE STATEMENT DATED AND SIGNED BY A BIRTH PARENT
23 ABOUT THE MEDICAL HISTORY OF THE BIRTH PARENT OR OTHER
24 BIOLOGICAL RELATIVES OF THE ADOPTEE THAT CAN BE VOLUNTARILY
25 SUBMITTED BY THE BIRTH PARENT TO THE STATE REGISTRAR FOR FUTURE
26 DISCLOSURE TO THE BIRTH PARENT'S ADULT CHILD WHO IS AN ADULT
27 ADOPTEE OR AN ADULT DESCENDANT OF THE ADOPTEE OR LEGAL

1 REPRESENTATIVE OF SUCH PERSON IN ACCORDANCE WITH THE PROVISIONS
2 OF SECTION 19-5-305 (1.5).

3 (144) (a) "VICTIM", AS USED IN THIS TITLE 19 AND EXCEPT AS
4 PROVIDED IN SUBSECTION (144)(b) OF THIS SECTION, HAS THE SAME
5 MEANING AS SET FORTH IN SECTION 19-2.5-102.

6 (b) "VICTIM", AS USED IN SECTION 19-5-105.5, MEANS ANY
7 NATURAL PERSON AGAINST WHOM A CRIME OF SEXUAL ASSAULT OR A
8 CRIME IN WHICH THE UNDERLYING FACTUAL BASIS WAS SEXUAL ASSAULT
9 IS PERPETRATED OR IS ALLEGED TO HAVE BEEN PERPETRATED.

10 (145) "YOUTH" MEANS AN INDIVIDUAL WHO IS LESS THAN
11 TWENTY-ONE YEARS OF AGE.

12 **SECTION 145. Effective date.** This act takes effect October 1,
13 2021.

14 **SECTION 146. Safety clause.** The general assembly hereby
15 finds, determines, and declares that this act is necessary for the immediate
16 preservation of the public peace, health, or safety.
