HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB25-003 be amended as follows:

1 Amend reengrossed bill, page 7, line 4, strike "OR".

2 Page 7, line 7, after "DUTIES;" add "OR

3 (V) AN INSTRUCTOR OF AN ACCREDITED GUNSMITHING COURSE IN
4 A STATE-AUTHORIZED INSTITUTION OF HIGHER EDUCATION OR AN
5 INSTITUTION REGULATED BY THE COLORADO DIVISION OF PRIVATE
6 OCCUPATIONAL SCHOOLS FOR THE PURPOSES OF EDUCATIONAL
7 INSTRUCTION OR MANUFACTURE, REPAIR, OR MAINTENANCE OF A
8 SPECIFIED SEMIAUTOMATIC FIREARM DURING THE COURSE OF
9 EDUCATIONAL INSTRUCTION;".

10 Page 7, line 16, strike "OR".

11 Page 7, strike lines 17 through 20 and substitute:

12 "(II) A GUNSMITH FOR THE".

13 Page 7, line 25, after "FIREARM;" add "OR

14 (III) A STUDENT OF AN ACCREDITED GUNSMITHING COURSE IN A
15 STATE-AUTHORIZED INSTITUTION OF HIGHER EDUCATION OR AN
16 INSTITUTION REGULATED BY THE COLORADO DIVISION OF PRIVATE
17 OCCUPATIONAL SCHOOLS FOR THE PURPOSES OF EDUCATIONAL
18 INSTRUCTION OR MANUFACTURE, REPAIR, OR MAINTENANCE OF A
19 SPECIFIED SEMIAUTOMATIC FIREARM DURING THE COURSE OF THE
20 STUDENT'S EDUCATIONAL INSTRUCTION;".

21 Page 10, line 16, after "MUST" insert "SATISFY THE COURSE
22 REQUIREMENTS ADOPTED BY THE DIVISION AND".

23 Page 17, strike lines 18 through 27 and substitute:

24 **SECTION 7.** In Colorado Revised Statutes, add 24-35-122 as
25 follows:

26 **24-35-122. Specified semiautomatic firearms guidance.** THE
27 DIVISION IN THE DEPARTMENT OF REVENUE RESPONSIBLE FOR ISSUING
28 STATE FIREARMS DEALER PERMITS SHALL PROVIDE GUIDANCE AND
29 CLARIFICATION TO ASSIST IN THE IMPLEMENTATION OF SECTION 18-12-116.
30 THE DIVISION SHALL PUBLISH AND MAKE PUBLICLY AVAILABLE GUIDANCE
31 ABOUT SPECIFIC MODELS OF FIREARMS TO WHICH SECTION 18-12-116 (2)
32 APPLIES. THE DIVISION MAY CONSULT WITH FIREARM EXPERTS AND
33 CONVENE WORKING GROUPS TO ASSIST WITH CREATING GUIDANCE ABOUT
34 THE SPECIFIC MODELS OF FIREARMS TO WHICH SECTION 18-12-116 (2)
35 APPLIES."
