

## SENATE FLOOR AMENDMENT

Second Reading

BY SENATOR Pelton B.

1 Amend printed bill, page 3, line 16, after "**penalties**" insert "**- notice to**  
2 **the revisor**".

3 Page 5, line 14, strike "ON OR AFTER SEPTEMBER 1, 2025, IT" and  
4 substitute "It".

5 Page 7, after line 12, insert:

6 "(5) SUBSECTIONS (1) TO (4) OF THIS SECTION WILL TAKE EFFECT  
7 IF FEWER THAN ONE HUNDRED THOUSAND VIOLENT CRIMES, PROPERTY  
8 CRIMES, OR A COMBINATION OF BOTH WERE CLEARED STATEWIDE  
9 BETWEEN JANUARY 1, 2025, AND DECEMBER 31, 2029, ACCORDING TO THE  
10 COLORADO CRIME STATISTICS DATABASE, OR A SUCCESSOR DATABASE,  
11 MAINTAINED BY THE COLORADO BUREAU OF INVESTIGATION. ON OR  
12 BEFORE MAY 1, 2030, THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF  
13 PUBLIC SAFETY SHALL NOTIFY THE REVISOR OF STATUTES IN WRITING THAT  
14 THE CONDITION SPECIFIED IN THIS SUBSECTION (5) HAS OCCURRED BY  
15 E-MAILING THE NOTICE TO REVISOROFSTATUTES.GA@COLEG.GOV. IF THE  
16 REVISOR RECEIVES THE NOTICE THAT ONE HUNDRED THOUSAND VIOLENT  
17 CRIMES, PROPERTY CRIMES, OR A COMBINATION OF BOTH WERE CLEARED  
18 BETWEEN JANUARY 1, 2025, AND DECEMBER 31, 2029, ACCORDING TO THE  
19 COLORADO CRIME STATISTICS DATABASE, SUBSECTIONS (1) TO (4) OF THIS  
20 SECTION TAKE EFFECT SEPTEMBER 1, 2030."

21 Page 9, strike lines 26 and 27 and substitute:

22 "**SECTION 8. Effective date - applicability.** (1) Except as  
23 provided in subsection (2) of this section, this act takes effect upon  
24 passage and applies to offenses committed on or after said date.

25 (2) Sections 18-12-116 (1), (2), (3), and (4), Colorado Revised  
26 Statutes, as added in section 2 of this act, and sections 1, 3, 4, 5, 6, and 7  
27 of this act shall only take effect upon receipt of the notice to the Revisor  
28 of Statutes required by section 18-12-116 (5)."

29 Page 10, strike line 1.
