- 1 After the last section, add the following and renumber sections and 2 internal references accordingly:
- 3 "Sec. 501. Subsection (a) of section 29-28a of the general statutes is
- 4 repealed and the following is substituted in lieu thereof (*Effective October*
- 5 1, 2025):
- 6 (a) (1) Requests for temporary state permits under section 29-28, as
- amended by this act, shall be submitted to the chief of police, the chief
- 8 of police of a law enforcement unit of any federally recognized Native
- 9 American tribe within the borders of the state as referenced in
- subsection (b) of section 29-28, as amended by this act, or, where there
- 11 is no chief of police, to the chief executive officer, as defined in section
- 12 7-193, of the municipality, as defined in section 7-148, or, if designated
- 13 by such chief executive officer, the resident state trooper serving such
- 14 municipality or a state police officer of the state police troop having

15 jurisdiction over such municipality, on application forms prescribed by 16 the Commissioner of Emergency Services and Public Protection. Upon 17 written request by any person for a temporary state permit not on a 18 prescribed application form, or upon request by any person for such 19 application form, the local authority, or the chief of police of a law 20 enforcement unit of any federally recognized Native American tribe 21 within the borders of the state as referenced in subsection (b) of section 22 29-28, as amended by this act, shall supply such forms. When any such 23 request is made in person at the office of the local authority, the local 24 authority, or the chief of police of a law enforcement unit of any 25 federally recognized Native American tribe within the borders of the 26 state as referenced in subsection (b) of section 29-28, as amended by this 27 act, shall supply such application form immediately. When any such 28 request is made in any other manner, the local authority, or the chief of 29 police of a law enforcement unit of any federally recognized Native American tribe within the borders of the state as referenced in 30 31 subsection (b) of section 29-28, as amended by this act, shall supply such 32 application form not later than one week after receiving such request. If 33 such application form is not supplied within the time limits required by 34 this section, the request therefor shall constitute a sufficient application. 35 If any local authority, or the chief of police of a law enforcement unit of 36 any federally recognized Native American tribe within the borders of 37 the state as referenced in subsection (b) of section 29-28, as amended by 38 this act, fails to supply an application form upon the request of any 39 person, such person may request an application form from the 40 Commissioner of Emergency Services and Public Protection or any 41 barracks of the Division of State Police, and the time limits and 42 procedures set forth in this section for handling requests for such forms 43 shall be applicable.

(2) No chief of police, chief of police of a law enforcement unit of any federally recognized Native American tribe within the borders of the state as referenced in subsection (b) of section 29-28, as amended by this act, or, where there is no chief of police, chief executive officer, as defined in section 7-193, of the municipality, as defined in section 7-148,

49 or, if designated by such chief executive officer, resident state trooper 50 serving such municipality or a state police officer of the state police 51 troop having jurisdiction over such municipality, may request of any 52 applicant for a temporary state permit information other than (A) a 53 completed and notarized application on the form prescribed by the Commissioner of Emergency Services and Public Protection, which 54 55 form may not be modified or supplemented, (B) proof of lawful 56 presence in the United States, (C) a certificate of completion for a course in pistol and revolver safety, and (D) two sets of fingerprints for 57 58 purposes of the state and national criminal history records check required by section 29-29." 59

This act shall take effect as follows and shall amend the following sections:

Sec. 501	October 1, 2025	29-28a(a)
