17 To declare the existence of an emergency with respect to the need to amend the Firearms Control
18 Regulations Act of 1975 to create a judicial process through which individuals who have
19 been disqualified from receiving a firearms registration certificate due to having been
20 voluntarily admitted or involuntarily committed to a mental health facility, determined to
21 be an incapacitated individual, adjudicated as a mental defective, or committed to a mental
22 institution, can petition the Superior Court of the District of Columbia for relief from that
23 disqualification, to increase the penalty for possessing a large capacity ammunition feeding
24 device to not more than 3 years' imprisonment, a fine, or both, to allow persons to petition
25 the Superior Court of the District of Columbia for an extreme risk protection order, which
26 would prohibit the respondent from possessing firearms or ammunition if the court finds
27 that the subject poses a significant danger of causing bodily injury to self or others, to
28 establish a process for the personal service, renewal, and termination of extreme risk
29 protection orders, to establish procedures for the surrender, storage, assessment of fees for
30 storage, and return of firearms and ammunition that are recovered pursuant to an extreme
31 risk protection order, and to establish a penalty for a violation of an extreme risk protection
32 order; To amend An Act to control the possession, sale, transfer, and use of pistols and
33 other dangerous weapons in the District of Columbia, to provide penalties, to prescribe
34 rules of evidence, and for other purposes to prohibit the possession of bump stocks.

36 RESOLVED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
37 resolution may be cited as the "Firearms Safety Omnibus Emergency Declaration Resolution of
38 2018."

39 Sec. 2. (a) As of December 12, 2018, there have been 155 homicides in the District of
40 Columbia – more than 100 of which involved the use of a firearm.

41 (b) Of the 139 homicide investigations conducted by the Office of the Chief Medical
42 Examiner (“OCME”) in 2016, the cause of death was a firearm in 96 cases, comprising 69% of
43 homicides.

44 (c) Firearms were used in 6 of the 44 suicides investigated by the OCME in 2016. In 2012,
45 firearms were involved in 20% of the 44 suicides; in 2013, 15% of the 52 suicides; in 2014, 32%
46 of the 69 suicides; and in 2015, 29% of the 52 suicides.

47 (d) The Metropolitan Police Department recovered 1,870 illegal firearms in 2016, an
48 increase of 164 over 2015.

49 (e) Identical permanent legislation to this emergency legislation, the Firearms Safety
50 Omnibus Amendment Act of 2018 (Bill 22-0588), is before the Council on final reading on
51 December 18, 2018.

52 (f) This emergency legislation is necessary to immediately protect District residents.

53 Sec. 3. The Council of the District of Columbia determines that the circumstances
54 enumerated in section 2 constitute emergency circumstances making it necessary that the Firearms
55 Safety Omnibus Emergency Amendment Act of 2018 be adopted after a single reading.

56 Sec. 4. This resolution shall take effect immediately.
