8 (1) Before a firearm may be purchased or transferred in
9 this state, the buyer or transferee must provide the seller or
10 transferor with documentation that the buyer or transferee has
11 completed a firearms training course that includes, but is not
12 limited to, a gun safety course; shotgun, pistol, or rifle

14 firearm carry and transport safety.

15 (2) A photocopy of a certificate of completion of any of
16 the courses or classes; an affidavit from the instructor,
17 school, club, organization, or group that conducted or taught
18 such course or class attesting to the completion of the course
19 or class by the applicant; or a copy of any document that shows
20 completion of the course shall constitute evidence of
21 qualification under this section. A person who conducts a course
22 or who, as an instructor, attests to the completion of such
23 courses, must maintain records certifying that he or she
24 observed the student safely handle and discharge the firearm in
25 his or her physical presence and that the discharge of the
26 firearm included live fire using a firearm and ammunition as
27 defined in s. 790.001.

28 (3) This section does not apply to:

29 (a) The holder of a current concealed weapons or firearms
30 license under s. 790.06.

31 (b) A person who presents evidence of:

32 1. Completion of any law enforcement firearms safety or
33 training course or class offered for security guards,
34 investigators, special deputies, or any division or subdivision
35 of a law enforcement agency or security enforcement.
