DIGEST OF SB 199 (Updated March 9, 2015 12:44 pm - DI 123)

Citations Affected: IC 3; IC 4; IC 5; IC 6; IC 9; IC 10; IC 12; IC 13; IC 14; IC 15; IC 16; IC 20; IC 21; IC 22; IC 24; IC 25; IC 30; IC 34; IC 35; IC 36.

Synopsis: Substantive problems in the Indiana Code. Resolves various nontechnical conflicts and problems not suitable for resolution in the annual technical corrections bill, including: (1) statutes that have been both amended and repealed; (2) ambiguous language and references; (3) faulty definitions; and (4) references to defunct entities. Replaces certain instances of "lieutenant governor" with "director of the Indiana office of energy development". Provides a definition of "small business ombudsman". Replaces instances of "ombudsman" with "small business ombudsman". (The introduced version of this bill was prepared by the code revision commission.)

Effective: Upon passage; July 1, 2011 (retroactive); July 1, 2013 (retroactive); July 1, 2014 (retroactive); January 1, 2015 (retroactive).

ENGROSSED SENATE BILL No. 199

A BILL FOR AN ACT to amend the Indiana Code concerning general provisions.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 3-11-8-25.1, AS AMENDED BY P.L.76-2014,
2 SECTION 37, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 UPON PASSAGE]: Sec. 25.1. (a) Except as provided in subsection (e),
4 a voter who desires to vote an official ballot at an election shall provide
5 proof of identification.
6 (b) Except as provided in subsection (e), before the voter proceeds
7 to vote in the election, a precinct election officer shall ask the voter to
8 provide proof of identification. One (1) of each of the precinct election
9 officers nominated by each county chairman of a major political party
10 of the county under IC 3-6-6-8 or IC 3-6-6-9 is entitled to ask the voter
11 to provide proof of identification. The voter shall produce the proof of
12 identification to each precinct officer requesting the proof of
13 identification before being permitted to sign the poll list.
14 (c) If:
15 (1) the voter is unable or declines to present the proof of
16 identification; or

1 (2) a member of the precinct election board determines that the
2 proof of identification provided by the voter does not qualify as
3 proof of identification under IC 3-5-2-40.5;

4 a member of the precinct election board shall challenge the voter as
5 prescribed by this chapter.

6 (d) If the voter executes a challenged voter's affidavit under section
7 22.1 of this chapter, the voter may:

8 (1) sign the poll list; and

9 (2) receive a provisional ballot.

10 (e) A voter who votes in person at a precinct polling place that is
11 located at a state licensed care facility where the voter resides is not
12 required to provide proof of identification before voting in an election.

13 (f) After a voter has passed the challengers or has been sworn in, the
14 voter shall be instructed by a member of the precinct election board to
15 proceed to the location where the poll clerks are stationed. In a vote
16 center county using an electronic poll list, two (2) election officers who
17 are not members of the same political party must be present when a
18 voter signs in on the electronic poll list. The voter shall announce the
19 voter's name to the poll clerks or assistant poll clerks. A poll clerk, an
20 assistant poll clerk, or a member of the precinct election board shall
21 require the voter to write the following on the poll list or to provide the
22 following information for entry into the electronic poll list:

23 (1) The voter's name.

24 (2) Except as provided in subsection (k), the voter's current
25 residence address.

26 (g) The poll clerk, an assistant poll clerk, or a member of the
27 precinct election board shall:

28 (1) ask the voter to provide or update the voter's voter
29 identification number;

30 (2) tell the voter the number the voter may use as a voter
31 identification number; and

32 (3) explain to the voter that the voter is not required to provide or
33 update a voter identification number at the polls.

34 (h) The poll clerk, an assistant poll clerk, or a member of the
35 precinct election board shall ask the voter to provide proof of
36 identification.

37 (i) In case of doubt concerning a voter's identity, the precinct
38 election board shall compare the voter's signature with the signature on
39 the affidavit of registration or any certified copy of the signature
40 provided under IC 3-7-29 or enter the information into the electronic
41 poll book. If the board determines that the voter's signature is authentic,
42 the voter may then vote. If either poll clerk doubts the voter's identity



1 following comparison of the signatures, the poll clerk shall challenge
2 the voter in the manner prescribed by section 21 of this chapter.

3 (j) If: ~~in a precinct governed by subsection (g):~~

4 (1) the poll clerk does not execute a challenger's affidavit; or

5 (2) the voter executes a challenged voter's affidavit under section
6 22.1 of this chapter or executed the affidavit before signing the
7 poll list;

8 the voter may then vote.

9 (k) The electronic poll book (or each line on a poll list sheet
10 provided to take a voter's current address) must include a box under the
11 heading "Address Unchanged" so that the voter may check the box
12 instead of writing the voter's current address on the poll list, or if an
13 electronic poll book is used, the poll clerk may check the box after
14 stating to the voter the address shown on the electronic poll book and
15 receiving an oral affirmation from the voter that the voter's residence
16 address shown on the poll list is the voter's current residence address
17 instead of writing the voter's current residence address on the poll list
18 or reentering the address in the electronic poll book.

19 (l) If the voter indicates that the voter's current residence is located
20 within another county in Indiana, the voter is considered to have
21 directed the county voter registration office of the county where the
22 precinct is located to cancel the voter registration record within the
23 county. The precinct election board shall provide the voter with a voter
24 registration application for the voter to complete and file with the
25 county voter registration office of the county where the voter's current
26 residence address is located.

27 (m) If the voter indicates that the voter's current residence is located
28 outside Indiana, the voter is considered to have directed the county
29 voter registration office of the county where the precinct is located to
30 cancel the voter registration record within the county.

18 studies, or analyses relied upon by the agency in making the
19 determination.

20 (b) For purposes of subsection (a), a proposed rule will be fully
21 implemented with respect to small businesses after:

22 (1) the conclusion of any phase-in period during which:

23 (A) the rule is gradually made to apply to small businesses or
24 certain types of small businesses; or

25 (B) the costs of the rule are gradually implemented; and

26 (2) the rule applies to all small businesses that will be affected by
27 the rule.

28 In determining the total annual economic impact of the rule under
29 subsection (a)(3), the agency shall consider the annual economic
30 impact on all small businesses beginning with the first twelve (12)
31 month period after the rule is fully implemented. The agency may use
32 actual or forecasted data and may consider the actual and anticipated
33 effects of inflation and deflation. The agency shall describe any
34 assumptions made and any data used in determining the total annual
35 economic impact of a rule under subsection (a)(3).

22 common agency;

23 Now Therefore, The states of Illinois, Indiana, Kentucky, New York,
24 Ohio, Pennsylvania, Tennessee, and West Virginia do hereby covenant
25 and agree as follows:

26 Article 1.

27 Each of the signatory states pledges to each of the other signatory
28 states faithful cooperation in the control of future pollution in and
29 abatement of existing pollution from the rivers, streams, and waters in
30 the Ohio river basin which flow through, into, or border upon any of
31 such signatory states, and in order to effect such object, agrees to enact
32 any necessary legislation to enable each such state to place and
33 maintain the waters of said basin in a satisfactory sanitary condition,
34 available for safe and satisfactory use as public and industrial water
35 supplies after reasonable treatment, suitable for recreational usage,
36 capable of maintaining fish and other aquatic life, free from unsightly
37 or malodorous nuisances due to floating solids or sludge deposits, and
38 adaptable to such other uses as may be legitimate.

39 Article 2.

40 The signatory states hereby create a district to be known as the
41 "Ohio River Valley Water Sanitation District", hereinafter called the
42 district, which shall embrace all territory within the signatory states, the



1 water in which flows ultimately into the Ohio river, or its tributaries.

2 Article 3.

3 The signatory states hereby create the "Ohio River Valley Water
4 Sanitation Commission", hereinafter called the commission, which
5 shall be a body corporate, with the powers and duties set forth herein,
6 and such additional powers as may be conferred upon it by subsequent
7 action of the respective legislatures of the signatory states or by act or
8 acts of the congress of the United States.

9 Article 4.

10 The commission shall consist of three (3) commissioners from each
11 state, each of whom shall be a citizen of the state from which he is
12 appointed, and three (3) commissioners representing the United States
13 government. The commissioners from each state shall be chosen in the
14 manner and for the terms provided by the laws of the state from which
15 they shall be appointed, and any commissioner may be removed or
16 suspended from office as provided by the laws of the state from which
17 he shall be appointed. The commissioners representing the United
18 States shall be appointed by the President of the United States, or in
19 such other manner as may be provided by congress. The commissioners
20 shall serve without compensation, but shall be paid their actual
21 expenses incurred in and incident to the performance of their duties;
22 but nothing herein shall prevent the appointment of an officer or
23 employee of any state or of the United States government.

24 Article 5.

25 The commission shall elect from its number a chairman and vice
26 chairman and shall appoint, and at its pleasure remove or discharge,
27 such officers and legal, clerical, expert, and other assistants as may be
28 required to carry the provisions of this compact into effect, and shall fix
29 and determine their duties, qualifications, and compensation. It shall
30 adopt a seal and suitable bylaws, and shall adopt and promulgate rules
31 and regulations for its management and control. It may establish and
32 maintain one (1) or more offices within the district for the transaction
33 of its business, and may meet at any time or place. One (1) or more
34 commissioners from a majority of the member states shall constitute a
35 quorum for the transaction of business.

36 The commission shall submit to the governor of each state, at such
37 time as he may request, a budget of its estimated expenditures for such
38 period as may be required by the laws of such state for presentation to
39 the legislature thereof.

40 The commission shall keep accurate books of account, showing in
41 full its receipts and disbursements, and said books of account shall be
42 open at any reasonable time to the inspection of such representatives



1 of the respective signatory states as may be duly constituted for that
2 purpose.

3 On or before the first day of December of each year, the commission
4 shall submit to the respective governors of the signatory states a full
5 and complete report of its activities for the preceding year.

6 The commission shall not incur any obligations of any kind prior to
7 the making of appropriations adequate to meet the same; nor shall the
8 commission pledge the credit of any of the signatory states, except by
9 and with the authority of the legislature thereof.

10 Article 6.

11 It is recognized by the signatory states that no single standard for the
12 treatment of sewage or industrial wastes is applicable in all parts of the
13 district due to such variable factors as size, flow, location, character,
14 self-purification, and usage of waters within the district. The guiding
15 principle of this compact shall be that pollution by sewage or industrial
16 wastes originating within a signatory state shall not injuriously affect
17 the various uses of the interstate waters as hereinbefore defined.

18 All sewage from municipalities or other political subdivisions,
19 public or private institutions, or corporations, discharged or permitted
20 to flow into those portions of the Ohio River and its tributary waters
21 which form boundaries between or are contiguous to two (2) or more
22 signatory states, or which flow from one (1) signatory state into another
23 signatory state, shall be so treated, within a time reasonable for the
24 construction of the necessary works, as to provide for substantially
25 complete removal of settleable solids, and the removal of not less than
26 forty-five percent (45 percent) of the total suspended solids: Provided,
27 That in order to protect the public health or to preserve the waters for
28 other legitimate purposes, including those specified in Article 1, in
29 specific instances such higher degree of treatment shall be used as may
30 be determined to be necessary by the commission after investigation,
31 due notice, and hearing.

32 All industrial wastes discharged or permitted to flow into the
33 aforesaid waters shall be modified or treated, within a time reasonable
34 for the construction of the necessary works, in order to protect the
35 public health or to preserve the waters for other legitimate purposes,
36 including those specified in Article 1, to such degree as may be
37 determined to be necessary by the commission after investigation, due
38 notice, and hearing.

39 All sewage or industrial wastes discharged or permitted to flow into
40 tributaries of the aforesaid waters situated wholly within one (1) state
41 shall be treated to that extent, if any, which may be necessary to
42 maintain such waters in a sanitary and satisfactory condition at least



1 equal to the condition of the waters of the interstate stream immediately
2 above the confluence.

3 The commission is hereby authorized to adopt, prescribe, and
4 promulgate rules, regulations, and standards for administering and
5 enforcing the provisions of this article.

6 Article 7.

7 Nothing in this compact shall be construed to limit the powers of
8 any signatory state, or to repeal or prevent the enactment of any
9 legislation or the enforcement of any requirement by any signatory
10 state, imposing additional conditions and restrictions to further lessen
11 or prevent the pollution of waters within its jurisdiction.

12 Article 8.

13 The commission shall conduct a survey of the territory included
14 within the district, shall study the pollution problems of the district and
15 shall make a comprehensive report for the prevention or reduction of
16 stream pollution therein. In preparing such report, the commission shall
17 confer with any national or regional planning body which may be
18 established, and any department of the federal government authorized
19 to deal with matters relating to the pollution problems of the district.
20 The commission shall draft and recommend to the governors of the
21 various signatory states uniform legislation dealing with the pollution
22 of rivers, streams, and waters and other pollution problems within the
23 district. The commission shall consult with and advise the various
24 states, communities, municipalities, corporations, persons, or other
25 entities with regard to particular problems connected with the pollution
26 of waters, particularly with regard to the construction of plants for the
27 disposal of sewage, industrial, and other waste. The commission shall,
28 more than one (1) month prior to any regular meeting of the legislature
29 of any state which is a party thereto, present to the governor of the state
30 its recommendations relating to enactments to be made by any
31 legislature in furthering the intents and purposes of his compact.

32 Article 9.

33 The commission may from time to time, after investigation and after
34 a hearing, issue an order or orders upon any municipality, corporation,
35 person, or other entity discharging sewage or industrial waste into the
36 Ohio river or any other river, stream, or water, any part of which
37 constitutes any part of the boundary line between any two (2) or more
38 of the signatory states, or into any stream any part of which flows from
39 any portion of one (1) signatory state through any portion of another
40 signatory state. Any such order or orders may prescribe the date on or
41 before which such discharge shall be wholly or partially discontinued,
42 modified, or treated or otherwise disposed of. The commission shall



1 give reasonable notice of the time and place of the hearing to the
 2 municipality, corporation, or other entity against which such order is
 3 proposed. No such order shall go into effect unless and until it receives
 4 the assent of at least a majority of the commissioners from each of not
 5 less than a majority of the signatory states; and no such order upon a
 6 municipality, corporation, person, or entity in any state shall go into
 7 effect unless and until it receives the assent of not less than a majority
 8 of the commissioners from such state.

9 It shall be the duty of the municipality, corporation, person, or other
 10 entity to comply with any such order issued against it or him by the
 11 commission and any court of general jurisdiction or any United States
 12 district court in any of the signatory states shall have the jurisdiction,
 13 by mandamus, injunction, specific performance, or other form of
 14 remedy, to enforce any such order against any municipality,
 15 corporation, or other entity domiciled or located within such state or
 16 whose discharge of the waste takes place within or adjoining such state,
 17 or against any employee, department, or subdivision of such
 18 municipality, corporation, person, or other entity: Provided, however,
 19 such court may review the order and affirm, reverse, or modify the
 20 same upon any of the grounds customarily applicable in proceedings
 21 for court review of administrative decisions. The commission or, at its
 22 request, the attorney general or other law enforcing official, shall have
 23 power to institute in such court any action for the enforcement of such
 24 order.

25 Article 10.

26 The signatory states agree to appropriate for the salaries, office, and
 27 other administrative expenses, their proper proportion of the annual
 28 budget as determined by the commission and approved by the
 29 governors of the signatory states, one-half (1/2) of such amount to be
 30 prorated among the several states in proportion to their population
 31 within the district at the last preceding federal census, the other half to
 32 be prorated in proportion to their land area within the district. ~~Provided,~~
 33 ~~that the total cost to the state of Indiana be limited to the appropriation~~
 34 ~~specifically mentioned in section 5 of this bill.~~

35 Article 11.

36 This compact shall become effective upon ratification by the
 37 legislatures of a majority of the states located within the district and
 38 upon approval by the Congress of the United States; and shall become
 39 effective as to any additional states signing thereafter at the time of
 40 such signing.
