Synopsis: School emergency response systems. Urges the legislative council to assign to the appropriate interim study committee the topic of school emergency response systems for study during the 2015 interim.

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

14 **complete the study required by this SECTION and report its**
15 **findings and recommendations, if any, to the legislative council in**

1 **an electronic format under IC 5-14-6 before November 1, 2015.**
2 **(d) This SECTION expires January 1, 2016.**
3 **SECTION 2. An emergency is declared for this act.**
