1 AMENDMENT NO. 1

2 On page 1, line 2, after "reenact" insert "R.S. 14:95(N) as enacted by Section 1 of Act 1 of
3 the 2024 Second Extraordinary Session and"

4 AMENDMENT NO. 2

5 On page 1, line 3, after "R.S." delete "40:1379.3(I)(7) and 1382(A)(3) and" and insert
6 "40:1382"

7 AMENDMENT NO. 3

8 On page 1, between lines 7 and 8, insert:

9 "Section 1. R.S. 14:95(N) as enacted by Section 1 of Act 1 of the 2024 Second
10 Extraordinary Session is hereby amended and reenacted to read as follows:

11 §95. Illegal carrying of weapons

12 * * *

13 N. Any person lawfully carrying a handgun pursuant to Subsection M of this
14 Section shall be subject to the restrictions contained in R.S. 40:1379.3(I), ~~(L)~~, (M),
15 (N), and (O)."

16 AMENDMENT NO. 4

17 On page 1, line 8, change "Section 1." to "Section 2."

18 AMENDMENT NO. 5

19 On page 1, line 9, after "R.S." delete the remainder of the line and insert "40:1382(D) is
20 hereby enacted"

21 AMENDMENT NO. 6

22 On page 2, line 24, after "permit." insert:

23 **"A person carrying a concealed handgun pursuant to R.S. 14:95(M) who**
24 **fails to comply with the provisions of this Paragraph shall be subject to the**
25 **penalties provided in Subsection L of this Section."**

26 AMENDMENT NO. 7

27 On page 2, delete lines 26 through 28

28 AMENDMENT NO. 8

29 On page 2, line 29, after "L." delete the remainder of the line and insert "(1) Anyone"

30 AMENDMENT NO. 9

31 On page 3, between lines 3 and 4, insert:

32 **"(2) Anyone who carries a concealed handgun in violation of any**
33 **provision of this Section in the area within the boundaries of the French Quarter**
34 **Management District as established in R.S. 25:799 shall be fined not less than**

1 **five hundred dollars nor more than one thousand dollars, or be imprisoned for**
2 **not more than six months, or both.**

6 On page 4, line 1, after "**Section**" change "**may**" to "**shall**"
