A BILL ENTITLED

1 AN ACT concerning

2 **Criminal Law – Home Invasion and Armed Home Invasion**

3 FOR the purpose of prohibiting a person from breaking and entering the dwelling of
4 another and committing a crime of violence against a person in the dwelling;
5 prohibiting a person from employing or displaying a dangerous weapon during
6 the commission of a home invasion; establishing a unit of prosecution for a
7 certain violation; establishing certain criminal penalties; authorizing a sentence
8 imposed under this Act to be separate from and consecutive to a sentence for
9 any other crime that arises from the conduct underlying the home invasion or
10 armed home invasion; defining certain terms; altering a certain definition; and
11 generally relating to the prohibition against home invasion.

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
24 MARYLAND, That the Laws of Maryland read as follows:

25 **Article – Criminal Law**

1 **(D) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A FELONY**
2 **AND ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 30 YEARS.**

3 **(E) A SENTENCE IMPOSED UNDER THIS SECTION MAY BE SEPARATE**
4 **FROM AND CONSECUTIVE TO A SENTENCE FOR ANY OTHER CRIME THAT ARISES**
5 **FROM THE CONDUCT UNDERLYING THE HOME INVASION VIOLENT CRIME OR**
6 **ARMED HOME INVASION VIOLENT CRIME.**

8 (a) In this section, “crime of violence” means:

- 9 (1) abduction;
- 10 (2) arson in the first degree;
- 11 (3) kidnapping;
- 12 (4) manslaughter, except involuntary manslaughter;
- 13 (5) mayhem;
- 14 (6) maiming, as previously proscribed under former Article 27, §§ 385
15 and 386 of the Code;
- 16 (7) murder;
- 17 (8) rape;
- 18 (9) robbery under § 3–402 or § 3–403 of this article;
- 19 (10) carjacking;
- 20 (11) armed carjacking;
- 21 (12) sexual offense in the first degree;
- 22 (13) sexual offense in the second degree;
- 23 (14) use of a handgun in the commission of a felony or other crime of
24 violence;
- 25 (15) child abuse in the first degree under § 3–601 of this article;
- 26 (16) sexual abuse of a minor under § 3–602 of this article if:

1 (i) the victim is under the age of 13 years and the offender is an
2 adult at the time of the offense; and

3 (ii) the offense involved:

4 1. vaginal intercourse, as defined in § 3–301 of this
5 article;

6 2. a sexual act, as defined in § 3–301 of this article;

7 3. an act in which a part of the offender's body
8 penetrates, however slightly, into the victim's genital opening or anus; or

9 4. the intentional touching, not through the clothing, of
10 the victim's or the offender's genital, anal, or other intimate area for sexual arousal,
11 gratification, or abuse;

12 (17) an attempt to commit any of the crimes described in items (1)
13 through (16) of this subsection;

14 (18) continuing course of conduct with a child under § 3–315 of this
15 article;

16 (19) assault in the first degree;

17 (20) assault with intent to murder;

18 (21) assault with intent to rape;

19 (22) assault with intent to rob;

20 **(23) HOME INVASION UNDER § 3–1002(A) OF THIS ARTICLE;**

21 **(24) ARMED HOME INVASION UNDER § 3–1002(B) OF THIS**
22 **ARTICLE;**

23 ~~[(23)]~~ **(25)** assault with intent to commit a sexual offense in the first
24 degree; and

25 ~~[(24)]~~ **(26)** assault with intent to commit a sexual offense in the second
26 degree.

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
28 October 1, 2014.
