#### 1 AN ACT concerning

## Public Safety – Distribution of Literature to Purchasers of Firearms and Ammunition

4 FOR the purpose of requiring the Maryland Department of Health to prepare certain  $\mathbf{5}$ literature relating to firearms and ammunition and to distribute the literature to all 6 county health departments in the State; requiring each county health department to 7 distribute certain literature to all establishments that sell firearms or ammunition 8 within the county; requiring establishments that sell firearms or ammunition in the 9 State to make certain literature visible and available and to distribute the literature to purchasers of firearms or ammunition; requiring a county health department to 10 11 authorize a certain representative who may issue citations to owners of 12establishments who violate this Act; and generally relating to the distribution of 13 literature to purchasers of firearms and ammunition.
