collect, nor transmit to any private or public entity, any personal data of or information
about a purchaser resulting from a sale eligible for the exemption under this subdivision. It
information about the purchase or transfer of a firearm safety device or firearm storage unit
is required to be collected by a government entity, all data pertaining to that purchase or
transfer are private data on individuals, as defined in section 13.02, subdivision 12, or
