A bill for an act

1.1 relating to health occupations; changing the regulatory agency for licensed
 1.2 midwives from the Board of Medical Practice to the commissioner of health;
 1.3 amending Minnesota Statutes 2014, sections 147D.01, subdivisions 3, 4, 5,
 1.4 7; 147D.05, subdivision 1; 147D.07, subdivisions 2, 3; 147D.09; 147D.13,
 1.5 subdivisions 2, 3, 4; 147D.15, subdivision 2; 147D.17, subdivisions 1, 2, 3,
 1.6 5, 6, 7, 8, 9, 10, 12, 13; 147D.19; 147D.21, subdivisions 1, 2, 5; 147D.25,
 1.7 subdivisions 1, 3; 147D.27, subdivisions 1, 2; proposing coding for new law in
 1.8 Minnesota Statutes, chapter 147D; repealing Minnesota Statutes 2014, sections

1.11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.12 Section 1. Minnesota Statutes 2014, section 147D.01, subdivision 3, is amended to read:

1.13 Subd. 3. **Approved education program.** "Approved education program" means a
 1.14 university, college, or other education program leading to eligibility for certification in
 1.15 midwifery that is approved or accredited by the Midwifery Education and Accreditation
 1.16 Council (MEAC) or its successor, or a national accrediting organization recommended by
 1.17 the advisory council and approved by the ~~board~~ commissioner.

1.18 Sec. 2. Minnesota Statutes 2014, section 147D.01, subdivision 4, is amended to read:

1.19 Subd. 4. **Board Commissioner.** "~~Board~~" "Commissioner" means the ~~Board of~~
 1.20 ~~Medical Practice~~ commissioner of health.

1.21 Sec. 3. Minnesota Statutes 2014, section 147D.01, subdivision 5, is amended to read:

1.22 Subd. 5. **Contact hour.** "Contact hour" means 50 consecutive minutes,
 1.23 excluding coffee breaks, registration, meals without a speaker, and social activities,
 1.24 of a ~~board-approved~~ advisory council-approved learning experience either through an
 1.25 instructional session or clinical practice.

2.1 Sec. 4. Minnesota Statutes 2014, section 147D.01, subdivision 7, is amended to read:

2.2 Subd. 7. **Credentialing examination.** "Credentialing examination" means an
2.3 examination administered by the North American Registry of Midwives (NARM) or its
2.4 successor, or other national testing organization recommended by the advisory council and
2.5 approved by the ~~board~~ commissioner for credentialing as a licensed traditional midwife. A
2.6 credentialing examination must include a written examination and a skills assessment.

2.7 Sec. 5. Minnesota Statutes 2014, section 147D.05, subdivision 1, is amended to read:

2.8 Subdivision 1. **Practice standards.** (a) A licensed traditional midwife shall provide
2.9 an initial and ongoing screening to ensure that each client receives safe and appropriate
2.10 care. A licensed traditional midwife shall only accept and provide care to those women
2.11 who are expected to have a normal pregnancy, labor, and delivery. As part of the initial
2.12 screening to determine whether any contraindications are present, the licensed traditional
2.13 midwife must take a detailed health history that includes the woman's social, medical,
2.14 surgical, menstrual, gynecological, contraceptive, obstetrical, family, nutritional, and
2.15 drug/chemical use histories. If a licensed traditional midwife determines at any time
2.16 during the course of the pregnancy that a woman's condition may preclude attendance by a
2.17 traditional midwife, the licensed traditional midwife must refer the client to a licensed
2.18 health care provider. As part of the initial and ongoing screening, a licensed traditional
2.19 midwife must provide or recommend that the client receive the following services, if
2.20 indicated, from an appropriate health care provider:

2.21 (1) initial laboratory pregnancy screening, including blood group and type, antibody
2.22 screen, Indirect Coombs, rubella titer, CBC with differential and syphilis serology;

2.23 (2) gonorrhea and chlamydia cultures;

2.24 (3) screening for sickle cell;

2.25 (4) screening for hepatitis B and human immunodeficiency virus (HIV);

2.26 (5) maternal serum alpha-fetoprotein test and ultrasound;

2.27 (6) Rh antibody and glucose screening at 28 weeks gestation;

2.28 (7) mandated newborn screening;

2.29 (8) Rh screening of the infant for maternal RhoGAM treatment; and

2.30 (9) screening for premature labor.

2.31 (b) A client must make arrangements to have the results of any of the tests described
2.32 in paragraph (a) sent to the licensed traditional midwife providing services to the client.

2.33 The licensed traditional midwife must include these results in the client's record.

2.34 Sec. 6. Minnesota Statutes 2014, section 147D.07, subdivision 2, is amended to read:

- 3.1 Subd. 2. **Contents.** The informed consent form must be written in language
3.2 understandable to the client and, at a minimum, must contain the following:
- 3.3 (1) name, address, telephone number, and license number of the licensed traditional
3.4 midwife;
- 3.5 (2) a description of the licensed traditional midwife's education, training, and
3.6 experience in traditional midwifery;
- 3.7 (3) the licensed traditional midwife's fees and method of billing;
- 3.8 (4) the right of the client to file a complaint with the ~~board~~ commissioner and the
3.9 procedures for filing a complaint;
- 3.10 (5) a description of the licensed traditional midwife's medical consultation plan and
3.11 the antepartum, intrapartum, and postpartum conditions requiring consultation, transfer of
3.12 care, or transport to a hospital;
- 3.13 (6) the scope of care and services to be provided to the client by the licensed
3.14 traditional midwife;
- 3.15 (7) the available alternatives to traditional midwifery care;
- 3.16 (8) a statement indicating that the client's records and any transaction with the
3.17 licensed traditional midwife are confidential;
- 3.18 (9) a notice that reads: "We realize that there are risks associated with birth,
3.19 including the risk of death or disability of either mother or child. We understand that
3.20 a situation may arise, which requires emergency medical care and that it may not be
3.21 possible to transport the mother and/or baby to the hospital in time to benefit from such
3.22 care. We fully accept the outcome and consequences of our decision to have a licensed
3.23 traditional midwife attend us during pregnancy and at our birth. We realize that our
3.24 licensed traditional midwife is not licensed to practice medicine. We are not seeking a
3.25 licensed physician or certified nurse midwife as the primary caregiver for this pregnancy,
3.26 and we understand that our licensed traditional midwife shall inform us of any observed
3.27 signs or symptoms of disease, which may require evaluation, care, or treatment by a
3.28 medical practitioner. We agree that we are totally responsible for obtaining qualified
3.29 medical assistance for the care of any disease or pathological condition.";
- 3.30 (10) the right of a client to refuse services unless otherwise provided by law;
- 3.31 (11) a disclosure of whether the licensed traditional midwife carries malpractice
3.32 or liability insurance; and
- 3.33 (12) the client's and licensed traditional midwife's signatures and date of signing.

3.34 Sec. 7. Minnesota Statutes 2014, section 147D.07, subdivision 3, is amended to read:

4.1 Subd. 3. **Filing.** The licensed traditional midwife must have a signed informed
4.2 consent form on file for each client. Upon request, the licensed traditional midwife must
4.3 provide a copy of the informed consent form to the ~~board~~ commissioner.

4.4 Sec. 8. Minnesota Statutes 2014, section 147D.09, is amended to read:

4.5 **147D.09 LIMITATIONS OF PRACTICE.**

4.6 (a) A licensed traditional midwife shall not prescribe, dispense, or administer
4.7 prescription drugs, except as permitted under paragraph (b).

4.8 (b) A licensed traditional midwife may administer vitamin K either orally or through
4.9 intramuscular injection, maternal RhoGAM treatment, postpartum antihemorrhagic drugs
4.10 under emergency situations, local anesthetic, oxygen, and a prophylactic eye agent to
4.11 the newborn infant.

4.12 (c) A licensed traditional midwife shall not perform any operative or surgical
4.13 procedures except for suture repair of first- or second-degree perineal lacerations.

4.15 Subd. 2. **Practice report.** (a) A licensed traditional midwife must compile a
4.16 summary report on each client. The report must include the following:

4.17 (1) vital statistics;

4.18 (2) scope of care administered;

4.19 (3) whether the medical consultation plan was implemented; and

4.20 (4) any physician or other health care provider referrals made.

4.21 (b) The ~~board~~ commissioner or advisory council may review these reports at any
4.22 time upon request.

4.23 Sec. 10. Minnesota Statutes 2014, section 147D.13, subdivision 3, is amended to read:

4.24 Subd. 3. **Public health report.** A licensed traditional midwife must promptly report
4.25 to the commissioner of health ~~and to the board~~ any maternal, fetal, or neonatal mortality
4.26 or morbidity.

4.27 Sec. 11. Minnesota Statutes 2014, section 147D.13, subdivision 4, is amended to read:

4.28 Subd. 4. **Disciplinary action.** A licensed traditional midwife must report to the
4.29 ~~board~~ commissioner termination, revocation, or suspension of the licensed traditional
4.30 midwife's certification or any ~~disciplinary~~ incident review action taken against the licensed
4.31 traditional midwife by the North American Registry of Midwives.

5.1 Sec. 12. Minnesota Statutes 2014, section 147D.15, subdivision 2, is amended to read:

5.2 Subd. 2. **Prohibited from practicing.** A person whose license under this chapter
5.3 has been revoked by the ~~board~~ commissioner is prohibited from practicing traditional
5.4 midwifery.

5.5 Sec. 13. Minnesota Statutes 2014, section 147D.17, subdivision 1, is amended to read:

5.6 Subdivision 1. **General requirements for licensure.** To be eligible for licensure, an
5.7 applicant, with the exception of those seeking licensure by reciprocity under subdivision
5.8 2, must:

5.9 (1) submit a completed application on forms provided by the ~~board~~ commissioner
5.10 along with all fees required under section 147D.27 that includes:

5.11 (i) the applicant's name, Social Security number, home address and telephone
5.12 number, and business address and telephone number;

5.13 (ii) a list of degrees received from educational institutions;

5.14 (iii) a description of the applicant's professional training;

5.15 (iv) a list of registrations, certifications, and licenses held in other jurisdictions;

5.16 (v) a description of any other jurisdiction's refusal to credential the applicant;

5.17 (vi) a description of all professional disciplinary actions initiated against the
5.18 applicant in any jurisdiction; and

5.19 (vii) any history of drug or alcohol abuse, and any misdemeanor or felony conviction;

5.20 (2) submit a diploma from an approved education program or submit evidence
5.21 of having completed an apprenticeship;

5.22 (3) submit a verified copy of a valid and current credential, issued by the North
5.23 American Registry of Midwives or other national organization recommended by the
5.24 advisory council and approved by the ~~board~~ commissioner, as a certified professional
5.25 midwife;

5.26 (4) submit current certification from the American Heart Association or the
5.27 American Red Cross for adult and infant cardiopulmonary resuscitation;

5.28 (5) submit a copy of the applicant's medical consultation plan;

5.29 (6) submit documentation verifying that the applicant has the following practical
5.30 experience through an apprenticeship or other supervisory setting:

5.31 (i) the provision of 75 prenatal examinations, including 20 initial examinations;

5.32 (ii) supervised participation in 20 births, ten of which must be in a home setting;

5.33 (iii) participation as the primary birth attendant under the supervision of a licensed
5.34 traditional midwife at an additional 20 births, ten of which must have occurred outside a
5.35 state licensed health care facility;

- 6.1 (iv) 20 newborn examinations; and
- 6.2 (v) 40 postpartum examinations;
- 6.3 (7) submit additional information as requested by the ~~board~~ commissioner or
- 6.4 advisory council, including any additional information necessary to ensure that the
- 6.5 applicant is able to practice with reasonable skill and safety to the public;
- 6.6 (8) sign a statement that the information in the application is true and correct to the
- 6.7 best of the applicant's knowledge and belief; and
- 6.8 (9) sign a waiver authorizing the ~~board~~ commissioner to obtain access to the
- 6.9 applicant's records in this or any other state in which the applicant has completed an
- 6.10 approved education program or engaged in the practice of traditional midwifery.

6.11 Sec. 14. Minnesota Statutes 2014, section 147D.17, subdivision 2, is amended to read:

6.12 Subd. 2. **Licensure by reciprocity.** To be eligible for licensure by reciprocity, the

6.13 applicant must be credentialed by the North American Registry of Midwives or other

6.14 national organization recommended by the advisory council and approved by the ~~board~~

6.15 commissioner and must:

6.16 (1) submit the application materials and appropriate fees as required under

6.17 subdivision 1, clauses (1), (3), (4), (5), (6), (7), (8), and (9), and section 147D.27;

6.18 (2) provide a verified copy from the appropriate body of a current and unrestricted

6.19 credential for the practice of traditional midwifery in another jurisdiction that has initial

6.20 credentialing requirements equivalent to or higher than the requirements in subdivision

6.30 under this section if the application for licensure is complete, all applicable requirements

6.31 in this section have been met, and a nonrefundable fee set by the ~~board~~ commissioner

6.32 has been paid. The permit remains valid only until ~~the meeting of the board at which a~~

6.33 decision is made on the application for licensure.

7.2 Subd. 5. **License expiration.** Licenses issued under this chapter expire ~~annually~~

7.5 Subd. 6. **Renewal.** To be eligible for license renewal, a licensed traditional midwife
7.6 must:

7.7 (1) complete a renewal application on a form provided by the ~~board~~ commissioner;

7.9 (3) provide evidence every three years of a total of 30 hours of continuing education
7.10 approved by the ~~board~~ commissioner as described in section 147D.21;

7.20 by the ~~board~~ commissioner at the licensed traditional midwife's address on file with

7.21 the ~~board~~ commissioner shall be considered as having been received by the licensed

7.24 Subd. 8. **License renewal notice.** At least 30 days before the license renewal date,
7.25 the ~~board~~ commissioner shall send out a renewal notice to the last known address of the
7.26 licensed traditional midwife on file. The notice must include a renewal application and a
7.27 notice of fees required for renewal. It must also inform the licensed traditional midwife that
7.28 licensure will expire without further action by the ~~board~~ commissioner if an application for
7.29 license renewal is not received before the deadline for renewal. The licensed traditional
7.30 midwife's failure to receive this notice shall not relieve the licensed traditional midwife of
7.31 the obligation to meet the deadline and other requirements for license renewal. Failure to
7.32 receive this notice is not grounds for challenging expiration of licensure status.

8.2 Subd. 9. **Renewal deadline.** The renewal application and fee must be postmarked
8.3 on or before July 1 or as determined by the ~~board~~ commissioner. If the postmark is
8.4 illegible, the application shall be considered timely if received by the third working day
8.5 after the deadline.

8.6 Sec. 21. Minnesota Statutes 2014, section 147D.17, subdivision 10, is amended to read:

8.7 Subd. 10. **Inactive status and return to active status.** (a) A license may be placed

8.23 within two licensure renewal cycles starting July 1999. A licensed traditional midwife
8.24 whose license is canceled for nonrenewal must obtain a new license by applying for
8.25 licensure and fulfilling all requirements then in existence for initial licensure as a licensed

Subd. 4. **Licensure by equivalency during transition period.** (a) From July 1, 1999, to July 1, 2001, a person may qualify for licensure if the person has engaged in the practice of traditional midwifery in this state for at least five years in the period from July 1, 1994, to June 30, 1999, and submits documentation verifying the practical experience described in subdivision 1, clause (6). To be eligible for licensure under this subdivision, the person must also submit the application materials and the appropriate fees required under subdivision 1, clauses (1), (4), (5), (6), (7), (8), and (9), and section 147D.27.

(b) An application for licensure under this subdivision must be submitted to the board between July 1, 1999, and June 30, 2001. Licensure under this subdivision may be renewed once. Within a two-year period from the date a license is issued by the board in accordance with this subdivision, the licensed traditional midwife must obtain a certification from the North American Registry of Midwives as a certified professional midwife. If certification is not obtained within this time period, the licensed traditional midwife must obtain a new license by applying for licensure and fulfilling the requirements then in existence for obtaining an initial license as a licensed traditional midwife.

For purposes of this chapter, licensed traditional midwives and applicants are subject to the provisions of sections 147.091 to 147.162.
