 2.2 The figures "2020" and "2021" used in this article mean that the appropriations listed under  
 2.3 them are available for the fiscal year ending June 30, 2020, or June 30, 2021, respectively.  
 2.4 "The first year" is fiscal year 2020. "The second year" is fiscal year 2021. "The biennium"  
 2.5 is fiscal years 2020 and 2021. Appropriations for the fiscal year ending June 30, 2019, are  
 2.6 effective the day following final enactment.
