Minnesota Statutes 2024, section 297A.67, subdivision 40, is amended to read: 1.6 Subd. 40. Firearm safety devices; firearm storage units. (a) Safety devices and secure 1.7 firearm storage units are exempt. For the purposes of this subdivision: 1.8 (1) "firearm safety device" means: 1.9 (i) a device that, when installed on a firearm, is designed to prevent the firearm from 1.10 being operated without first deactivating the device; or 1.11 (ii) a device to be equipped or installed on a firearm that is designed to prevent the 1.12 operation of the firearm by anyone who does not have authorized access to the firearm; 1.13 (2) "secure firearm storage unit" means a container that is fully enclosed and locked by 1.14 a padlock, keylock, combination lock, or similar locking device, and is either specifically 1.15 designed for the safe storage of firearms or sold for that purpose by a federally licensed 1.16 firearms dealer; and 1.17 (2) (3) "firearm" has the meaning provided in section 97A.015, subdivision 19. 1.18

(b) A firearm sold with a firearm safety device already installed on it is treated as the

sale of a firearm and not the sale of a firearm safety device.

(b) (c) The seller of a <u>firearm safety device or secure firearm storage unit must neither</u> collect, nor transmit to any private or public entity, any personal data of or information about a purchaser resulting from a sale eligible for the exemption under this subdivision. <u>If</u> information about the purchase or transfer of a firearm safety device or firearm storage unit is required to be collected by a government entity, as defined in section 13.02, subdivision 7a, all data pertaining to that purchase or transfer are private data on individuals, as defined in section 13.02, subdivision 12, or nonpublic data, as defined in section 13.02, subdivision 9.
