1 AMEND House Committee Substitute for House Bill No. 549, Page 34, Section 589.042, Line 8, by
2 inserting after all of said section and line the following:

3
4 "589.414. 1. Any person required by sections 589.400 to 589.425 to register shall, within
5 three business days, appear in person to the chief law enforcement officer of the county or city not
6 within a county if there is a change to any of the following information:

- 7 (1) Name;
8 (2) Residence;
9 (3) Employment, including status as a volunteer or intern;
10 (4) Student status; or
11 (5) A termination to any of the items listed in this subsection.

12 2. Any person required to register under sections 589.400 to 589.425 shall, within three
13 business days, notify the chief law enforcement official of the county or city not within a county of
14 any changes to the following information:

- 15 (1) Vehicle information;
16 (2) Temporary lodging information;
17 (3) Temporary residence information;
18 (4) Email addresses, instant messaging addresses, and any other designations used in
19 internet communications, postings, or telephone communications; or
20 (5) Telephone or other cellular number, including any new forms of electronic
21 communication.

22 3. The chief law enforcement official in the county or city not within a county shall
23 immediately forward the registration changes described under subsections 1 and 2 of this section to
24 the Missouri state highway patrol within three business days.

25 4. If any person required by sections 589.400 to 589.425 to register changes such person's
26 residence or address to a different county or city not within a county, the person shall appear in
27 person and shall inform both the chief law enforcement official with whom the person last registered
28 and the chief law enforcement official of the county or city not within a county having jurisdiction
29 over the new residence or address in writing within three business days of such new address and
30 phone number, if the phone number is also changed. If any person required by sections 589.400 to
31 589.425 to register changes his or her state, territory, the District of Columbia, or foreign country, or
32 federal, tribal, or military jurisdiction of residence, the person shall appear in person and shall
33 inform both the chief law enforcement official with whom the person was last registered and the
34 chief law enforcement official of the area in the new state, territory, the District of Columbia, or
35 foreign country, or federal, tribal, or military jurisdiction having jurisdiction over the new residence
36 or address within three business days of such new address. Whenever a registrant changes

1 residence, the chief law enforcement official of the county or city not within a county where the
 2 person was previously registered shall inform the Missouri state highway patrol of the change within
 3 three business days. When the registrant is changing the residence to a new state, territory, the
 4 District of Columbia, or foreign country, or federal, tribal, or military jurisdiction, the Missouri state
 5 highway patrol shall inform the responsible official in the new state, territory, the District of
 6 Columbia, or foreign country, or federal, tribal, or military jurisdiction of residence within three
 7 business days.

8 5. Tier I sexual offenders, in addition to the requirements of subsections 1 to 4 of this
 9 section, shall report in person to the chief law enforcement official annually in the month of their
 10 birth to verify the information contained in their statement made pursuant to section 589.407. Tier I
 11 sexual offenders include:

12 (1) Any offender who has been adjudicated for the offense of:

13 (a) Sexual abuse in the first degree under section 566.100 if the victim is eighteen years of
 14 age or older;

15 (b) Sexual misconduct involving a child under section 566.083 if it is a first offense and [~~the~~
 16 ~~punishment is less than one year~~] if the offense is a misdemeanor;

17 (c) Sexual abuse in the second degree under section 566.101 [~~the punishment is less than one~~
 18 ~~year~~] if the offense is a misdemeanor;

19 (d) Kidnapping in the second degree under section 565.120 with sexual motivation;

20 (e) Kidnapping in the third degree under section 565.130;

21 (f) Sexual conduct with a nursing facility resident or vulnerable person in the first degree
 22 under section 566.115 [~~the punishment is less than one year~~] if the offense is a misdemeanor;

23 (g) Sexual conduct under section 566.116 with a nursing facility resident or vulnerable
 24 person;

25 (h) Sexual contact with a prisoner or offender under section 566.145 if the victim is eighteen
 26 years of age or older;

27 (i) Sex with an animal under section 566.111;

28 (j) Trafficking for the purpose of sexual exploitation under section 566.209 if the victim is
 29 eighteen years of age or older;

30 (k) Possession of child pornography under section 573.037;

31 (l) Sexual misconduct in the first degree under section 566.093;

32 (m) Sexual misconduct in the second degree under section 566.095;

33 (n) Child molestation in the second degree under section 566.068 as it existed prior to
 34 January 1, 2017, if the [~~punishment is less than one year~~] offense is a misdemeanor; or

35 (o) Invasion of privacy under section 565.252 if the victim is less than eighteen years of age;

36 (2) Any offender who is or has been adjudicated in any other state, territory, the District of
 37 Columbia, or foreign country, or under federal, tribal, or military jurisdiction of an offense of a
 38 sexual nature or with a sexual element that is comparable to the tier I sexual offenses listed in this
 39 subsection or, if not comparable to those in this subsection, comparable to those described as tier I
 40 offenses under the Sex Offender Registration and Notification Act, Title I of the Adam Walsh Child
 41 Protection and Safety Act of 2006, Pub. L. 109-248.

42 6. Tier II sexual offenders, in addition to the requirements of subsections 1 to 4 of this
 43 section, shall report semiannually in person in the month of their birth and six months thereafter to
 44 the chief law enforcement official to verify the information contained in their statement made
 45 pursuant to section 589.407. Tier II sexual offenders include:

46 (1) Any offender who has been adjudicated for the offense of:

47 (a) Statutory sodomy in the second degree under section 566.064 if the victim is sixteen to
 48 seventeen years of age;

49 (b) Child molestation in the third degree under section 566.069 if the victim is between

1 thirteen and fourteen years of age;

2 (c) Sexual contact with a student under section 566.086 if the victim is thirteen to seventeen
3 years of age;

4 (d) Enticement of a child under section 566.151;

5 (e) Abuse of a child under section 568.060 if the offense is of a sexual nature and the victim
6 is thirteen to seventeen years of age;

7 (f) Sexual exploitation of a minor under section 573.023;

8 (g) Promoting child pornography in the first degree under section 573.025;

9 (h) Promoting child pornography in the second degree under section 573.035;

10 (i) Patronizing prostitution under section 567.030;

11 (j) Sexual contact with a prisoner or offender under section 566.145 if the victim is thirteen
12 to seventeen years of age;

13 (k) Child molestation in the fourth degree under section 566.071 if the victim is thirteen to
14 seventeen years of age;

15 (l) Sexual misconduct involving a child under section 566.083 if it is a first offense and [the
16 penalty is a term of imprisonment of more than a year] if the offense is a felony; or

17 (m) Age misrepresentation with intent to solicit a minor under section 566.153;

18 (2) Any person who is adjudicated of an offense comparable to a tier I offense listed in this
19 section or failure to register offense under section 589.425 or comparable out-of-state failure to
20 register offense and who is already required to register as a tier I offender due to having been
21 adjudicated of a tier I offense on a previous occasion; or

22 (3) Any person who is or has been adjudicated in any other state, territory, the District of
23 Columbia, or foreign country, or under federal, tribal, or military jurisdiction for an offense of a
24 sexual nature or with a sexual element that is comparable to the tier II sexual offenses listed in this
25 subsection or, if not comparable to those in this subsection, comparable to those described as tier II
26 offenses under the Sex Offender Registration and Notification Act, Title I of the Adam Walsh Child
27 Protection and Safety Act of 2006, Pub. L. 109-248.

28 7. Tier III sexual offenders, in addition to the requirements of subsections 1 to 4 of this
29 section, shall report in person to the chief law enforcement official every ninety days to verify the
30 information contained in their statement made under section 589.407. Tier III sexual offenders
31 include:

32 (1) Any offender registered as a predatory sexual offender [as defined in section 566.123] or
33 a persistent sexual offender as defined in section [566.124] 566.125;

34 (2) Any offender who has been adjudicated for the crime of:

35 (a) Rape in the first degree under section 566.030;

36 (b) Statutory rape in the first degree under section 566.032;

37 (c) Rape in the second degree under section 566.031;

38 (d) Endangering the welfare of a child in the first degree under section 568.045 if the
39 offense is sexual in nature;

40 (e) Sodomy in the first degree under section 566.060;

41 (f) Statutory sodomy under section 566.062;

42 (g) Statutory sodomy under section 566.064 if the victim is under sixteen years of age;

43 (h) Sodomy in the second degree under section 566.061;

44 (i) Sexual misconduct involving a child under section 566.083 if the offense is a second or
45 subsequent offense;

46 (j) Sexual abuse in the first degree under section 566.100 if the victim is under thirteen
47 years of age;

48 (k) Kidnapping in the first degree under section 565.110 if the victim is under eighteen years
49 of age, excluding kidnapping by a parent or guardian;

- 1 (l) Child kidnapping under section 565.115;
- 2 (m) Sexual conduct with a nursing facility resident or vulnerable person in the first degree
3 under section 566.115 [~~if the punishment is greater than a year~~] if the offense is a felony ;
- 4 (n) Incest under section 568.020;
- 5 (o) Endangering the welfare of a child in the first degree under section 568.045 with sexual
6 intercourse or deviate sexual intercourse with a victim under eighteen years of age;
- 7 (p) Child molestation in the first degree under section 566.067;
- 8 (q) Child molestation in the second degree under section 566.068;
- 9 (r) Child molestation in the third degree under section 566.069 if the victim is under thirteen
10 years of age;
- 11 (s) Promoting prostitution in the first degree under section 567.050 if the victim is under
12 eighteen years of age;
- 13 (t) Promoting prostitution in the second degree under section 567.060 if the victim is under
14 eighteen years of age;
- 15 (u) Promoting prostitution in the third degree under section 567.070 if the victim is under
16 eighteen years of age;
- 17 (v) Promoting travel for prostitution under section 567.085 if the victim is under eighteen
18 years of age;
- 19 (w) Trafficking for the purpose of sexual exploitation under section 566.209 if the victim is
20 under eighteen years of age;
- 21 (x) Sexual trafficking of a child in the first degree under section 566.210;
- 22 (y) Sexual trafficking of a child in the second degree under section 566.211;
- 23 (z) Genital mutilation of a female child under section 568.065;
- 24 (aa) Statutory rape in the second degree under section 566.034;
- 25 (bb) Child molestation in the fourth degree under section 566.071 if the victim is under
26 thirteen years of age;
- 27 (cc) Sexual abuse in the second degree under section 566.101 [~~if the penalty is a term of~~
28 ~~imprisonment of more than a year~~] if the offense is a felony;
- 29 (dd) Patronizing prostitution under section 567.030 if the offender is a persistent offender;
- 30 (ee) Abuse of a child under section 568.060 if the offense is of a sexual nature and the
31 victim is under thirteen years of age;
- 32 (ff) Sexual contact with a prisoner or offender under section 566.145 if the victim is under
33 thirteen years of age;
- 34 (gg) Sexual intercourse with a prisoner or offender under section 566.145;
- 35 (hh) Sexual contact with a student under section 566.086 if the victim is under thirteen years
36 of age;
- 37 (ii) Use of a child in a sexual performance under section 573.200; or
- 38 (jj) Promoting a sexual performance by a child under section 573.205;
- 39 (3) Any offender who is adjudicated for a crime comparable to a tier I or tier II offense
40 listed in this section or failure to register offense under section 589.425, or other comparable out-of-
41 state failure to register offense, who has been or is already required to register as a tier II offender
42 because of having been adjudicated for a tier II offense, two tier I offenses, or combination of a tier I
43 offense and failure to register offense, on a previous occasion;
- 44 (4) Any offender who is adjudicated in any other state, territory, the District of Columbia, or
45 foreign country, or under federal, tribal, or military jurisdiction for an offense of a sexual nature or
46 with a sexual element that is comparable to a tier III offense listed in this section or a tier III offense
47 under the Sex Offender Registration and Notification Act, Title I of the Adam Walsh Child
48 Protection and Safety Act of 2006, Pub. L. 109-248; or
- 49 (5) Any offender who is adjudicated in Missouri for any offense of a sexual nature requiring

1 registration under sections 589.400 to 589.425 that is not classified as a tier I or tier II offense in this
2 section.

3 8. In addition to the requirements of subsections 1 to 7 of this section, all Missouri
4 registrants who work, including as a volunteer or unpaid intern, or attend any school whether public
5 or private, including any secondary school, trade school, professional school, or institution of higher
6 education, on a full-time or part-time basis or have a temporary residence in this state shall be
7 required to report in person to the chief law enforcement officer in the area of the state where they
8 work, including as a volunteer or unpaid intern, or attend any school or training and register in that
9 state. "Part-time" in this subsection means for more than seven days in any twelve-month period.

10 9. If a person who is required to register as a sexual offender under sections 589.400 to
11 589.425 changes or obtains a new online identifier as defined in section 43.651, the person shall
12 report such information in the same manner as a change of residence before using such online
13 identifier."; and

15 Further amend said bill by amending the title, enacting clause, and intersectional references
16 accordingly.
