## AN ACT

To repeal sections 161.217, 162.720, 208.044, 208.046, 208.053, 210.027, 210.102, 210.199, 210.201, 210.203, 210.211, 210.221, 210.223, 210.231, 210.241, 210.245, 210.251, 210.254, 210.255, 210.256, 210.258, 210.275, 210.278, 210.493, 210.1007, and 210.1080, RSMo, and to enact in lieu thereof twenty-seven new sections relating to youth services, with an emergency clause for certain sections.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Sections 161.217, 162.720, 208.044, 208.046, 208.053, 210.027, 210.102, 210.199, 210.201, 210.203, 210.211, 210.221, 210.223, 210.231, 210.241, 210.245, 210.251, 210.254, 210.255, 210.256, 210.258, 210.275, 210.278, 210.493, 210.1007, and 210.1080, RSMo, are repealed and twenty-seven new sections enacted in lieu thereof, to be known as sections 161.217, 162.720, 163.063, 208.044, 208.046, 208.053, 210.027, 210.102, 210.201, 210.203, 210.211, 210.221, 210.223, 210.231, 210.241, 210.245, 210.251, 210.254, 210.255, 210.256, 210.258, 210.275, 210.278, 210.493, 210.1007, 210.1080, and 210.1450, to read as follows:

161.217. 1. The department of elementary and secondary education, in collaboration with **the department's office of childhood**, the Missouri Head Start State Collaboration Office, and the departments of ~~[health and senior services,]~~ mental health~~[-]~~ and social services, shall ~~[develop, as a three-year pilot program,]~~ **provide a continuous quality improvement process for early learning programs and present families with consumer education about the quality of early learning programs by producing** a voluntary early learning quality assurance report. The early learning quality assurance report shall be developed based on evidence-based practices.

EXPLANATION — Matter enclosed in bold-faced brackets ~~[thus]~~ in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

9           2. Participation in the early learning quality assurance report [~~pilot~~] program shall be  
10 voluntary for any licensed or license-exempt early learning providers that are center-based or  
11 home-based and are providing services for children from any ages from birth up to  
12 kindergarten.

13           3. The early learning quality assurance report may include, but is not limited to,  
14 information regarding staff qualifications, instructional quality, professional development,  
15 health and safety standards, parent engagement, and community engagement.

16           4. The early learning quality assurance report shall not be used for enforcement of  
17 compliance with any law or for any punitive purposes.

18           5. The department of elementary and secondary education shall promulgate all  
19 necessary rules and regulations for the administration of this section. Any rule or portion of a  
20 rule, as that term is defined in section 536.010, that is created under the authority delegated in  
21 this section shall become effective only if it complies with and is subject to all of the  
22 provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536  
23 are nonseverable and if any of the powers vested with the general assembly pursuant to  
24 chapter 536 to review, to delay the effective date, or to disapprove and annul a rule are  
25 subsequently held unconstitutional, then the grant of rulemaking authority and any rule  
26 proposed or adopted after August 28, 2016, shall be invalid and void.

27           6. Under section 23.253 of the Missouri sunset act:

29 [~~automatically~~] sunset [~~three years after August 28, 2019, unless reauthorized by an act of the~~

32 ~~automatically sunset three years after the effective date of the reauthorization of this section]~~  
33 **on August 28, 2026; and**

34           [~~(3)~~] **(2)** This section shall terminate on September first of the calendar year  
35 immediately following the calendar year in which the program authorized under this section  
36 is sunset.

162.720. 1. **(1) This subdivision shall apply to all school years ending before**  
2 **July 1, 2024.** Where a sufficient number of children are [~~determined to be~~] **identified as**  
3 **gifted** and their development requires programs or services beyond the level of those  
4 ordinarily provided in regular public school programs, districts may establish special  
5 programs for such gifted children.

6           **(2) For school year 2024-25 and all subsequent school years, if three percent or**  
7 **more of students enrolled in a school district are identified as gifted and their**  
8 **development requires programs or services beyond the level of those ordinarily**

9 **provided in regular public school programs, the district shall establish a state-approved**  
10 **gifted program for gifted children.**

11 **2. For school year 2024-25 and all subsequent school years, any teacher**  
12 **providing gifted services to students in districts with an average daily attendance of**  
13 **more than three hundred fifty students shall be certificated in gifted education. In**  
14 **districts with an average daily attendance of three hundred fifty students or fewer, any**  
15 **teacher providing gifted services shall not be required to be certificated to teach gifted**  
16 **education but such teacher shall annually participate in at least six clock hours of**  
17 **professional development focused on gifted services. The school district shall pay for**  
18 **such professional development focused on gifted services.**

19 **3. The state board of education shall determine standards for such gifted programs**  
20 **and gifted services. Approval of ~~such~~ gifted programs shall be made by the state**  
21 **department of elementary and secondary education based upon project applications submitted**  
22 **~~[by July fifteenth of each year]~~ at a time and in a form determined by the department of**  
23 **elementary and secondary education.**

24 **~~[3-]~~ 4. No district shall ~~[make a determination as to whether]~~ identify a child ~~[is]~~ as**  
25 **gifted based on the child's participation in an advanced placement course or international**  
26 **baccalaureate course. Districts shall ~~[determine]~~ identify a child ~~[is]~~ as gifted only if the**  
27 **child meets the definition of gifted children as provided in section 162.675.**

28 **~~[4-]~~ 5. Any district with a gifted education program approved under subsection ~~[2]~~ 3**  
29 **of this section shall have a policy, approved by the board of education of the district, that**  
30 **establishes a process that outlines the procedures and conditions under which parents or**  
31 **guardians may request a review of the decision ~~[that determined]~~ that their child did not**  
32 **qualify to receive services through the district's gifted education program.**

33 **~~[5-]~~ 6. School districts and school district employees shall be immune from liability**  
34 **for any and all acts or omissions relating to the decision that a child did not qualify to receive**  
35 **services through the district's gifted education program.**

36 **7. The department of elementary and secondary education may promulgate all**  
37 **necessary rules and regulations for the implementation and administration of this**  
38 **section. Any rule or portion of a rule, as that term is defined in section 536.010, that is**  
39 **created under the authority delegated in this section shall become effective only if it**  
40 **complies with and is subject to all of the provisions of chapter 536 and, if applicable,**  
41 **section 536.028. This section and chapter 536 are nonseverable, and if any of the powers**  
42 **vested with the general assembly pursuant to chapter 536 to review, to delay the**

163.063. 1. For the purpose of determining state and local funding for a child's education, if the child resides in a residential treatment facility or other facility and is unable to attend in the public school district where the child resides, either because the child may be a safety risk or the child has behavioral conditions that support the need to educate the child on such facility's site or campus and the school district uses the residential care facility to provide any portion of the child's education, the school district shall pass through to such facility at least eighty percent of any state or local moneys paid to the district on a per-pupil basis for such child in addition to any other moneys available to the school district through the department of elementary and secondary education for such child.

2. If the school district provides a teacher or other educational resources to such residential treatment facility or other facility, the district may use moneys provided under subsection 2 of this section to offset the cost of such teacher or other educational resources that are directly attributable to such child in state custody at such facility's site or campus. Such facility shall be afforded reasonable costs associated with such child's education up to the average per-pupil cost. No such facility shall be required to offset the costs to the child's school district for the education of such child as long as such costs of education do not exceed the average per-pupil spending on an annual basis within the school district.

3. The school district shall provide an annual accounting to the residential treatment facility or other facility and shall either support or approve the facility's education plan for such child or provide for the child's education on such facility's site or campus.

4. If a child receives educational services from a residential care facility, it shall be the responsibility of the school district in which the child resides to provide for the education of the child and ensure the child is receiving education services that are substantially similar to the curriculum and standards of the school district.

5. The provisions of this section shall not apply to school boards authorized under sections 162.670 to 162.999.

208.044. 1. The [~~children's division~~] department of elementary and secondary education shall provide child day care services to any person who meets the qualifications set forth at sections 301 and 302 of the Family Support Act of 1988 (P.L. 100-485).

2. The division shall purchase the child day care services required by this section by making payments directly to any providers of day care services licensed pursuant to chapter 210 or to providers of day care services who are not required by chapter 210 to be licensed because they are providing care to no more than six children pursuant to section 210.211.

8           3. When a person who has been eligible and receiving day care services under this  
9 section becomes ineligible due to the end of the twelve-month period of transitional ~~[day]~~  
10 **child care services**, as defined in section 208.400, such person may receive day care services  
11 from the ~~[division]~~ **department of elementary and secondary education** if otherwise  
12 eligible for such services.

208.046. 1. The ~~[children's division]~~ **department of elementary and secondary**  
2 **education** shall promulgate rules ~~[to become effective no later than July 1, 2011,]~~ to modify  
3 the income eligibility criteria for any person receiving state-funded child care assistance  
4 ~~[under this chapter,]~~ either through vouchers or direct reimbursement to child care providers  
5 ~~[;]~~ as follows:

6           (1) Child care recipients eligible under this chapter and the criteria set forth in ~~[13~~  
7 ~~CSR 35-32.010]~~ **5 CSR 25-200** may pay a fee based on adjusted gross income and family size  
8 unit based on a child care sliding fee scale established by the ~~[children's division]~~  
9 **department of elementary and secondary education**, which shall be subject to  
10 appropriations. However, a person receiving state-funded child care assistance under this  
11 chapter and whose income surpasses the annual appropriation level may continue to receive  
12 reduced subsidy benefits on a scale established by the ~~[children's division]~~ **department of**  
13 **elementary and secondary education**, at which time such person will have assumed the full  
14 cost of the maximum base child care subsidy rate established by the ~~[children's division]~~  
15 **department of elementary and secondary education** and shall be no longer eligible for  
16 child care subsidy benefits;

17           (2) The sliding scale fee may be waived for children with special needs as established  
18 by the ~~[division]~~ **department of elementary and secondary education**; and

19           (3) The maximum payment by the ~~[division]~~ **department of elementary and**  
20 **secondary education** shall be the applicable rate minus the applicable fee.

21           2. For purposes of this section, "annual appropriation level" shall mean the maximum  
22 income level to be eligible for a full child care benefit as determined through the annual  
23 appropriations process.

24           3. Any rule or portion of a rule, as that term is defined in section 536.010, that is  
25 created under the authority delegated in this section shall become effective only if it complies  
26 with and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028.  
27 This section and chapter 536 are nonseverable and if any of the powers vested with the  
28 general assembly pursuant to chapter 536 to review, to delay the effective date, or to  
29 disapprove and annul a rule are subsequently held unconstitutional, then the grant of

208.053. 1. The provisions of this section shall be known as the "Low-Wage Trap Elimination Act". In order to more effectively transition persons receiving state-funded child care subsidy benefits under this chapter, the ~~[children's division]~~ **department of elementary and secondary education**, in conjunction with the department of revenue, shall, subject to appropriations, by July 1, 2022, implement a pilot program in a county with a charter form of government and with more than six hundred thousand but fewer than seven hundred thousand inhabitants, a county of the first classification with more than two hundred sixty thousand but fewer than three hundred thousand inhabitants, and a county of the first classification with more than two hundred thousand but fewer than two hundred sixty thousand inhabitants, to be called the "Hand-Up Program", to allow applicants in the program to receive transitional child care benefits without the requirement that such applicants first be eligible for full child care benefits.

(1) For purposes of this section, "full child care benefits" shall be the full benefits awarded to a recipient based on the income eligibility amount established by the division through the annual appropriations process as of August 28, 2021, to qualify for the benefits and shall not include the transitional child care benefits that are awarded to recipients whose income surpasses the eligibility level for full benefits to continue. The hand-up program shall be voluntary and shall be designed such that an applicant may begin receiving the transitional child care benefit without having first qualified for the full child care benefit or any other tier of the transitional child care benefit. Under no circumstances shall any applicant be eligible for the hand-up program if the applicant's income does not fall within the transitional child care benefit income limits established through the annual appropriations process.

(2) A participating recipient shall be allowed to opt out of the program at any time, but such person shall not be allowed to participate in the program a second time.

2. The ~~[division]~~ **department of elementary and secondary education** shall track the number of participants in the hand-up program and shall issue an annual report to the general assembly by September 1, 2023, and annually on September first thereafter, detailing the effectiveness of the pilot program in encouraging recipients to secure employment earning an income greater than the maximum wage eligible for the full child care benefit. The report shall also detail the costs of administration and the increased amount of state income tax paid as a result of the program, as well as an analysis of whether the pilot program could be expanded to include other types of benefits including but not limited to food stamps, temporary assistance for needy families, low-income heating assistance, women, infants and children supplemental nutrition program, the state children's health insurance program, and MO HealthNet benefits.

3. The ~~[division]~~ **department of elementary and secondary education** shall pursue all necessary waivers from the federal government to implement the hand-up program. If the

210.027. 1. For child-care providers who receive state or federal funds for providing  
2 child-care services, either by direct payment or through reimbursement to a child-care  
3 beneficiary, the department of ~~[social services]~~ **elementary and secondary education** shall:

4 (1) Establish publicly available website access to provider-specific information about  
5 any health and safety licensing or regulatory requirements for the providers, and including  
6 dates of inspections, history of violations, and compliance actions taken, as well as the  
7 consumer education information required under subdivision (12) of this ~~[section]~~ **subsection**  
8 **and subsection 2 of this section;**

9 (2) Establish or designate one hotline for parents to submit complaints about child  
10 care providers;

11 (3) Be authorized to revoke the registration of a registered provider for due cause;

12 (4) Require providers to be at least eighteen years of age;

13 (5) **(a)** Establish minimum requirements for building and physical premises to  
14 include:

15 ~~[(a)]~~ **a.** Compliance with state and local fire, health, and building codes, which shall  
16 include the ability to evacuate children in the case of an emergency; and

17 ~~[(b)]~~ **b.** Emergency preparedness and response planning.

18           **(b)** Child care providers shall meet ~~[these]~~ **such** minimum requirements prior to  
19 receiving federal assistance. Where there are no local ordinances or regulations regarding  
20 smoke detectors, the department shall require providers, by rule, to install and maintain an  
21 adequate number of smoke detectors in the residence or other building where child care is  
22 provided;

23           (6) Require providers to be tested for tuberculosis on the schedule required for  
24 employees in licensed facilities;

25           (7) Require providers to notify parents if the provider does not have immediate access  
26 to a telephone;

27           (8) Make providers aware of local opportunities for training in first aid and child care;

28           (9) Promulgate rules and regulations to define preservice training requirements for  
29 child care providers and employees pursuant to applicable federal laws and regulations;

30           (10) Establish procedures for conducting unscheduled on-site monitoring of child  
31 care providers prior to receiving state or federal funds for providing child care services either  
32 by direct payment or through reimbursement to a child care beneficiary, and annually  
33 thereafter;

35 laws and regulations to report to the department any serious injuries or death of children

46 related to registration or licensing requirements. The system shall also indicate if the provider  
47 utilizes curricula and if the provider is in compliance with staff educational requirements.

210.102. 1. There is hereby established within the department of ~~[social services]~~  
2 **elementary and secondary education** the "Coordinating Board for Early Childhood", which  
3 shall constitute a body corporate and politic, and shall include but not be limited to the  
4 following members:

- 5 (1) A representative from the governor's office;
- 6 (2) A representative from each of the following departments: health and senior  
7 services, mental health, social services, and elementary and secondary education;
- 8 (3) A representative of the judiciary;
- 9 (4) A representative of the family and community trust board (FACT);
- 10 (5) A representative from the head start program; **and**
- 11 (6) Nine members appointed by the governor with the advice and consent of the  
12 senate who are representatives of the groups, such as business, philanthropy, civic groups,  
13 faith-based organizations, parent groups, advocacy organizations, early childhood service  
14 providers, and other stakeholders.

15 **2.** The coordinating board may make all rules it deems necessary to enable it to  
16 conduct its meetings, elect its officers, and set the terms and duties of its officers. The

19 Members of the board shall serve without compensation but may be reimbursed for actual

35 contracts or other transactions with any federal or state agency, any private organizations, or  
36 any other source in furtherance of the purpose of subsection 1 of this section and this  
37 subsection, and take any and all actions necessary to avail itself of such aid and cooperation;
- 38 (8) Direct disbursements from the coordinating board for early childhood fund as  
39 provided in this section;
- 40 (9) Administer the coordinating board for early childhood fund and invest any portion  
41 of the moneys not required for immediate disbursement in obligations of the United States or  
42 any agency or instrumentality of the United States, in obligations of the state of Missouri and  
43 its political subdivisions, in certificates of deposit and time deposits, or other obligations of  
44 banks and savings and loan associations, or in such other obligations as may be prescribed by  
45 the board;
- 46 (10) Purchase, receive, take by grant, gift, devise, bequest or otherwise, lease, or  
47 otherwise acquire, own, hold, improve, employ, use, and otherwise deal with real or personal  
48 property or any interests therein, wherever situated;
- 49 (11) Sell, convey, lease, exchange, transfer or otherwise dispose of all or any of its  
50 property or any interest therein, wherever situated;
- 51 (12) Employ and fix the compensation of an executive director and such other agents  
52 or employees as it considers necessary;
- 53 (13) Adopt, alter, or repeal by its own bylaws, rules, and regulations governing the  
54 manner in which its business may be transacted;
- 55 (14) Adopt and use an official seal;
- 56 (15) Assess or charge fees as the board determines to be reasonable to carry out its  
57 purposes;
- 58 (16) Make all expenditures which are incident and necessary to carry out its purposes;
- 59 (17) Sue and be sued in its official name; **and**
- 60 (18) Take such action, enter into such agreements, and exercise all functions  
61 necessary or appropriate to carry out the duties and purposes set forth in this section.

210.201. As used in sections 210.201 to 210.257, the following terms mean:

2 (1) "Child", an individual who is under the age of seventeen;

3 (2) "Child care", care of a child away from his or her home for any part of the twenty-  
4 four-hour day for compensation or otherwise. Child care is a voluntary supplement to  
5 parental responsibility for the child's protection, development, and supervision;

6 (3) "Child-care facility" or "child care facility", a house or other place conducted or  
7 maintained by any person who advertises or holds himself or herself out as providing child  
8 care for any part of the twenty-four-hour day for compensation or otherwise if providing child  
9 care to more than:

10 (a) Six children; or

11 (b) Three children under two years of age;

12 (4) "Child care provider" or "provider", the person or persons licensed or required to  
13 be licensed under section 210.221 to establish, conduct, or maintain a child care facility;

14 (5) **"Day camp", a program operated by a person or organization between the  
15 hours of 6:00 a.m. and 7:00 p.m. when a local school system is not in session requiring  
16 actual pupil attendance with the primary function of providing a recreational program  
17 for children five years of age or older who are enrolled in kindergarten or any grade  
18 above kindergarten but providing no child care for children under five years of age who  
19 are not yet enrolled in kindergarten in the same space or in the same outdoor play area  
20 simultaneously;**

210.223. 1. All licensed child care facilities that provide care for children less than  
2 one year of age shall implement and maintain a written safe sleep policy in accordance with  
3 the most recent safe sleep recommendations of the American Academy of Pediatrics. The  
4 purpose of the safe sleep policy is to maintain a safe sleep environment that reduces the risk  
5 of sudden infant death syndrome and sudden unexpected infant deaths in children less than  
6 one year of age.



7           2. When, in the opinion of the infant's licensed health care provider, an infant requires  
8 alternative sleep positions or special sleeping arrangements that differ from those set forth in  
9 the most recent sleep recommendations of the American Academy of Pediatrics, the child  
10 care facility shall be provided with written instructions, signed by the infant's licensed health  
11 care provider, detailing the alternative sleep positions or special sleeping arrangements for  
12 such infant. The child care facility shall put the infant to sleep in accordance with such  
13 written instructions.

14           3. As used in this section, the following terms shall mean:

15           (1) "Sudden infant death syndrome", the sudden death of an infant less than one year  
16 of age that cannot be explained after a thorough investigation has been conducted, including a  
17 complete autopsy, an examination of the death scene, and a review of the clinical history;

18           (2) "Sudden unexpected infant death", the sudden and unexpected death of an infant  
19 less than one year of age in which the manner and cause of death are not immediately obvious  
20 prior to investigation. Causes of sudden unexpected infant death include, but are not limited  
21 to, metabolic disorders, hypothermia or hyperthermia, neglect or homicide, poisoning, and  
22 accidental suffocation.

23           4. All employees of licensed child care facilities who care for infants less than one  
24 year of age or any volunteer who may be assisting at the facility shall successfully complete  
25 department-approved training on the most recent safe sleep recommendations of the  
26 American Academy of Pediatrics every three years.

27           5. The department **of elementary and secondary education** shall promulgate rules to  
28 implement the provisions of this section. Such rules shall include, but not be limited to:

29           (1) Amending any current rules which are not in compliance with the most recent safe  
30 sleep recommendations of the American Academy of Pediatrics [~~including but not limited to~~  
31 ~~19 CSR 30.62-092(1)C which permits the use of bumper pads in cribs or playpens~~];

32           (2) Keeping soft or loose bedding away from sleeping infants and out of safe sleep  
33 environments including, but not limited to, bumper pads, pillows, quilts, comforters, sleep  
34 positioning devices, sheepskins, blankets, flat sheets, cloth diapers, bibs, and other similar  
35 items; and

36           (3) Prohibiting blankets or other soft or loose bedding from being hung on the sides  
37 of cribs.

38           6. The department **of elementary and secondary education** may adopt emergency  
39 rules to implement the requirements of this section. Any rule or portion of a rule, as that term  
40 is defined in section 536.010, that is created under the authority delegated in this section shall  
41 become effective only if it complies with and is subject to all of the provisions of chapter 536  
42 and, if applicable, section 536.028. This section and chapter 536 are nonseverable and if any

210.245. 1. Any person who violates any provision of sections 210.201 to 210.245,  
2 or who for such person or for any other person makes materially false statements in order to  
3 obtain a license or the renewal thereof pursuant to sections 210.201 to 210.245, shall be guilty  
4 of a class C misdemeanor for the first offense and shall be assessed a fine not to exceed seven  
5 hundred fifty dollars and shall be guilty of a class A misdemeanor and shall be assessed a fine  
6 of up to two thousand dollars per day, not to exceed a total of ten thousand dollars for  
7 subsequent offenses. In case such guilty person is a corporation, association, institution or
