SUMMARY—Revises provisions governing graffiti.
(BDR 15-479)

AN ACT relating to graffiti; revising the definition of “graffiti”; expanding the list of items that are considered graffiti implements which are unlawful to carry in certain places; clarifying that a governmental entity may bring a civil action for damages to public property; authorizing the governing body of a city to adopt ordinances to address covering and removing certain graffiti on residential and nonresidential property; revising provisions governing money in a city’s graffiti reward and abatement fund; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

- 1 Existing law makes it a crime to place graffiti on or otherwise deface the public
- 2 or private property, real or personal, of another, without the permission of the
- 3 owner. (NRS 206.330) **Sections 5, 8.2 and 16** of this bill revise the definition of
- 4 “graffiti” to: (1) clarify that estrays and livestock are included within the scope of
- 5 property to which the offense of graffiti applies; and (2) exclude certain items
- 6 which are affixed to property.
- 7 Existing law makes it a misdemeanor for a person to carry on his or her person,
- 8 in certain public places, a graffiti implement with the intent to vandalize, place
- 9 graffiti on or deface property. (NRS 206.335) **Section 7** of this bill revises the
- 10 definition of “graffiti implement” to include any item that may be used to etch or
- 11 deface property.
- 12 Existing law requires a person who is ordered to pay restitution for placing
- 13 graffiti on public property to pay the restitution to the governmental entity that has
- 14 incurred expenses for abating the graffiti. (NRS 206.345) **Section 8** of this bill
- 15 authorizes the payment of restitution to a governmental entity for future expenses to
- 16 abate the graffiti. Existing law also authorizes the owner of public or private



17 property that has been damaged by graffiti to bring a civil action against the person
18 who placed the graffiti and recover damages in an amount up to three times the
19 amount of any loss in value to property and up to three times the cost of restoring
20 the property plus attorney's fees and costs. (NRS 206.345) **Section 8** clarifies that a
21 governmental entity may also bring a civil action to recover such damages from a
22 person who placed graffiti on property if the governmental entity owns or is
23 otherwise responsible for the damaged property.

24 Existing law authorizes a board of county commissioners to provide by
25 ordinance for the covering or removal of certain graffiti on certain types of
26 property. (NRS 244.36935) **Sections 8.4 and 8.6** of this bill revise provisions
27 governing the covering or removal of certain graffiti that is placed on residential
28 property. **Section 14** of this bill authorizes the governing body of a city to similarly
29 provide by ordinance for the covering or removal of certain graffiti on residential
30 property.

31 Existing law authorizes a board of county commissioners to provide by
32 ordinance procedures pursuant to which the board may order an owner of
33 nonresidential property to cover or remove certain graffiti on the owner's property.
34 (NRS 244.3694) **Section 8.8** of this bill revises provisions governing the covering
35 or removal of graffiti that is placed on nonresidential property. **Section 15** of this
36 bill similarly authorizes the governing body of a city to provide by ordinance
37 procedures pursuant to which the governing body may order an owner of
38 nonresidential property to cover or remove certain graffiti on the owner's property.

39 Existing law requires the governing body of each city to create a fund to pay,
40 upon approval by the governing body of the city, a reward to certain persons who
41 provide information which results in the identification, apprehension and
42 conviction of a person who violated a city ordinance prohibiting graffiti or other
43 defacement of property. (NRS 268.4085) **Section 18** of this bill expands the
44 authorized use of money in the fund: (1) to purchase supplies or pay for other
45 graffiti abatement costs incurred by the city; (2) to be paid for information which
46 results in the identification, apprehension or conviction of a person who is alleged
47 to have violated a city ordinance that prohibits graffiti or defacement of property;
48 and (3) to be paid upon approval of the city manager, the authorized designee of the
49 city manager or, if the city does not have a city manager, the governing body of the
50 city.

1 **Section 1.** Chapter 206 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 2, 3 and 4 of this act.

4 *requires, the words and terms defined in NRS 206.005 and*
5 *sections 3 and 4 of this act have the meanings ascribed to them in*

8 *public or private lands in this State whose owner is unknown in*

3 **1. “Graffiti”** means any unauthorized inscription, word, figure
4 or design that is marked, etched, scratched, drawn, painted on or
5 affixed to the public or private property, real or personal, of another,
6 *including, without limitation, an estray or one or more head of*
7 *livestock*, which defaces the property.

8 **2. The term does not include any item affixed to property**
9 **which may be removed:**

10 (a) *By hand without defacing the property;*

11 (b) *Through the use of a chemical or cleaning solvent*
12 *commonly used for removing an adhesive substance without*
13 *defacing the property; or*

14 (c) *Without the use of a decal remover tool.*

15 **3. As used in this section, “decal remover tool” means any**
16 **device using power or heat to remove an adhesive substance.**

17 **Sec. 6.** NRS 206.150 is hereby amended to read as follows:

18 206.150 1. Except as otherwise provided in subsections 2 and
19 3, any person who willfully and maliciously kills, maims or
20 disfigures any animal belonging to another, or exposes any poison
21 or noxious substance with intent that it should be taken by the
22 animal is guilty of a category D felony and shall be punished as
23 provided in NRS 193.130, and may be further punished by a fine of
24 not more than \$10,000.

25 2. Except as otherwise provided in NRS 205.220, a person who
26 willfully and maliciously kills an estray or one or more head of
27 livestock, without the authority to do so, is guilty of a category C
28 felony and shall be punished as provided in NRS 193.130.

29 3. The provisions of subsection 1 do not apply to any person
30 who kills a dog pursuant to NRS 575.020.

36 **Sec. 7.** NRS 206.335 is hereby amended to read as follows:

37 206.335 1. Any person who carries on his or her person a
38 graffiti implement with the intent to vandalize, place graffiti on or
39 otherwise deface public or private property, real or personal, of
40 another:

41 (a) While on or under any overpass or bridge or in any flood
42 channel;

43 (b) At any public facility, community center, park, playground,
44 swimming pool, transportation facility, beach or recreational area
45 whereon a sign is posted in a location reasonably expected to be



1 viewed by the public which states that it is a misdemeanor to
2 possess a graffiti implement at that public location without valid
3 authorization; or

4 (c) In a public transportation vehicle wherein a sign is posted
5 that is easily viewed by passengers which states that it is a
6 misdemeanor to possess a graffiti implement in the vehicle without
7 valid authorization,

8 ➤ is guilty of a misdemeanor unless the person has first received
9 valid authorization from the governmental entity which has
10 jurisdiction over the public area or other person who is designated to
11 provide such authorization.

12 2. As used in this section:

13 (a) "Broad-tipped indelible marker" means any felt-tipped
14 marker or similar implement which contains a fluid that is not
15 soluble in water and which has a flat or angled writing surface of a
16 width of one-half inch or greater.

17 (b) "Graffiti implement" means any broad-tipped indelible
18 marker, ~~or~~ aerosol paint container, *carbide-tipped instrument* or
19 other item that may be used to ~~propel~~:

20 (1) *Propel* or apply ~~fluid~~ *any substance* that is not soluble
21 in water ~~H~~; or

22 (2) *Etch or deface property.*

23 (c) "Public transportation vehicle" means a bus, train or other
24 vehicle or instrumentality used to transport persons from a
25 transportation facility to another location.

26 (d) "Transportation facility" means an airport, marina, bus
27 terminal, train station, bus stop or other facility where a person may
28 go to obtain transportation.

29 **Sec. 8.** NRS 206.345 is hereby amended to read as follows:

30 206.345 1. A court may, in addition to any other fine or
31 penalty imposed, order a person who places graffiti on or otherwise
32 defaces public or private property in violation of NRS 206.125 or
33 206.330 to participate in counseling, and if the person is less than 18
34 years of age, order the parent or legal guardian of the person to
35 attend or participate in counseling pursuant to NRS 62E.290.

36 2. If a court orders a person who violates the provisions of
37 NRS 206.125 or 206.330 to pay restitution, the person shall pay the
38 restitution to:

39 (a) The owner of the property which was affected by the
40 violation; or

41 (b) If the violation involved the placing of graffiti on any public
42 property, the governmental entity that incurred *or will incur*
43 expenses for removing, covering or cleaning up the graffiti.

8 legal guardian of the offender.

7 the city to cover or remove the graffiti and may recover the
8 amount expended by the city for labor and materials used to cover
9 or remove the graffiti if:

10 (a) The owner has not requested a hearing within the time
11 prescribed in the ordinance adopted pursuant to subsection 1 and
12 has failed to cover or remove the graffiti within the period
13 specified in the notice;

14 (b) After a hearing in which the owner did not prevail, the

29 person responsible for placing graffiti on the property of the city to
30 recover a civil penalty and damages ~~[for the cost of removing or~~
31 ~~covering the graffiti placed on such property.]~~ *pursuant to the*
32 *provisions of NRS 206.345.*

33 **Sec. 18.** NRS 268.4085 is hereby amended to read as follows:

34 268.4085 1. The governing body of each city shall create a
35 graffiti reward and abatement fund. The money in the fund must be
36 used *to purchase supplies or pay for other costs incurred by the*
37 *city which are directly related to graffiti abatement or* to pay a
38 reward to a person who, in response to the offer of a reward,
39 provides information which results in the identification,
40 apprehension ~~[and]~~ *or* conviction of a person who *is alleged to have*
41 *violated or who violates* a city ordinance that prohibits graffiti or
42 other defacement of property.

43 2. When a defendant pleads or is found guilty or guilty but
44 mentally ill of violating a city ordinance that prohibits graffiti or
45 other defacement of property, the court shall include an



1 administrative assessment of \$250 for each violation in addition to
2 any other fine or penalty. The money collected must be paid by the
3 clerk of the court to the city treasurer on or before the fifth day of
4 each month for credit to the graffiti reward and abatement fund.

5 3. If sufficient money is available in the graffiti reward and
6 abatement fund, a law enforcement agency for the city may offer a
7 reward, not to exceed \$1,000, for information leading to the
8 identification, apprehension ~~and~~ or conviction of a person who *is*
9 *alleged to have violated or who* violates a city ordinance that
10 prohibits graffiti or other defacement of property.

11 4. The *money to purchase supplies or pay for other costs*
12 *incurred by the city which are directly related to graffiti abatement*
13 *or to pay a* reward must be paid out of the graffiti reward and
14 abatement fund upon approval of the *city manager, the authorized*
15 *designee of the city manager or, if the city does not have a city*
16 *manager, the* governing body of the city.

17 **Sec. 19.** Nothing in this act may be construed to limit the
18 ability of a county or city to enforce any ordinance or regulation
19 relating to the abatement of graffiti adopted before, on or after
20 October 1, 2015.
