SUMMARY—Provides for the registration of medical marijuana establishments authorized to cultivate or dispense marijuana or manufacture products containing marijuana for sale to persons authorized to engage in the medical use of marijuana. (BDR 15-89)

AN ACT relating to medical marijuana; providing for the registration of medical marijuana establishments authorized to cultivate or dispense marijuana or manufacture products containing marijuana for sale to persons authorized to engage in the medical use of marijuana; setting forth the manner in which such establishments must register and operate; providing penalties; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

- 1 Under existing law, the State of Nevada provides immunity from state and local
- 2 prosecution for possessing, delivering and producing marijuana in certain limited
- 3 amounts for patients with qualifying medical conditions, and their designated
- 4 primary caregivers, who apply to and receive from the Health Division of the
- 5 Department of Health and Human Services a registry identification card. Existing

6 law does not specify the manner in which qualifying patients and their designated
7 primary caregivers are to obtain marijuana. (Chapter 453A of NRS)

8 This bill: (1) states that it is an unlawful act, punishable as a category E felony,
9 to forge, counterfeit or attempt to forge or counterfeit a registry identification card;
10 (2) provides for the registration of medical marijuana establishments, the three
11 types of which are cultivation facilities, facilities for the production of edible
12 marijuana products and medical marijuana dispensaries; (3) provides for the
13 registration of medical marijuana establishment agents; (4) sets forth the crimes and
14 acts which disqualify a person from serving as the owner, officer, board member or
15 agent of such an establishment; (5) enumerates the acts for which a medical
16 marijuana establishment registration certificate and a medical marijuana
17 establishment agent registration card are immediately revocable; (6) establishes that
18 it is a privilege and not a right to hold a medical marijuana establishment
19 registration certificate or a medical marijuana establishment agent registration card;
20 (7) sets forth the maximum fees which may be charged by the Health Division for
21 the initial issuance and renewal of such certificates and cards; (8) sets forth the
22 basic requirements for operating a medical marijuana establishment; and (9) directs
23 the Health Division to adopt necessary regulations. This bill also increases the
24 amounts of usable marijuana and live marijuana plants that a holder of a registry
25 identification card and his or her designated primary caregiver are allowed to
26 possess at any one time, matching the amounts allowed under the laws of the State
27 of Arizona.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 207 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 *1. It is unlawful for any person to counterfeit or forge or*
4 *attempt to counterfeit or forge a registry identification card.*

5 *2. Any person who violates the provisions of subsection 1 is*
6 *guilty of a category E felony and shall be punished as provided in*
7 *NRS 193.130.*

8 *3. As used in this section, "registry identification card" has*
9 *the meaning ascribed to it in NRS 453A.140.*

10 **Sec. 2.** Chapter 453A of NRS is hereby amended by adding
11 thereto the provisions set forth as sections 3 to 20, inclusive, of this
12 act.

13 **Sec. 3. "Crime of violence" means any felony:**

14 *1. Involving the use or threatened use of force or violence*
15 *against the person or property of another; or*

16 *2. For which there is a substantial risk that force or violence*
17 *may be used against the person or property of another in the*
18 *commission of the felony.*

19 **Sec. 3.5. "Cultivation facility" means a business that:**

20 *1. Is registered with the Division pursuant to section 10 of*
21 *this act; and*



1 2. *Acquires, possesses, cultivates, delivers, transfers,*
2 *transports, supplies or sells marijuana and related supplies to:*

3 (a) *Medical marijuana dispensaries;*

4 (b) *Facilities for the production of edible marijuana products;*

5 *or*

6 (c) *Other cultivation facilities.*

7 Sec. 4. (Deleted by amendment.)

8 Sec. 5. (Deleted by amendment.)

9 Sec. 5.3. *“Edible marijuana products” means products that:*

10 1. *Contain marijuana or an extract thereof;*

11 2. *Are intended for human consumption; and*

12 3. *Are presented in the form of foodstuffs, extracts, oils,*
13 *tinctures and other similar products.*

14 Sec. 5.5. *“Electronic verification system” means an*
15 *electronic database that:*

16 1. *Keeps track of data in real time; and*

17 2. *Is accessible by the Division and by registered medical*
18 *marijuana establishments.*

19 Sec. 6. *“Enclosed, locked facility” means a closet, display*
20 *case, room, greenhouse or other enclosed area that meets the*
21 *requirements of section 19.4 of this act and is equipped with locks*
22 *or other security devices which allow access only by a medical*
23 *marijuana establishment agent and the holder of a valid registry*
24 *identification card.*

25 Sec. 7. 1. *“Excluded felony offense” means:*

26 (a) *A crime of violence; or*

27 (b) *A violation of a state or federal law pertaining to controlled*
28 *substances, if the law was punishable as a felony in the*
29 *jurisdiction where the person was convicted.*

30 2. *The term does not include:*

31 (a) *A criminal offense for which the sentence, including any*
32 *term of probation, incarceration or supervised release, was*
33 *completed within the 10 previous years; or*

34 (b) *An offense involving conduct that would be immune from*
35 *arrest, prosecution or penalty pursuant to sections 10 to 20,*
36 *inclusive, of this act, except that the conduct occurred before*
37 *January 1, 2014, or was prosecuted by an authority other than the*
38 *State of Nevada.*

39 Sec. 7.3. *“Facility for the production of edible marijuana*
40 *products” means a business that:*

41 1. *Is registered with the Division pursuant to section 10 of*
42 *this act; and*

43 2. *Acquires, possesses, manufactures, delivers, transfers,*
44 *transports, supplies or sells edible marijuana products to medical*
45 *marijuana dispensaries.*



1 **Sec. 7.7.** *“Inventory control system” means a process, device*
2 *or other contrivance that may be used to monitor the chain of*
3 *custody of marijuana used for medical purposes from the point of*
4 *cultivation to the end consumer.*

5 **Sec. 8.** *“Medical marijuana dispensary” means a business*
6 *that:*

7 1. *Is registered with the Division pursuant to section 10 of*
8 *this act; and*

9 2. *Acquires, possesses, delivers, transfers, transports,*
10 *supplies, sells or dispenses marijuana or related supplies and*
11 *educational materials to the holder of a valid registry*
12 *identification card.*

13 **Sec. 8.3.** *“Medical marijuana establishment” means:*

14 1. *A cultivation facility;*

15 2. *A facility for the production of edible marijuana products;*

16 3. *A medical marijuana dispensary; or*

17 4. *A business that has registered with the Division and paid*
18 *the requisite fees to act as more than one of the types of businesses*
19 *listed in subsections 1, 2 and 3.*

20 **Sec. 8.5.** *“Medical marijuana establishment agent” means*
21 *an owner, officer, board member, employee or volunteer of a*
22 *medical marijuana establishment.*

23 **Sec. 8.6.** *“Medical marijuana establishment agent*
24 *registration card” means a registration card that is issued by the*
25 *Division pursuant to section 13 of this act to authorize a person to*
26 *volunteer or work at a medical marijuana establishment.*

27 **Sec. 8.7.** *“Medical marijuana establishment registration*
28 *certificate” means a registration certificate that is issued by the*
29 *Division pursuant to section 10 of this act to authorize the*
30 *operation of a medical marijuana establishment.*

31 **Sec. 8.8.** *“THC” means delta-9-tetrahydrocannabinol, which*
32 *is the primary active ingredient in marijuana.*

33 **Sec. 9.** (Deleted by amendment.)

34 **Sec. 10.** 1. *Each medical marijuana establishment must*
35 *register with the Division.*

36 2. *A person who wishes to operate a medical marijuana*
37 *establishment:*

38 (a) *Must submit to the Division an application on a form*
39 *prescribed by the Division; and*

40 (b) *Must have been a resident of the State of Nevada for at*
41 *least 3 years immediately preceding the date on which he or she*
42 *submits the application.*

43 3. *Except as otherwise provided in sections 11 and 16 of this*
44 *act, not later than 90 days after receiving an application to operate*
45 *a medical marijuana establishment, the Division shall register the*



1 *medical marijuana establishment and issue a medical marijuana*
2 *establishment registration certificate and a random 20-digit*
3 *alphanumeric identification number if:*

4 (a) *The person who wishes to operate the proposed medical*
5 *marijuana establishment has submitted to the Division all of the*
6 *following:*

7 (1) *The application fee, as set forth in section 12 of this act;*

8 (2) *An application, which must include:*

9 (I) *The legal name of the proposed medical marijuana*
10 *establishment;*

11 (II) *The physical address where the proposed medical*
12 *marijuana establishment will be located and the physical address*
13 *of any co-owned additional or otherwise associated medical*
14 *marijuana establishments, the locations of which may not be*
15 *within 1,000 feet of a public or private school that provides formal*
16 *education traditionally associated with preschool or kindergarten*
17 *through grade 12, and that existed on the date on which the*
18 *application for the proposed medical marijuana establishment was*
19 *submitted to the Division;*

20 (III) *Evidence that the applicant controls not less than*
21 *\$150,000 in liquid assets to cover the initial expenses of opening*
22 *the proposed medical marijuana establishment and complying*
23 *with the provisions of sections 10 to 20, inclusive, of this act;*

24 (IV) *Evidence that the applicant owns the property on*
25 *which the proposed medical marijuana establishment will be*
26 *located or has the written permission of the property owner to*
27 *operate the proposed medical marijuana establishment on that*
28 *property;*

29 (V) *For the applicant and each person who will be an*
30 *owner, officer or board member of the proposed medical*
31 *marijuana establishment, a complete set of the person's*
32 *fingerprints and written permission of the person authorizing the*
33 *Division to forward the fingerprints to the Central Repository for*
34 *Nevada Records of Criminal History for submission to the Federal*
35 *Bureau of Investigation for its report;*

36 (VI) *The name, address and date of birth of each person*
37 *who will be an owner, officer or board member of the proposed*
38 *medical marijuana establishment; and*

39 (VII) *The name, address and date of birth of each*
40 *person who will be employed by or otherwise provide labor at the*
41 *proposed medical marijuana establishment as a medical*
42 *marijuana establishment agent;*

43 (3) *Operating procedures consistent with rules of the*
44 *Division for oversight of the proposed medical marijuana*
45 *establishment, including, without limitation:*



1 (I) Procedures to ensure the use of adequate security
2 measures; and

3 (II) The use of an electronic verification system and an
4 inventory control system, pursuant to sections 19.1 and 19.2 of this
5 act;

6 (4) If the proposed medical marijuana establishment will
7 sell or deliver edible marijuana products, proposed operating
8 procedures for handling such products which must be
9 preapproved by the Division;

10 (5) If the city, town or county in which the proposed
11 medical marijuana establishment will be located has enacted
12 zoning restrictions, a sworn statement certifying that the proposed
13 medical marijuana establishment is in compliance with those
14 restrictions; and

15 (6) Such other information as the Division may require by
16 regulation;

17 (b) None of the persons who would be owners, officers or
18 board members of the proposed medical marijuana establishment
19 have been convicted of an excluded felony offense;

20 (c) None of the persons who would be owners, officers or
21 board members of the proposed medical marijuana establishment
22 have:

23 (1) Served as an owner, officer or board member for a
24 medical marijuana establishment that has had its medical
25 marijuana establishment registration certificate revoked; or

26 (2) Previously had a medical marijuana establishment
27 agent registration card revoked; and

28 (d) None of the persons who would be owners, officers or
29 board members of the proposed medical marijuana establishment
30 are under 21 years of age.

31 4. For each person who submits an application pursuant to
32 this section, and each person who would be an owner, officer or
33 board member of a proposed medical marijuana establishment,
34 the Division shall submit the fingerprints of the person to the
35 Central Repository for Nevada Records of Criminal History for
36 submission to the Federal Bureau of Investigation to determine
37 the criminal history of that person.

38 5. If an application for registration as a medical marijuana
39 establishment satisfies the requirements of this section and the
40 establishment is not disqualified from being registered as a
41 medical marijuana establishment pursuant to this section or other
42 applicable law, the Division shall issue to the establishment a
43 medical marijuana establishment registration certificate. A
44 medical marijuana establishment registration certificate expires 1
45 year after the date of issuance and may be renewed upon:



1 (a) *Resubmission of the information set forth in this section;*
2 *and*

3 (b) *Payment of the renewal fee set forth in section 12 of this*
4 *act.*

5 **Sec. 10.5.** *Each medical marijuana establishment must:*

6 1. *Be located in a separate building or facility;*

7 2. *Comply with local zoning ordinances and rules;*

8 3. *Have an appearance, both as to the interior and exterior,*
9 *that is professional, orderly, dignified and consistent with the*
10 *traditional style of pharmacies and medical offices; and*

11 4. *Have discreet and professional signage that is consistent*
12 *with the traditional style of signage for pharmacies and medical*
13 *offices.*

14 **Sec. 11. 1.** *Except as otherwise provided in this section, the*
15 *Division shall issue medical marijuana establishment registration*
16 *certificates for medical marijuana dispensaries in the following*
17 *quantities for applicants who qualify pursuant to section 10 of this*
18 *act:*

19 (a) *In a county whose population is 700,000 or more, 40*
20 *certificates;*

21 (b) *In a county whose population is 100,000 or more but less*
22 *than 700,000, 10 certificates;*

23 (c) *In a county whose population is 55,000 or more but less*
24 *than 100,000, 2 certificates; and*

25 (d) *In each other county, 1 certificate.*

26 2. *Notwithstanding the provisions of subsection 1, the*
27 *Division shall not issue medical marijuana establishment*
28 *registration certificates for medical marijuana dispensaries in*
29 *such a quantity as to cause the existence within the applicable*
30 *county of more than one medical marijuana dispensary for every*
31 *10 pharmacies that have been licensed in the county pursuant to*
32 *chapter 639 of NRS. The Division may issue medical marijuana*
33 *establishment registration certificates for medical marijuana*
34 *dispensaries in excess of the ratio otherwise allowed pursuant to*
35 *this subsection if to do so is necessary to ensure that the Division*
36 *issues at least one medical marijuana establishment registration*
37 *certificate in each county of this State in which the Division has*
38 *approved an application for such an establishment to operate.*

39 3. *With respect to medical marijuana establishments that are*
40 *not medical marijuana dispensaries, the Division shall determine*
41 *the appropriate number of such establishments as are necessary to*
42 *serve and supply the medical marijuana dispensaries to which the*
43 *Division has granted medical marijuana establishment*
44 *registration certificates.*



1 4. The Division shall not, for more than a total of 10 business
2 days in any 1 calendar year, accept applications to operate medical
3 marijuana establishments.

4 Sec. 12. 1. Except as otherwise provided in subsection 2,
5 the Division shall collect not more than the following maximum
6 fees:

7	
8	For the initial issuance of a medical marijuana
9	establishment registration certificate for a
10	medical marijuana dispensary..... \$20,000
11	For the renewal of a medical marijuana
12	establishment registration certificate for a
13	medical marijuana dispensary..... 5,000
14	For the initial issuance of a medical marijuana
15	establishment registration certificate for a
16	cultivation facility..... 3,000
17	For the renewal of a medical marijuana
18	establishment registration certificate for a
19	cultivation facility..... 1,000
20	For the initial issuance of a medical marijuana
21	establishment registration certificate for a
22	facility for the production of edible marijuana
23	products..... 2,000
24	For the renewal of a medical marijuana
25	establishment registration certificate for a
26	facility for the production of edible marijuana
27	products..... 750
28	For the initial issuance of a medical marijuana
29	establishment agent registration card..... 500
30	For the renewal of a medical marijuana
31	establishment agent registration card..... 500
32	

33 2. In addition to the fees described in subsection 1, each
34 applicant for a medical marijuana establishment registration
35 certificate must pay to the Division:

- 36 (a) A one-time, nonrefundable application fee of \$5,000; and
- 37 (b) The actual costs incurred by the Division in processing the
- 38 application, including, without limitation, conducting background
- 39 checks.

40 3. Any revenue generated from the fees imposed pursuant to
41 this section:

- 42 (a) Must be expended first to pay the costs of the Division in
- 43 carrying out the provisions of sections 10 to 20, inclusive of this
- 44 act; and



1 (b) If any excess revenue remains after paying the costs
2 described in paragraph (a), such excess revenue must be paid over
3 to the State Treasurer to be deposited to the credit of the State
4 Distributive School Account in the State General Fund.

5 **Sec. 13. 1.** A person shall not volunteer or work at a
6 medical marijuana establishment as a medical marijuana
7 establishment agent unless the person is registered with the
8 Division pursuant to this section.

9 2. A medical marijuana establishment that wishes to retain as
10 a volunteer or employ a medical marijuana establishment agent
11 shall submit to the Division an application on a form prescribed by
12 the Division. The application must be accompanied by:

13 (a) The name, address and date of birth of the prospective
14 medical marijuana establishment agent;

15 (b) A statement signed by the prospective medical marijuana
16 establishment agent pledging not to dispense or otherwise divert
17 marijuana to any person who is not authorized to possess
18 marijuana in accordance with the provisions of this chapter;

19 (c) A statement signed by the prospective medical marijuana
20 establishment agent asserting that he or she has not previously
21 had a medical marijuana establishment agent registration card
22 revoked;

23 (d) A complete set of the fingerprints and written permission of
24 the prospective medical marijuana establishment agent
25 authorizing the Division to forward the fingerprints to the Central
26 Repository for Nevada Records of Criminal History for submission
27 to the Federal Bureau of Investigation for its report;

28 (e) The application fee, as set forth in section 12 of this act;
29 and

30 (f) Such other information as the Division may require by
31 regulation.

32 3. A medical marijuana establishment shall notify the
33 Division within 10 days after a medical marijuana establishment
34 agent ceases to be employed by or volunteer at the medical
35 marijuana establishment.

36 4. A person who:

37 (a) Has been convicted of an excluded felony offense; or

38 (b) Is less than 21 years of age,

39 ↪ shall not serve as a medical marijuana establishment agent.

40 5. The Division shall submit the fingerprints of an applicant
41 for registration as a medical marijuana establishment agent to the
42 Central Repository for Nevada Records of Criminal History for
43 submission to the Federal Bureau of Investigation to determine
44 the criminal history of the applicant.



1 6. *The provisions of this section do not require a person who*
2 *is an owner, officer or board member of a medical marijuana*
3 *establishment to resubmit information already furnished to the*
4 *Division at the time the establishment was registered with the*
5 *Division.*

6 7. *If an applicant for registration as a medical marijuana*
7 *establishment agent satisfies the requirements of this section and*
8 *is not disqualified from serving as such an agent pursuant to this*
9 *section or any other applicable law, the Division shall issue to the*
10 *person a medical marijuana establishment agent registration card.*
11 *A medical marijuana establishment agent registration card expires*
12 *1 year after the date of issuance and may be renewed upon:*

13 (a) *Resubmission of the information set forth in this section;*
14 *and*

15 (b) *Payment of the renewal fee set forth in section 12 of this*
16 *act.*

17 **Sec. 14. 1.** *In addition to any other requirements set forth*
18 *in this chapter, an applicant for the issuance or renewal of a*
19 *medical marijuana establishment agent registration card or*
20 *medical marijuana establishment registration certificate shall:*

21 (a) *Include the social security number of the applicant in the*
22 *application submitted to the Division.*

23 (b) *Submit to the Division the statement prescribed by the*
24 *Division of Welfare and Supportive Services of the Department of*
25 *Health and Human Services pursuant to NRS 425.520. The*
26 *statement must be completed and signed by the applicant.*

27 2. *The Division shall include the statement required pursuant*
28 *to subsection 1 in:*

29 (a) *The application or any other forms that must be submitted*
30 *for the issuance or renewal of the medical marijuana*
31 *establishment agent registration card or medical marijuana*
32 *establishment registration certificate; or*

33 (b) *A separate form prescribed by the Division.*

34 3. *A medical marijuana establishment agent registration card*
35 *or medical marijuana establishment registration certificate may*
36 *not be issued or renewed by the Division if the applicant:*

37 (a) *Fails to submit the statement required pursuant to*
38 *subsection 1; or*

39 (b) *Indicates on the statement submitted pursuant to*
40 *subsection 1 that the applicant is subject to a court order for the*
41 *support of a child and is not in compliance with the order or a*
42 *plan approved by the district attorney or other public agency*
43 *enforcing the order for the repayment of the amount owed*
44 *pursuant to the order.*



1 4. *If an applicant indicates on the statement submitted*
2 *pursuant to subsection 1 that the applicant is subject to a court*
3 *order for the support of a child and is not in compliance with the*
4 *order or a plan approved by the district attorney or other public*
5 *agency enforcing the order for the repayment of the amount owed*
6 *pursuant to the order, the Division shall advise the applicant to*
7 *contact the district attorney or other public agency enforcing the*
8 *order to determine the actions that the applicant may take to*
9 *satisfy the arrearage.*

10 **Sec. 15.** *1. If the Division receives a copy of a court order*
11 *issued pursuant to NRS 425.540 that provides for the suspension*
12 *of all professional, occupational and recreational licenses,*
13 *certificates and permits issued to a person who is the holder of a*
14 *medical marijuana establishment agent registration card or*
15 *medical marijuana establishment registration certificate, the*
16 *Division shall deem the card or certificate issued to that person to*
17 *be suspended at the end of the 30th day after the date on which the*
18 *court order was issued unless the Division receives a letter issued*
19 *to the holder of the card or certificate by the district attorney or*
20 *other public agency pursuant to NRS 425.550 stating that the*
21 *holder of the card or certificate has complied with the subpoena or*
22 *warrant or has satisfied the arrearage pursuant to NRS 425.560.*

23 *2. The Division shall reinstate a medical marijuana*
24 *establishment agent registration card or medical marijuana*
25 *establishment registration certificate that has been suspended by a*
26 *district court pursuant to NRS 425.540 if the Division receives a*
27 *letter issued by the district attorney or other public agency*
28 *pursuant to NRS 425.550 to the person whose card or certificate*
29 *was suspended stating that the person whose card or certificate*
30 *was suspended has complied with the subpoena or warrant or has*
31 *satisfied the arrearage pursuant to NRS 425.560.*

32 **Sec. 16.** *The following acts constitute grounds for immediate*
33 *revocation of a medical marijuana establishment registration*
34 *certificate:*

35 *1. Dispensing, delivering or otherwise transferring marijuana*
36 *to a person other than a medical marijuana establishment agent,*
37 *another medical marijuana establishment, a patient who holds a*
38 *valid registry identification card or the designated primary*
39 *caregiver of such a patient.*

40 *2. Acquiring usable marijuana or mature marijuana plants*
41 *from any person other than a medical marijuana establishment*
42 *agent, another medical marijuana establishment, a patient who*
43 *holds a valid registry identification card or the designated primary*
44 *caregiver of such a patient.*



1 3. *Violating a regulation of the Division, the violation of*
2 *which is stated to be grounds for immediate revocation of a*
3 *medical marijuana establishment registration certificate.*

4 **Sec. 17.** *The following acts constitute grounds for the*
5 *immediate revocation of the medical marijuana establishment*
6 *agent registration card of a medical marijuana establishment*
7 *agent:*

8 1. *Having committed or committing any excluded felony*
9 *offense.*

10 2. *Dispensing, delivering or otherwise transferring marijuana*
11 *to a person other than a medical marijuana establishment agent,*
12 *another medical marijuana establishment, a patient who holds a*
13 *valid registry identification card or the designated primary*
14 *caregiver of such a patient.*

15 3. *Violating a regulation of the Division, the violation of*
16 *which is stated to be grounds for immediate revocation of a*
17 *medical marijuana establishment agent registration card.*

18 **Sec. 18.** *The purpose for registering medical marijuana*
19 *establishments and medical marijuana establishment agents is to*
20 *protect the public health and safety and the general welfare of the*
21 *people of this State. Any medical marijuana establishment*
22 *registration certificate issued pursuant to section 10 of this act and*
23 *any medical marijuana establishment agent registration card*
24 *issued pursuant to section 13 of this act is a revocable privilege*

27 **Sec. 19.** 1. *The operating documents of a medical*

31 (b) *To ensure accurate recordkeeping, including, without*
