

House Bill 2442

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Governor John A. Kitzhaber, M.D., for Housing and Community Services Department)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Changes name of State Housing Council to Oregon Housing Stability Council. Increases membership of council.

Abolishes advisory committee on energy, Interagency Council on Hunger and Homelessness and Community Development Incentive Advisory Board.

Transfers responsibility as lead public body administering state policy on hunger from Housing and Community Services Department to Department of Human Services.

12 **SECTION 1.** ORS 456.395 is amended to read:

13 456.395. The Housing and Community Services Department and [*State Housing Council*] **the**
14 **Oregon Housing Stability Council** shall cooperate with and assist local housing authorities as de-
15 fined in ORS 456.375 to obtain federal approval, renewal of an existing waiver of federal require-
16 ments or a new waiver of federal requirements, as necessary to make the use and distribution of
17 federal rent subsidy and assistance payments under 42 U.S.C. 1437f as efficient and beneficial as
18 possible to increase the supply of decent, safe, sanitary and affordable housing for persons of low
19 income and very low income in this state.

20 **SECTION 2.** ORS 456.515 is amended to read:

21 456.515. As used in ORS 456.515 to 456.725 and ORS chapter 458 unless the context requires
22 otherwise:

23 (1) "Community Action Partnership of Oregon" means an organization described in ORS 458.505.

24 (2) "Construction" includes, but is not limited to, new construction or moderate or substantial
25 rehabilitation of existing structures or facilities.

26 (3) "Council" means the [*State Housing Council*] **Oregon Housing Stability Council** established
27 under ORS 456.567.

28 (4) "Department" means the Housing and Community Services Department established under

2 (5) "Director" means the Director of the Housing and Community Services Department.

3 (6) "Elderly household" means a household whose head is over the age of 55, residing in this
4 state.

5 (7) "Major life activity" includes but is not limited to self-care, ambulation, communication,
6 transportation, education, socialization, employment and ability to acquire, rent or maintain prop-
7 erty.

8 (8)(a) "Multifamily housing" means a structure or facility established primarily to provide
9 housing that provides more than one living unit, and may also provide facilities that are functionally
10 related and subordinate to the living units for use by the occupants in social, health, educational
11 or recreational activities:

12 (A) For the elderly, including but not limited to individual living units within such structures,
13 mobile home and manufactured dwelling parks and residential facilities licensed under ORS 443.400
14 to 443.455 and other congregate care facilities with or without domiciliary care.

15 (B) For persons with disabilities, including, but not limited to, individual living units within such
16 structures, mobile home and manufactured dwelling parks and residential facilities licensed under
17 ORS 443.400 to 443.455 and other congregate care facilities with or without domiciliary care.

18 (b) "Multifamily housing" does not include nursing homes, hospitals, places primarily engaged
19 in recreational activities and single-family, detached dwellings, except manufactured dwellings situ-
20 ated in a mobile home and manufactured dwelling park.

21 (9) "Person with a disability" means a person who has a physical or mental impairment that
22 substantially limits one or more major life activities.

23 (10) "Target population" means:

24 (a) Elderly households; or

25 (b) Persons with disabilities.

26 **SECTION 3.** ORS 456.539 is amended to read:

27 456.539. (1) The Housing and Community Services Department shall be the agency for the State
28 of Oregon for the administration of the Elderly and Disabled Housing Fund. Except as otherwise
29 provided in ORS 456.515 to 456.725 the provisions of ORS 456.515 to 456.725 are applicable to the
30 administration of the Elderly and Disabled Housing Fund.

31 (2) The department is authorized to use the Elderly and Disabled Housing Fund to advance
32 funds, by contract, grant, loan or otherwise, as provided by Article XI-I(2) of the Oregon Constitu-
33 tion to finance multifamily housing for elderly households, persons with disabilities and their family
34 members and such other persons who reside therein as are necessary to maintain the housing or
35 provide services or companionship for elderly households and persons with disabilities.

36 (3) In carrying out the provisions specified in Article XI-I(2) of the Oregon Constitution, the
37 department shall, with the concurrence of the [*State Housing Council*] **Oregon Housing Stability**
38 **Council**, adopt criteria for approval of projects proposed by qualified housing sponsors to finance
39 multifamily housing for the target population and their family members and such other persons who
40 reside therein as are necessary to maintain the housing or provide services or companionship for
41 elderly households and persons with disabilities. The criteria shall:

42 (a) Assure that health, mental health and other supportive services as may be necessary to
43 maintain elderly and disabled households living in the housing are available to the occupants onsite
44 or in the community;

45 (b) Give priority to members of the target populations; and

1 (c) Allow occupancy by such family members or other persons as the department determines
 2 necessary to maintain the housing and provide services or companionship for elderly households and
 3 persons with disabilities.

4 (4) The department shall:

5 (a) Adopt criteria consistent with the maximum household income restrictions in ORS 456.620
 6 (4) for approval of applications for financing the purchase by elderly households of ownership in-
 7 terests within a multifamily structure or facility.

8 (b) Provide means for allocating funds to finance multifamily housing units for the target popu-
 9 lation and to establish limitations on the interest and fees to be charged on loans made by the de-
 10 partment.

11 (c) Adopt rules necessary for efficient administration of the Elderly and Disabled Housing Fund.

12 (d) Adopt rules to assure that each of the target populations has access to a reasonable portion
 13 of the bond authority under ORS 456.515 to 456.725, and that a reasonable portion of the funds for
 14 elderly households is made available to finance the purchase by elderly households of ownership
 15 interests within multifamily housing structures or facilities.

16 (5) Loans made by the department under this section for the interim construction financing of
 17 multifamily housing shall be subject to the provisions of ORS 456.717.

18 **SECTION 4.** ORS 456.541 is amended to read:

19 456.541. The Housing and Community Services Department shall and the [*State Housing*
 20 *Council*] **Oregon Housing Stability Council** may consult generally with the Department of Human
 21 Services and such other persons as the council or Housing and Community Services Department
 22 may consider appropriate concerning project applications for housing for disabled households. The
 23 Housing and Community Services Department shall seek comment on such project applications
 24 concerning:

25 (1) The need for and design of the project generally, considering the proposed location of the
 26 housing;

27 (2) The means proposed for screening eligibility for occupancy to assure that priority will be
 28 given to members of the target populations of persons with disabilities; and

29 (3) The adequacy of the provisions for assuring the availability of health, mental health and
 30 other supportive services necessary to maintain disabled households in the housing.

31 **SECTION 5.** ORS 456.548 is amended to read:

32 456.548. As used in ORS 456.548 to 456.725, unless the context requires otherwise:

33 (1) "Bonds" means any bonds, as defined in ORS 286A.001, or any other evidence of indebt-
 34 edness, issued under ORS 456.515 to 456.725 or issued in anticipation of bonds and payable from the
 35 proceeds of bonds issued.

36 (2) "Capital reserve account" or "capital reserve accounts" means one or more of the special
 37 trust accounts that may be established by the Housing and Community Services Department within
 38 the Housing Finance Fund.

39 (3) "Consumer housing cooperative" means a cooperative corporation formed under ORS chapter
 40 62 and whose articles of incorporation provide, in addition to the other requirements of ORS chapter
 41 62, that:

42 (a) The consumer housing cooperative has been organized exclusively to provide housing facili-
 43 ties for persons and families of lower income and such social, recreational, commercial and com-
 44 munal facilities as may be incidental to such housing facilities.

45 (b) All income and earnings of the consumer housing cooperative shall be used exclusively for

1 consumer housing cooperative purposes and that no unreasonable part of the net income or net
 2 earnings of the cooperative shall inure to the benefit or profit of any private individual, firm, cor-
 3 poration, partnership or association.

4 (c) The consumer housing cooperative is in no manner controlled or under the direction of or
 5 acting in the substantial interest of any private individual, firm, corporation, partnership or associ-
 6 ation seeking to derive profit or gain therefrom or seeking to eliminate or minimize losses in any
 7 transaction therewith, except that such limitation shall apply to the members of the cooperative only
 8 to the extent provided by rules of the department.

9 (d) The operations of the consumer housing cooperative may be supervised by the department
 10 and that the consumer housing cooperative shall enter into such agreements with the department
 11 as the department may require to provide regulation by the department of the planning, development
 12 and management of any housing project undertaken by the cooperative and the disposition of the
 13 property and other interests of the cooperative.

14 (4) "Development costs" means the costs that have been approved by the department as appro-
 15 priate expenditures and includes, but is not limited to:

16 (a) Payments for options to purchase property for the proposed housing project site, deposits on
 17 contracts of purchase, payments for the purchase of property as approved by the department, legal,
 18 organizational and marketing expenses including payment of attorney fees, managerial and clerical
 19 staff salaries, office rent and other incidental expenses, payment of fees for preliminary feasibility
 20 studies, advances for planning, engineering and architectural work;

21 (b) Expenses for surveys as to need and market analyses; and

22 (c) Such other expenses incurred by the qualified housing sponsor as the department may deem
 23 necessary under ORS 456.548 to 456.725.

24 (5) "Federally insured security" means an evidence of indebtedness insured or guaranteed as to
 25 repayment of principal and interest by the United States or an agency or instrumentality thereof.

26 (6) "Housing development" means a development that contains housing units for persons or
 27 families of lower income and such other incidental elements of residential, commercial, recreational,
 28 industrial, communal or educational facilities as the department determines improve the quality of
 29 the development as it relates to housing for persons or families of lower income and the financial
 30 feasibility of the development.

31 (7) "Housing finance bond declaration" means a written instrument signed by the Director of the
 32 Housing and Community Services Department and on file with and bearing the certificate of ap-
 33 proval of the State Treasurer or the designee of the State Treasurer, and all housing finance bond
 34 declarations supplemental to that instrument.

35 (8) "Housing Finance Fund" means the Housing Finance Fund established in ORS 456.720 (1).

36 (9) "Lending institution" means any bank, mortgage banking company, trust company, savings
 37 bank, credit union, national banking association, federal savings and loan association or federal
 38 credit unit maintaining an office in this state, or any insurance company authorized to do business
 39 in this state.

40 (10) "Limited dividend housing sponsor" means a corporation, trust, partnership, association or
 41 other entity, or an individual that is a mortgagor.

42 (11) "Manufactured dwelling park nonprofit cooperative" has the meaning given that term in
 43 ORS 62.803.

44 (12) "Manufactured housing" means a dwelling unit manufactured off-site having a minimum
 45 width of 10 feet and a minimum area of 400 square feet built on a permanent chassis and designed

1 to be used for permanent residential occupancy whether or not on a permanent foundation, and that
 2 contains permanent eating, cooking, sleeping and sanitary facilities and meets such standards as the
 3 department determines, by rule, are reasonable to maintain the quality, safety and durability of the
 4 dwelling, the sanitary requirements of the communities in which they are located and the security
 5 of the loans that the department may finance for the purchase of the dwellings.

6 (13) "Nonprofit housing corporation" means an organization formed under ORS chapter 65 and
 7 whose articles of incorporation provide, in addition to the other requirements of ORS chapter 65,
 8 that:

9 (a) The corporation has been organized exclusively to provide housing facilities for persons and
 10 families of lower income and such other social, recreational, commercial and communal facilities as
 11 may be incidental to such housing facilities.

12 (b) All the income and earnings of the corporation shall be used exclusively for corporation
 13 purposes and that no part of the net income or net earnings of the corporation may inure to the
 14 benefit of any private individual, firm, corporation, partnership or association.

15 (c) The corporation is in no manner controlled or under the direction or acting in the substan-
 16 tial interest of any private individual, firm, partnership or association seeking to derive profit or
 17 gain therefrom or seeking to eliminate or minimize losses in transactions therewith.

18 (d) The operations of the corporation may be supervised by the department and that the corpo-
 19 ration shall enter into such agreements with the department as the department may require to reg-
 20 ulate the planning, development and management of any housing project undertaken by the
 21 corporation and the disposition of the property and other interests of the corporation.

22 (14) "Person of lower income" or "family of lower income" means:

23 (a) A person or family residing in this state whose income is not more than 80 percent of area
 24 median income, adjusted for family size, as determined by the [*State Housing Council*] **Oregon**
 25 **Housing Stability Council** based upon information from the United States Department of Housing
 26 and Urban Development;

27 (b) A person or family residing in this state whose income, adjusted for family size, is below the
 28 level the Housing and Community Services Department has determined to be necessary in order to
 29 obtain in the open market decent, safe and sanitary housing, including the cost of utilities and taxes,
 30 for not more than 25 percent of the gross income of the person or family; or

31 (c) Any person or family the department determines is appropriate to treat as a person of lower
 32 income or a family of lower income incidental to the accomplishment of department programs for
 33 persons and families of lower income described in paragraphs (a) and (b) of this subsection.

34 (15) "Project cost" or "costs of the project" means the sum of all reasonable expenses incurred
 35 by a qualified housing sponsor in undertaking and completing a housing project approved by the
 36 department. "Project costs" or "costs of the project" include but are not limited to the expenses
 37 incurred by a qualified housing sponsor for:

38 (a) Studies and surveys;

39 (b) Plans, specifications, architectural and engineering services;

40 (c) Legal, organizational and other special services;

41 (d) Financing, acquisition, demolition, construction, equipment and site development of new and
 42 rehabilitated housing units;

43 (e) Movement of existing buildings to new sites; the cost of acquisition, or estimated fair market
 44 value, of land and other interests in real estate;

45 (f) Rehabilitation, reconstruction, repair or remodeling of existing buildings;

- 1 (g) Estimated carrying charges during construction and for a reasonable period thereafter;
- 2 (h) Placement of tenants or occupants and relocation services in connection with the housing
- 3 project;
- 4 (i) Reasonable builder's or sponsor's profit and risk allowance; and
- 5 (j) Development costs not otherwise included in this subsection.
- 6 (16) "Qualified housing sponsor" includes, subject to the approval of the department:
- 7 (a) A consumer housing cooperative;
- 8 (b) A limited dividend housing sponsor;
- 9 (c) A nonprofit housing corporation;
- 10 (d) A for-profit housing sponsor including, but not limited to, an individual operating in compli-
- 11 ance with the criteria adopted by the department under ORS 456.620 (1);
- 12 (e) A housing authority created by ORS 456.075;
- 13 (f) An urban renewal agency created by ORS 457.035; and
- 14 (g) Any city or county governing body or agency or department designated by the governing
- 15 body.
- 16 (17) "Residential housing" means a specific work or improvement within this state undertaken
- 17 primarily to provide dwelling accommodations, including land development and acquisition, con-
- 18 struction or rehabilitation of buildings and improvements thereto, for residential housing, and such
- 19 other nonhousing facilities as may be incidental or appurtenant thereto and as the department de-
- 20 termines improve the quality of the development as it relates to housing for persons or families of
- 21 lower income and the financial feasibility of the development. "Residential housing" includes, but
- 22 is not limited to, a specific work or improvement within this state undertaken to provide mobile
- 23 home or manufactured dwelling parks as defined in ORS 446.003. As used in this subsection, "land
- 24 development" includes, but is not limited to, the improvement of streets and alleys and the con-
- 25 struction of surface drains, sewers, curbing and sidewalks.
- 26 (18) "Residential loan" means any of the following:
- 27 (a) A loan that is for the acquisition, construction, improvement or rehabilitation of residential
- 28 housing and, if the loan is for acquisition or construction of residential housing, that is secured by
- 29 a first lien on real property located in the state and:
- 30 (A) Improved by a newly constructed, existing or rehabilitated residential structure for persons
- 31 or families of lower income; or
- 32 (B) Unimproved if the proceeds of such loan shall be used for the erection of a residential
- 33 structure thereon, whether or not such loan is insured or guaranteed by the United States or any
- 34 instrumentality or agency thereof.
- 35 (b) An insured or guaranteed loan for the acquisition of manufactured housing or for the ac-
- 36 quisition of a lot described in ORS 92.840 by a manufactured dwelling park tenant.
- 37 (c) A loan for the purchase of a proprietary lease and related cooperative shares in a housing
- 38 cooperative formed under ORS chapter 62 secured by a security interest of first priority and a
- 39 pledge or an assignment of proprietary leases and related cooperative shares.
- 40 (19) "Revolving account" means the Housing and Community Services Department Revolving
- 41 Account created in ORS 456.574.
- 42 **SECTION 6.** ORS 456.555 is amended to read:
- 43 456.555. (1) The Housing and Community Services Department is established.
- 44 (2) The department shall be under the supervision and control of a director who is responsible
- 45 for the performance of the duties imposed upon the department. The Governor shall appoint the

1 Director of the Housing and Community Services Department. The director shall hold office at the
 2 pleasure of the Governor. The person appointed as director shall be a person who, by training and
 3 experience, is well qualified to perform the duties of the office.

4 (3) The director shall receive such salary as may be provided by law, or, if not so provided, as
 5 may be fixed by the Governor. In addition to the salary of the director, the director shall, subject
 6 to the limitations otherwise provided by law, be reimbursed for all expenses actually and necessarily
 7 incurred by the director in the performance of official duties.

8 (4) The director may establish department divisions including but not limited to divisions for
 9 administration, housing programs and community services programs.

10 (5) The [State Housing Council] **Oregon Housing Stability Council** shall:

11 (a) With the advice of the director, set policy and approve or disapprove rules and standards for
 12 housing programs;

13 (b) Approve or disapprove loans, grants and other funding award proposals under ORS 456.561;
 14 and

15 (c) Carry out the provisions of ORS 456.571.

16 (6) The Community Action Partnership of Oregon, **in conjunction with the Oregon Housing**
 17 **Stability Council**, shall advise the department [and the council] on community services programs
 18 as determined by the director and as set forth in ORS 458.505.

19 (7) The director shall report regularly to the council to keep the council informed on progress
 20 made by the department in carrying out the department's responsibilities for housing programs.

21 (8) The department may adopt rules to carry out the programs that the department is charged
 22 with administering, including, but not limited to, rules regarding:

23 (a) Administration and enforcement.

24 (b) Criteria for the granting of benefits.

25 (c) The establishment of fees and charges.

26 (d) The identification of housing programs and community services programs.

27 (e) The distinguishing of housing programs from community services programs.

28 (9) Subject to the approval of the council, the department shall establish by rule one or more
 29 threshold property purchase prices above which a housing loan proposed by the department requires
 30 council review and approval under ORS 456.561. In establishing or modifying a threshold property
 31 purchase price under this subsection, the department shall consider any maximum acquisition cost
 32 set forth in the Internal Revenue Code or federal rules and regulations implementing the code.

33 (10) Subject to the approval of the council, the department shall establish by rule one or more
 34 threshold amounts above which a housing grant or other housing funding award proposal requires
 35 council review and approval under ORS 456.561.

36 **SECTION 7.** ORS 456.559 is amended to read:

37 456.559. (1) The Housing and Community Services Department shall:

38 (a) Maintain current housing data and information concerning available programs, status of
 39 funding, programs planned or undertaken which might conflict with, overlap, duplicate or supersede
 40 other planned or existing programs and call these to the attention of appropriate state agencies,
 41 governmental bodies and public or private housing sponsors.

42 (b) Provide to appropriate state agencies, governmental bodies and public or private housing
 43 sponsors such advisory and educational services as will assist them in the development of housing
 44 plans and projects.

45 (c) Subject to the approval of the [State Housing Council] **Oregon Housing Stability Council**,

1 make noninterest bearing advances, in accordance with ORS 456.710 and the policies of the depart-
2 ment, to qualified nonprofit sponsors for development costs of housing projects until mortgage funds
3 are released to repay the advances as provided in ORS 456.710.

4 (d) Advise and assist appropriate state agencies, governmental bodies and public or private
5 housing sponsors, cities and counties, in all programs and activities which are designed or might
6 tend to fulfill the purposes of ORS 456.548 to 456.725 and ORS chapter 458.

7 (e) Encourage and assist in the planning, development, construction, rehabilitation and conser-
8 vation of dwelling units for persons and families of lower income.

9 (f) Be the central state department to apply for, receive and distribute, on behalf of appropriate
10 state agencies, governmental bodies and public or private housing sponsors in the state, grants, gifts,
11 contributions, loans, credits or assistance from the federal government or any other source for
12 housing programs except when the donor, grantor, or lender of such funds specifically directs some
13 other agency to administer them. Moneys received under this section shall be deposited with the
14 State Treasurer in an account separate and distinct from the General Fund. Interest earned by the
15 account shall be credited to the account.

16 (g) For the purposes of acquiring moneys, credits or other assistance from any agency or
17 instrumentality of the United States or from any public corporation chartered by the United States,
18 comply with any applicable agreements or restrictions for the receipt of such assistance and become
19 a member of any such association or public corporation chartered by the United States.

20 (h) Assist individuals, appropriate state agencies, governmental bodies and public or private
21 housing sponsors through a program which provides housing information, planning, educational
22 services and technical assistance.

23 (i) Comply with the requirements of ORS 443.225 in assisting in the development of any housing
24 for residential care, training or treatment for persons with mental retardation, developmental disa-
25 bilities or mental or emotional disturbances.

26 (2) Except as otherwise provided in ORS 456.625 (7), the department may not itself develop,
27 construct, rehabilitate or conserve housing units; and neither the department nor any housing
28 sponsor, including but not limited to any association, corporation, cooperative housing authority or
29 urban renewal agency organized to provide housing and other facilities pursuant to ORS 456.548 to
30 456.725, may own, acquire, construct, purchase, lease, operate or maintain utility facilities, including
31 facilities for the generation of electricity, for the distribution of gas and electricity, and for the
32 conveyance of telephone and telegraph messages.

33 (3) In accordance with the provisions of this section and with the advice of the council, the
34 department shall establish statewide priorities for housing programs. State agencies shall coordinate
35 their housing programs with the department. All state agencies intending to apply for federal funds
36 for use in planning, developing or managing housing, or rendering assistance to governmental bodies
37 or sponsors or individuals involved therein shall submit a description of the proposed activity to the
38 department for review not less than 30 days prior to the intended date of submission of the appli-
39 cation to the federal agency. The department shall determine whether the proposal would result in
40 a program that would overlap, duplicate or conflict with any other housing program in the state. If
41 the department finds overlapping or duplication or conflict, it shall recommend modifications in the
42 application. The Oregon Department of Administrative Services shall consider these recommen-
43 dations in making its decision to approve or disapprove the application. The department shall com-
44 plete its review and forward its recommendations within 15 working days after receipt of the
45 notification. Failure of the department to complete the review within that time shall constitute ap-

1 proval of the application by the department.

2 (4) The Director of the **Housing and Community Services Department** may participate in
 3 discussions and deliberations of the council. The director may suggest policies and rules to the
 4 council, including those necessary to stimulate and increase the supply of housing for persons and
 5 families of lower income.

6 **SECTION 8.** ORS 456.561 is amended to read:

7 456.561. (1) The Housing and Community Services Department may effect loans, grants and other
 8 funding awards to accomplish department housing programs, subject to any requirement under this
 9 section for review and approval by the [*State Housing Council*] **Oregon Housing Stability Council**
 10 of proposals for loans, grants or other funding awards.

11 (2) The department shall submit a loan, grant or other funding award proposal arising under
 12 ORS 456.515 to 456.725 programs to the council for review if the proposal is for:

13 (a) A housing loan on property that has a purchase price in excess of an applicable threshold
 14 property purchase price established by rule under ORS 456.555 (9); or

15 (b) A housing grant or other housing funding award in excess of an applicable threshold amount
 16 established by rule under ORS 456.555 (10).

17 (3) The council shall review each loan, grant or other funding award proposal submitted by the
 18 department under this section and approve or disapprove the loan, grant or other funding award
 19 proposal.

 22 include notice of the loan, grant or other funding award proposal review, the names of the appli-

 24 of a loan, grant or other funding award proposal review to the loan, grant or other funding award
 25 applicant not less than five days before the review hearing.

26 **SECTION 9.** ORS 456.567 is amended to read:

27 456.567. (1) The [*State Housing Council*] **Oregon Housing Stability Council** is established. The
 28 council shall consist of [*seven*] **nine** members appointed by the Governor subject to confirmation by

18 (f) Regulate fees and charges for inspection services, permits, or professional services related

20 (g) Encourage alternatives that increase housing choices;

21 (h) Create or avert overlapping jurisdictional functions and the concomitant increased costs that
22 are reflected in housing prices;

23 (i) Create or avoid conflicting state and federal regulations that deprive lower income house-

26 Development Commission under ORS 197.240.

27 (4) The council, with the approval of the Governor, may initiate legal proceedings in the name
28 of the council to further the council's purposes under this section.

29 (5) The council shall exercise the responsibilities and powers of the council in a manner that
30 expedites the acquisition, construction, improvement or rehabilitation of housing.

31 **(6) With respect to the Community Development Incentive Project Fund established un-**
32 **der ORS 458.720, the council shall develop program guidelines, including specific project cri-**
33 **teria and financing mechanisms, review applications seeking funding from the fund and make**
34 **recommendations for funding approval to the director and review proposals for cooperative**
35 **agreements or joint projects between the department and other state agencies to facilitate**

37 **(7) The council shall advise and assist the department with rules, policies and programs**

41 456.620. In carrying out housing programs, the Housing and Community Services Department
42 shall:

43 (1) With the approval of the [*State Housing Council*] **Oregon Housing Stability Council**, adopt
44 standards for the planning, development and management of housing projects for which qualified
45 housing sponsors receive all or a portion of any required financing under ORS 456.548 to 456.725,

1 for audits and inspections to determine compliance with such standards and adopt criteria for the
 2 approval of qualified housing sponsors under ORS 456.548 to 456.725.

3 (2) Adopt criteria for the approval of qualified housing sponsors in ORS 456.548 to 456.725.

4 (3) Enter into agreements with qualified housing sponsors to regulate the planning, development
 5 and management of housing projects constructed with the assistance of the department under ORS
 6 456.548 to 456.725.

7 (4) With the approval of the council, establish maximum household income limits for all or a
 8 portion of the units in housing projects, housing developments or other residential housing financed
 9 in whole or in part by the department. A maximum of one-third of the units in a housing project,
 10 housing development or other residential housing financed by the department may be rented to
 11 households with an income level exceeding 120 percent of the median family income level, as de-

17 (10) Cooperate with and exchange services, personnel and information with any federal, state
18 or local governmental agency.

19 (11) With the approval of the State Treasurer, contract for the services of and consultation with
20 trustees, investment and financial advisors, paying agents, remarketing agents and other profes-
21 sional persons or organizations in carrying out ORS 456.515 to 456.725 and ORS chapter 458.

22 (12) Contract for, act on or perform any other duties that the department considers necessary
23 or appropriate to carry out housing programs and community services programs, including but not
24 limited to contracting to provide compliance monitoring or other administrative functions with re-
25 spect to housing developments and affordable housing, whether or not the housing developments or
26 affordable housing receives department funding and whether or not the housing developments or
27 affordable housing is located within this state. For purposes of this subsection, "affordable
28 housing" has the meaning given that term in ORS 456.055.

29 (13) Purchase, service, sell and make commitments to purchase, service and sell residential loans

31 (14) Initiate or assist appropriate state agencies, governmental bodies and public or private
32 housing sponsors in the development, construction, acquisition, ownership, leasing, rehabilitation or
33 management of housing to carry out the purposes of ORS 456.515 to 456.725 and ORS chapter 458
34 where such housing is not otherwise affordable or available in the area.

35 (15) Execute and record written instruments that contain terms, including but not limited to
36 restrictive covenants or equitable servitudes, pertaining to the use and enjoyment of housing
37 projects. Notwithstanding any other provision of law, the executed instruments shall constitute and
38 create restrictive covenants affecting and running with the property according to the terms of the
39 instruments when recorded in the records of the county where the property is located. County clerks
40 shall accept the instruments for recording when presented by or on behalf of the department.

41 (16) Subject to the provisions of any agreement then existing with bondholders, make available
42 funds by contract, grant, loan or otherwise, including loan guarantees, insurance or other financial
43 leveraging techniques, from moneys made available by the department to carry out the purposes of

- 30 458.505. (1) The community action agency network, established initially under the federal Eco-
31 nomic Opportunity Act of 1964, shall be the delivery system for federal antipoverty programs in
32 Oregon, including the Community Services Block Grant, Low Income Energy Assistance Program,
33 State Department of Energy Weatherization Program and such others as may become available.
- 34 (2) Funds for such programs shall be distributed to the community action agencies by the
35 Housing and Community Services Department with the advice of the Community Action Partnership
36 of Oregon **and the Oregon Housing Stability Council**.
- 37 (3) In areas not served by a community action agency, funds other than federal community ser-
38 vices funds may be distributed to and administered by organizations that are found by the Housing
39 and Community Services Department to serve the antipoverty purpose of the community action
40 agency network.
- 41 (4) In addition to complying with all applicable requirements of federal law, a community action
42 agency shall:
- 43 (a) Be an office, division or agency of the designating political subdivision or a not for profit
44 organization in compliance with ORS chapter 65.
- 45 (b) Have a community action board of at least nine but no more than 33 members, constituted

1 so that:

2 (A) One-third of the members of the board are elected public officials currently serving or their
 3 designees. If the number of elected officials reasonably available and willing to serve is less than
 4 one-third of the membership, membership of appointed public officials may be counted as meeting the

6 (B) At least one-third of the members are persons chosen through democratic selection proce-
 7 dures adequate to assure that they are representatives of the poor in the area served; and

10 (c) If the agency is a private not for profit organization, be governed by the Community Action

14 (B) Approval of all contracts, grant applications and budgets and operational policies of the
 15 agency;

30 (g) Provide assurances against the use of government funds for political activity by the com-
 31 munity action agency.

32 (h) Provide assurances that no person shall, on the grounds of race, color, sex, sexual orien-
 33 tation or national origin be excluded from participation in, be denied the benefits of or be subjected
 34 to discrimination under any program or activity funded in whole or in part with funds made avail-
 35 able through the community action program.

36 (i) Provide assurances the community action agency shall comply with any prohibition against
 37 discrimination on the basis of age under the Age Discrimination Act of 1975 or with respect to an
 38 otherwise qualified individual with disabilities as provided in section 504 of the Rehabilitation Act
 39 of 1973.

40 (5) For the purposes of this section, the Oregon Human Development Corporation is eligible to
 41 receive federal community service funds and low-income energy assistance funds.

42 (6) The Housing and Community Services Department shall:

43 (a) Administer federal and state antipoverty programs.

44 (b) Apply for all available antipoverty funds on behalf of eligible entities as defined in this sec-
 45 tion.

1 (c) In conjunction with the Community Action Partnership of Oregon **and the Oregon Housing**
 2 **Stability Council**, develop a collaborative role in advocating for, and addressing the needs of, all
 3 low income Oregonians.

4 (d) Biennially produce and make available to the public a status report on efforts by it and state
 5 agencies to reduce the incidence of poverty in Oregon. This report shall contain figures regarding
 6 the numbers and types of persons living in poverty in Oregon. The report shall also describe the
 7 status of efforts by the department and the Department of Human Services to implement the state
 8 policy regarding homelessness described in ORS 458.528.

9 (e) On a regular basis provide information to the Community Action Partnership of Oregon on
 10 the activities and expenditures of the Housing and Community Services Department.

11 (f) As resources are available, provide resources for technical assistance, training and program
 12 assistance to eligible entities.

13 (g) As resources are available, provide resources pursuant to ORS 409.750 for the training and
 14 technical assistance needs of the Community Action Partnership of Oregon.

15 (h) Conduct a planning process to meet the needs of low income people in Oregon. That process
 16 shall fully integrate the Oregon Human Development Corporation into the antipoverty delivery sys-
 17 tem. The planning process shall include development of a plan for minimum level of services and
 18 funding for low income migrant and seasonal farmworkers from the antipoverty programs adminis-
 19 tered by the agency.

20 (i) Limit its administrative budget in an effort to maximize the availability of antipoverty federal
 21 and state funds for expenditures by local eligible entities.

23 458.510. (1) There is established an Energy Crisis Trust Fund, separate and distinct from the

39 **SECTION 22.** ORS 458.532 is amended to read:

40 458.532. (1) The Hunger Relief Task Force is established [*in the Housing and Community Services*
 41 *Department*]. The task force shall consist of not more than 28 members appointed as follows:

42 (a) The President of the Senate shall appoint one member from among members of the Senate.

43 (b) The Senate Minority Leader shall appoint one member from among members of the Senate.

10 States Department of Housing and Urban Development.

11 (8) "Veteran" has the meaning given that term in ORS 408.225.

12 **SECTION 25.** ORS 458.625 is amended to read:

13 458.625. (1) The Housing and Community Services Department may use the following to expand
14 this state's supply of housing for low and very low income families and individuals, including, but
15 not limited to, housing for persons over 65 years of age, persons with disabilities, farmworkers and
16 Native Americans:

17 (a) The amount of moneys credited to the Housing Development and Guarantee Account that the
18 department determines may be used for the purposes identified in this subsection and that is not
19 used for the purposes set forth in ORS 458.630; and

42 section (2)(a) and (b) of this section may not exceed four percent of the average unpaid balance of
43 the qualified loan during the tax year for which the credit is claimed.

44 (4) Any tax credit allowed under this section that is not used by the taxpayer in a particular
45 year may be carried forward and offset against the taxpayer's tax liability for the next succeeding

1 tax year. Any credit remaining unused in the next succeeding tax year may be carried forward and
 2 used in the second succeeding tax year, and likewise, any credit not used in that second succeeding
 3 tax year may be carried forward and used in the third succeeding tax year, and any credit not used
 4 in that third succeeding tax year may be carried forward and used in the fourth succeeding tax year,
 5 and any credit not used in that fourth succeeding tax year may be carried forward and used in the
 6 fifth succeeding tax year, but may not be carried forward for any tax year thereafter.

7 (5) To be eligible for the tax credit allowable under this section, a lending institution must make
 8 a qualified loan by either purchasing bonds, as defined in ORS 286A.001, issued on behalf of the
 9 Housing and Community Services Department, the proceeds of which are used to finance or refi-

24 (c) Subject to subsection (14) of this section, a qualified borrower who:

25 (A) Uses the loan proceeds to finance construction, development, acquisition or rehabilitation
 26 of housing consisting of a manufactured dwelling park; and

27 (B) Provides a written certification executed by the Housing and Community Services Depart-
 28 ment that the housing will continue to be operated as a manufactured dwelling park during the pe-
 29 riod for which the tax credit is allowed; or

30 (d) A qualified borrower who:

31 (A) Uses the loan proceeds to finance acquisition or rehabilitation of housing consisting of a
 32 preservation project; and

33 (B) Provides a written certification executed by the Housing and Community Services Depart-

40 (6) A loan made to refinance a loan that meets the criteria stated in subsection (5) of this sec-

43 (7) For a qualified loan to be eligible for the tax credit allowable under this section, the Housing
 44 and Community Services Department must execute a written certification for the qualified loan that:

 37 paragraph (b) of this subsection, the public purpose charge shall be equal to three percent of the
 38 total revenues collected by the electric company, Oregon Community Power or the electricity ser-
 39 vice supplier from its retail electricity consumers for electricity services, distribution, ancillary
 40 services, metering and billing, transition charges and other types of costs included in electric rates
 41 on July 23, 1999.

42 (b) For an aluminum plant that averages more than 100 average megawatts of electricity use
 43 per year, beginning on March 1, 2002, the electric company or Oregon Community Power whose
 44 territory abuts the greatest percentage of the site of the aluminum plant shall collect from the alu-
 45 minum company a public purpose charge equal to one percent of the total revenue from the sale of

1 electricity services to the aluminum plant from any source.

2 (3)(a) The Public Utility Commission shall establish rules implementing the provisions of this
3 section relating to electric companies and Oregon Community Power.

4 (b) Subject to paragraph (e) of this subsection, funds collected by an electric company or Oregon
5 Community Power through public purpose charges shall be allocated as follows:

6 (A) Sixty-three percent for new cost-effective conservation, new market transformation.

7 (B) Nineteen percent for the above-market costs of constructing and operating new renewable
8 energy resources with a nominal electric generating capacity, as defined in ORS 469.300, of 20
9 megawatts or less.

10 (C) Thirteen percent for new low-income weatherization.

11 (D) Five percent shall be transferred to the Housing and Community Services Department
12 Electricity Public Purpose Charge Fund established by ORS 456.587 (1) and used for the purpose of

14 (c) The costs of administering subsections (1) to (6) of this section for an electric company or
15 Oregon Community Power shall be paid out of the funds collected through public purpose charges.
16 The commission may require that an electric company or Oregon Community Power direct funds

18 sections (1) to (6) of this section in order to pay the costs of administering such responsibilities.

19 (d) The commission shall direct the manner in which public purpose charges are collected and

8 (iii) Energy conservation education programs.

9 (iv) Purchasing electricity from environmentally focused sources and investing in renewable

11 (f) The commission may not establish a different public purpose charge than the public purpose
 12 charge described in subsection (2) of this section.

13 (g) If the commission directs funds collected through public purpose charges to a nongovern-
 14 mental entity, the entity shall:

15 (A) Include on the entity's board of directors an ex officio member designated by the commis-
 16 sion, who shall also serve on the entity's nominating committee for filling board vacancies.

17 (B) Require the entity's officers and directors to provide an annual disclosure of economic in-
 18 terest to be filed with the commission on or prior to April 15 of each calendar year for public review
 19 in a form similar to the statement of economic interest required for public officials under ORS

42 (b) Oregon Community Power, for any period during which Oregon Community Power collects
 43 a public purpose charge under subsection (2) of this section:

44 (A) Shall have no other obligation to invest in conservation, new market transformation or new
 45 low-income weatherization or to provide a commercial energy conservation services program; and

1 (B) Is not subject to ORS 469.631 to 469.645 and 469.860 to 469.900.

2 (5)(a) A retail electricity consumer that uses more than one average megawatt of electricity at
3 any site in the prior year shall receive a credit against public purpose charges billed by an electric
4 company or Oregon Community Power for that site. The amount of the credit shall be equal to the
5 total amount of qualifying expenditures for new energy conservation, not to exceed 68 percent of the
6 annual public purpose charges, and the above-market costs of purchases of new renewable energy
7 resources incurred by the retail electricity consumer, not to exceed 19 percent of the annual public
8 purpose charges, less administration costs incurred under this subsection. The credit may not ex-
9 ceed, on an annual basis, the lesser of:

10 (A) The amount of the retail electricity consumer's qualifying expenditures; or

11 (B) The portion of the public purpose charge billed to the retail electricity consumer that is
12 dedicated to new energy conservation, new market transformation or the above-market costs of new
13 renewable energy resources.

14 (b) To obtain a credit under this subsection, a retail electricity consumer shall file with the
15 State Department of Energy a description of the proposed conservation project or new renewable
16 energy resource and a declaration that the retail electricity consumer plans to incur the qualifying
17 expenditure. The State Department of Energy shall issue a notice of precertification within 30 days
18 of receipt of the filing, if such filing is consistent with this subsection. The credit may be taken after
19 a retail electricity consumer provides a letter from a certified public accountant to the State De-
20 partment of Energy verifying that the precertified qualifying expenditure has been made.

21 (c) Credits earned by a retail electricity consumer as a result of qualifying expenditures that
22 are not used in one year may be carried forward for use in subsequent years.

23 (d)(A) A retail electricity consumer that uses more than one average megawatt of electricity at
24 any site in the prior year may request that the State Department of Energy hire an independent
25 auditor to assess the potential for conservation investments at the site. If the independent auditor
26 determines there is no available conservation measure at the site that would have a simple payback
27 of one to 10 years, the retail electricity consumer shall be relieved of 54 percent of its payment
28 obligation for public purpose charges related to the site. If the independent auditor determines that
29 there are potential conservation measures available at the site, the retail electricity consumer shall
30 be entitled to a credit against public purpose charges related to the site equal to 54 percent of the
31 public purpose charges less the estimated cost of available conservation measures.

32 (B) A retail electricity consumer shall be entitled each year to the credit described in this sub-
33 section unless a subsequent independent audit determines that new conservation investment oppor-
34 tunities are available. The State Department of Energy may require that a new independent audit
35 be performed on the site to determine whether new conservation measures are available, provided
36 that the independent audits shall occur no more than once every two years.

37 (C) The retail electricity consumer shall pay the cost of the independent audits described in this

6 2008 is \$15 million. In calendar year 2009 and subsequent calendar years, the commission may not
7 change the rates established for retail electricity consumers, but the total amount collected in a
8 calendar year for low-income electric bill payment assistance may vary based on electricity usage
9 by retail electricity consumers and changes in the number of retail electricity consumers in this
10 state. In no event shall a retail electricity consumer be required to pay more than \$500 per month
11 per site for low-income electric bill payment assistance.

12 (c) Funds collected by the low-income electric bill payment assistance charge shall be paid into
13 the Housing and Community Services Department Low-Income Electric Bill Payment Assistance
14 Fund established by ORS 456.587 (2). Moneys deposited in the fund under this paragraph shall be
15 used by the Housing and Community Services Department for the purpose of funding low-income
16 electric bill payment assistance. The department's cost of administering this subsection shall be paid
17 out of funds collected by the low-income electric bill payment assistance charge. Moneys deposited
18 in the fund under this paragraph shall be expended solely for low-income electric bill payment as-
19 sistance. Funds collected from an electric company or Oregon Community Power shall be expended
20 in the service area of the electric company or Oregon Community Power from which the funds are
21 collected.

22 (d)(A) The Housing and Community Services Department[, *in consultation with the advisory*
23 *committee on energy established by ORS 458.515,*] shall determine the manner in which funds col-
24 lected under this subsection will be allocated by the department to energy assistance program pro-
25 viders for the purpose of providing low-income bill payment and crisis assistance.

26 (B) The department shall investigate and may implement alternative delivery models [*specified*
27 *by the advisory committee on energy,*] in consultation with electric companies[,] to effectively reduce
28 service disconnections and related costs to retail electricity consumers and electric utilities.

29 (C) Priority assistance shall be directed to low-income electricity consumers who are in danger
30 of having their electricity service disconnected.

31 (D) The department shall maintain records and provide those records upon request to an electric
32 company, Oregon Community Power and the Citizens' Utility Board established under ORS chapter
33 774 on a quarterly basis. Records maintained must include the numbers of low-income electricity
34 consumers served, the average amounts paid and the type of assistance provided. Electric companies
35 and Oregon Community Power shall, if requested, provide the department with aggregate data re-
36 lating to consumers served on a quarterly basis to support program development.

37 (e) Interest on moneys deposited in the Housing and Community Services Department Low-
38 Income Electric Bill Payment Assistance Fund established by ORS 456.587 (2) may be used to pro-
39 vide bill payment and crisis assistance to electricity consumers whose primary source of heat is not
40 electricity.

41 (f) Notwithstanding ORS 757.310, the commission may allow an electric company or Oregon
42 Community Power to provide reduced rates or other payment or crisis assistance or low-income
43 program assistance to a low-income household eligible for assistance under the federal Low Income
44 Home Energy Assistance Act of 1981, as amended and in effect on July 23, 1999.

45 (8) For purposes of this section, "retail electricity consumers" includes any direct service in-

1 dustrial consumer that purchases electricity without purchasing distribution services from the elec-
2 tric utility.

3 (9) For purposes of this section, amounts collected by Oregon Community Power through public
4 purpose charges are not considered moneys received from electric utility operations.

8 **SECTION 51. (1) The amendments to ORS 456.567 by section 9 of this 2015 Act are in-**
9 **tended to change the name of the “State Housing Council” to the “Oregon Housing Stability**
10 **Council.”**

11 **(2) For the purpose of harmonizing and clarifying statutory law, the Legislative Counsel**
12 **may substitute for words designating the “State Housing Council,” wherever they occur in**
13 **statutory law, other words designating the “Oregon Housing Stability Council.”**
