

## HOUSE AMENDMENTS TO HOUSE BILL 2474

By COMMITTEE ON AGRICULTURE AND NATURAL RESOURCES

April 8

1 On page 1 of the printed bill, line 15, delete “In”.

2 Delete lines 16 and 17.

3 On page 2, after line 13, insert:

4 “(5) Subject to prior approval of the Oregon Department of Administrative Services and a report  
5 to the Emergency Board prior to adopting the fees, the fees established under subsection (2)(c) of  
6 this section may not exceed the cost of administering this section or rules adopted under this sec-  
7 tion, as authorized by the Legislative Assembly within the Oregon State Veterinary Medical Exam-  
8 ining Board’s budget, as the budget may be modified by the Emergency Board.”.

9 On page 3, after line 2, insert:

10 **“SECTION 6. Section 7 of this 2015 Act is added to and made a part of ORS chapter 686.**

11 **“SECTION 7. (1) For the purpose of adopting, amending or repealing rules under ORS**  
12 **686.010 (4) or section 3 of this 2015 Act, the Oregon State Veterinary Medical Examining**  
13 **Board shall convene a rules advisory committee as described in ORS 183.333.**

14 **“(2) The rules advisory committee convened pursuant to subsection (1) of this section**  
15 **must include, if available and willing to participate, the following 11 members:**

16 **“(a) An individual who represents rural veterinary facilities;**

17 **“(b) An individual who represents urban veterinary facilities;**

18 **“(c) An individual who represents mixed animal practice veterinary facilities;**

19 **“(d) An individual who represents large animal practice veterinary facilities;**

20 **“(e) An individual who represents a nonprofit animal shelter;**

21 **“(f) An individual who represents a nonprofit organization that provides care for indigent**  
22 **animals;**

23 **“(g) An individual who represents the College of Veterinary Medicine, Oregon State Uni-**  
24 **versity;**

25 **“(h) An individual who is a certified veterinary technician or who represents a veterinary**  
26 **technology program offered in this state and accredited by the American Veterinary Medical**  
27 **Association;**

28 **“(i) Two current members of the board; and**

29 **“(j) One former member of the board.**

30 **“(3) The rules advisory committee convened pursuant to subsection (1) of this section**  
31 **shall report to the board no later than October 31, 2015, on the committee’s recommen-**  
32 **dations with respect to adopting the rules described in subsection (1) of this section.**

33 **“SECTION 8. Section 7 of this 2015 Act is repealed on January 1, 2020.”.**

34 In line 3, delete “6” and insert “9”.
