SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Clarifies that governing boards of universities with governing board are included in list of entities that must continue to provide and improve upon effective articulation and transfer framework for students in Oregon's post-secondary sectors.]

Abolishes Oregon University System, office of Chancellor of the Oregon University System and State Board of Higher Education.

States that all public universities have institutional governing boards.

Abolishes Oregon University System Fund and subaccounts, Higher Education Donation Fund, Higher Education Academic Modernization Account and Oregon University System Capital Construction, Deferred Maintenance and Capital Repair Project Fund. Transfers moneys remaining in accounts or funds to Public University Fund. Limits use of transferred moneys to purposes specified for original funds or accounts.

Creates conforming amendments.

Declares emergency, effective on passage.

Be It Enacted by the People of the State of Oregon:

**DISSOLUTION OF OREGON UNIVERSITY SYSTEM AND
STATE BOARD OF HIGHER EDUCATION**

SECTION 1. ORS 352.054 is amended to read:

352.054. (1) A governing board is established for each of the following public universities:

(a) University of Oregon;

(b) Portland State University;

(c) Oregon State University[, *if the president of Oregon State University notifies the Governor that the university will become a university with a governing board in the manner set forth in section 168 or 168a, chapter 768, Oregon Laws 2013*];

(d) Eastern Oregon University[, *if Eastern Oregon University becomes a university with a governing board in the manner set forth in section 168a, chapter 768, Oregon Laws 2013*];

(e) Oregon Institute of Technology[, *if Oregon Institute of Technology becomes a university with a governing board in the manner set forth in section 168a, chapter 768, Oregon Laws 2013*];

(f) Southern Oregon University[, *if Southern Oregon University becomes a university with a governing board in the manner set forth in section 168a, chapter 768, Oregon Laws 2013*]; and

(g) Western Oregon University[, *if Western Oregon University becomes a university with a governing board in the manner set forth in section 168a, chapter 768, Oregon Laws 2013*].

(2)(a) The University of Oregon governing board shall be known as the Board of Trustees of the University of Oregon.

(b) The Portland State University governing board shall be known as the Board of Trustees of Portland State University.

(c) The Oregon State University governing board shall be known as the Board of Trustees of Oregon State University[, *if the president of Oregon State University notifies the Governor that the university will become a university with a governing board in the manner set forth in section 168 or 168a, chapter 768, Oregon Laws 2013*].

(d) The Eastern Oregon University governing board shall be known as the Board of Trustees of Eastern Oregon University[, *if Eastern Oregon University becomes a university with a governing*

1 *board in the manner set forth in section 168a, chapter 768, Oregon Laws 2013].*

2 (e) The Oregon Institute of Technology governing board shall be known as the Board of Trustees
3 of the Oregon Institute of Technology[, *if the Oregon Institute of Technology becomes a university*
4 *with a governing board in the manner set forth in section 168a, chapter 768, Oregon Laws 2013].*

5 (f) The Southern Oregon University governing board shall be known as the Board of Trustees
6 of Southern Oregon University[, *if Southern Oregon University becomes a university with a governing*
7 *board in the manner set forth in section 168a, chapter 768, Oregon Laws 2013].*

8 (g) The Western Oregon University governing board shall be known as the Board of Trustees
9 of Western Oregon University[, *if Western Oregon University becomes a university with a governing*
10 *board in the manner set forth in section 168a, chapter 768, Oregon Laws 2013].*

11 **SECTION 2. (1) The Oregon University System is abolished.**

12 **(2) The office of the Chancellor of the Oregon University System is abolished.**

13 **(3) The State Board of Higher Education is abolished.**

14 **(4)(a) The office of the Chancellor of the Oregon University System shall deliver to the**
15 **Higher Education Coordinating Commission or, as appropriate, the State Archives, all re-**
16 **ords and property within the jurisdiction or possession of the office of the chancellor that**
17 **relate to public universities listed in ORS 352.002.**

18 **(b) The Governor shall resolve any dispute between the office of the Chancellor of the**
19 **Oregon University System and the Higher Education Coordinating Commission or the State**
20 **Archives relating to transfers of records and property under this section, and the Governor's**
21 **decision is final.**

22 **SECTION 3. (1) Except as otherwise expressly provided in this section, all persons em-**
23 **ployed by a university with a governing board, as set forth in ORS 352.054, shall continue**
24 **their employment with the university and shall retain any seniority, contractual rights or**
25 **tenure granted prior to the effective date of this 2015 Act. Nothing in this section shall affect**
26 **any term or condition of any employment agreement or collective bargaining agreement in**
27 **effect on the effective date of this 2015 Act.**

28 **(2) All of the duties, functions, powers and lawfully incurred rights and obligations of the**
29 **State Board of Higher Education that pertain to a university with a governing board are**
30 **transferred to and vested in the governing board. The transfer shall include but not be lim-**
31 **ited to all applicable contractual rights and obligations and title to all applicable records,**
32 **property, supplies and materials, including equipment, books and papers. For the purpose of**
33 **succession to these rights and obligations, the governing board is considered to be a contin-**
34 **uation of the State Board of Higher Education and not a new authority, and the governing**
35 **board must exercise such rights and fulfill such obligations as if they had not been assigned**
36 **or transferred, except as otherwise provided by law.**

37 **(3) All unexpended moneys, including but not limited to General Fund appropriations,**
38 **gifts, bequests, other funds, assessments, liability and worker's compensation reserves and**
39 **premiums that are appropriated to, held, managed or invested by or on behalf of or otherwise**
40 **available to a university with a governing board, are appropriated and transferred to the**
41 **university.**

42 **(4) A university with a governing board shall conduct and complete any proceeding,**
43 **action, prosecution or other matter that the university commenced before the effective date**
44 **of this 2015 Act and that is pending on the effective date of this 2015 Act.**

45 **(5) The transfer of duties, functions and powers to a governing board or university with**

1 a governing board does not affect any action, suit or proceeding relating to the university,
2 except that the university shall be substituted for the State Board of Higher Education and
3 the State of Oregon in any such action, suit or proceeding.

4 (6) Any action, proceeding or other matter that was commenced by a state agency, a
5 state officer, the State Board of Higher Education or an officer or employee of the State
6 Board of Higher Education before the effective date of this 2015 Act and relates to the gov-
7 erning board or university with a governing board and is still pending on the effective date
8 of this 2015 Act shall be conducted and completed by the governing board or university.

9 (7) Nothing in this 2015 Act relieves any person, public entity or private entity of any
10 obligation with respect to a tax, fee, fine or other charge, interest, penalty, forfeiture, rule,
11 policy, document, record or proceeding.

12 (8) Notwithstanding any other provision of this section, the lawfully adopted rules and
13 policies of the State Board of Higher Education pertaining to a university with a governing
14 board that are in effect on the effective date of this 2015 Act continue in effect until lawfully
15 superseded or repealed by the standards or policies of the governing board or the university.
16 References in rules or policies of the State Board of Higher Education to the state board or
17 an officer or employee of the state board are considered to be references to the governing
18 board or an officer or employee of a university with a governing board.

37 **SECTION 5.** (1) The Oregon University System Fund established in ORS 351.506 is abol-
38 ished. Any moneys remaining in the Oregon University System Fund on the effective date
39 of this 2015 Act that are unexpended, unobligated and not subject to any conditions are
40 transferred to the Public University Fund established under section 7, chapter 83, Oregon
41 Laws 2014.

42 (2) The account in the Oregon University System Fund established in ORS 348.010 is
43 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
44 are unexpended, unobligated and not subject to any conditions are transferred to the Public
45 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the purpose

1 of granting loans under the terms established by the National Defense Education Act of 1958,
2 as amended, under the terms of the Health Professions Educational Assistance Act of 1963,
3 as amended, and under the terms of the Nurses Training Act of 1964, as amended.

4 (3) The account in the Oregon University System Fund established in ORS 351.210 is
5 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
6 are unexpended, unobligated and not subject to any conditions are transferred to the Public
7 University Fund established under section 7, chapter 83, Oregon Laws 2014.

8 (4) The account in the Oregon University System Fund established in ORS 351.250 is
9 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
10 are unexpended, unobligated and not subject to any conditions are transferred to the Public
11 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the purpose
12 of paying the agreed share, if any, to assignors, and for the advancement of research or for
13 the acquisition and development of intellectual property, or both.

14 (5) The account in the Oregon University System Fund established in ORS 351.545 is
15 abolished.

16 (6) The account in the Oregon University System Fund established in ORS 351.590 is
17 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
18 are unexpended, unobligated and not subject to any conditions are transferred to the Public
19 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the purpose
20 of disbursements for necessary expenses for supplies, services and equipment associated with
21 student activities including but not limited to recruiting, training and grant-in-aid to
22 intercollegiate athletes.

23 (7) The account in the Oregon University System Fund established in ORS 351.615 is
24 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
25 are unexpended, unobligated and not subject to any conditions are transferred to the Public
26 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the repair
27 and alteration of auxiliary enterprise buildings and replacement of equipment.

28 (8) The account in the Oregon University System Fund established in ORS 351.626 is
29 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
30 are unexpended, unobligated and not subject to any conditions are transferred to the Public
31 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the con-
32 struction, expansion and remodeling of public university facilities.

33 (9) The account in the Oregon University System Fund established in ORS 351.627 is
34 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
35 are unexpended, unobligated and not subject to any conditions are transferred to the Public
36 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the purpose
37 of capital construction.

38 (10) The account in the Oregon University System Fund established in ORS 351.638 is
39 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
40 are unexpended, unobligated and not subject to any conditions are transferred to the Public
41 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the purpose
42 of attracting new, outstanding faculty members to public universities.

43 (11) The account in the Oregon University System Fund established in ORS 351.875 is
44 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
45 are unexpended, unobligated and not subject to any conditions are transferred to the Public

1 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the purpose
2 of providing grants for research.

3 (12) The account in the Oregon University System Fund established in ORS 352.360 is
4 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
5 are unexpended, unobligated and not subject to any conditions are transferred to the Public
6 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the purpose
7 of defraying the costs of constructing bicycle racks and bicycle lanes and of traffic control,
8 enforcement of traffic and parking regulations and maintenance and operation of parking
9 facilities.

10 (13) The account in the Oregon University System Fund established in ORS 352.650 is
11 abolished. Any moneys remaining in the account on the effective date of this 2015 Act that
12 are unexpended, unobligated and not subject to any conditions are transferred to the Public
13 University Fund established under section 7, chapter 83, Oregon Laws 2014.

14 (14) The subaccount in the Oregon University System Fund established in section 2,
15 chapter 624, Oregon Laws 2011, is abolished. Any moneys remaining in the subaccount on the
16 effective date of this 2015 Act that are unexpended, unobligated and not subject to any con-
17 ditions are transferred to the Public University Fund established under section 7, chapter
18 83, Oregon Laws 2014, to allow necessary compliance under the Internal Revenue Code.

19 **SECTION 6.** (1) The Higher Education Donation Fund established under ORS 351.130 is
20 abolished. Any moneys remaining in the fund on the effective date of this 2015 Act that are
21 unexpended, unobligated and not subject to any conditions are transferred to the Public
22 University Fund established under section 7, chapter 83, Oregon Laws 2014, for the purpose
23 for which the moneys were donated.

24 (2) The Higher Education Academic Modernization Account established under ORS
25 351.628 is abolished. Any moneys remaining in the account on the effective date of this 2015
26 Act that are unexpended, unobligated and not subject to any conditions are transferred to
27 the Public University Fund established under section 7, chapter 83, Oregon Laws 2014, for
28 academic modernization, capital repair, deferred maintenance and making facilities
29 compliant with building and safety codes.

30 (3) The Oregon University System Capital Construction, Deferred Maintenance and Cap-
31 ital Repair Project Fund established in section 3, chapter 788, Oregon Laws 2005, is abolished.
32 Any moneys remaining in the fund on the effective date of this 2015 Act that are unexpended,
33 unobligated and not subject to any conditions are transferred to the Public University Fund
34 established under section 7, chapter 83, Oregon Laws 2014, for capital construction, deferred
35 maintenance and capital repair projects.

36 **SECTION 7.** Notwithstanding any other provision of law, the unexpended proceeds, and
37 any interest earnings thereon, of bonds issued by the State Treasurer for the benefit of a
38 university with a governing board that have not been transferred to a university prior to
39 July 1, 2015, and are not subject to transfer pursuant to a loan, grant or other agreement
40 entered into between the State of Oregon and a university with a governing board or the
41 Oregon University System, are transferred to and made available for expenditure by the
42 university with a governing board on whose behalf the bonds were issued before the effective
43 date of this 2015 Act.

44 **SECTION 8.** ORS 286A.035 is amended to read:

45 286A.035. (1) Each related agency shall report the plans of the related agency for the issuance

1 of bonds during the next biennium. The related agency shall submit the related agency's report to
2 the Governor by a date determined by the Governor and shall include in the report a description
3 of bonds that the related agency intends to retire or defease during the next biennium.

4 (2) On or before a date determined by the Governor, the State Treasurer shall advise the Gov-
5 ernor on the prudent maximum amount of bonds to be issued for each bond program. The State
6 Treasurer shall consider available economic and financial data in preparing advice to be given to
7 the Governor.

8 (3) As part of the Governor's budget report described in ORS 291.216, the Governor shall:

9 (a) Consider the prudent maximum amounts advised by the State Treasurer pursuant to sub-
10 section (2) of this section to determine the Governor's total recommended amount; and

11 (b) Recommend to the Legislative Assembly the total amount of bonds the State Treasurer may
12 issue for each bond program for a biennium.

13 (4) [Except as otherwise provided in ORS 351.476,] The Legislative Assembly shall determine the
14 amount of bonds the State Treasurer may issue for each state agency for a biennium. If the Legis-
15 lative Assembly fails to make the determination described in this subsection by the first day of the
16 biennium, the unused portion of the authorization the Legislative Assembly made for the preceding
17 biennium is deemed to carry forward for the current biennium at the amount authorized for the
18 preceding biennium until the earlier of:

19 (a) The date on which legislation authorizing the amount of bonds for the current biennium is
20 enacted; or

21 (b) The date on which the Legislative Assembly adjourns sine die.

22 (5) [Except as otherwise provided in ORS 351.476,] The amount of bonds that may be issued under
23 bond programs may be modified by the Governor. However, the Governor may not modify the
24 amount of bonds that may be issued under bond programs in a way that would cause the maximum
25 amount established by the Legislative Assembly for a category of bond programs to be exceeded if
26 the Legislative Assembly:

27 (a) Has categorized the bonds that may be issued under bond programs as general obligation,
28 direct revenue and pass-through revenue bonds; and

29 (b) Assigned a maximum amount to each category.

30 (6) This section applies to bonds:

31 (a) Unless the bonds are expressly exempted from the requirements of this section.

32 (b) Except refunding bonds.

33 **SECTION 9.** ORS 286A.700 is amended to read:

34 286A.700. (1) As used in this section:

35 (a) "Oregon Baccalaureate Bonds" means bonds of the State of Oregon issued by the State
36 Treasurer at the request of the [Oregon University System] **Higher Education Coordinating Com-**
37 **mission** that are designated as baccalaureate bonds.

38 (b) "Post-secondary education" means training and instruction provided by fully accredited
39 public universities or private institutions of higher learning, community colleges and post-high-
40 school career schools.

41 (2) The Legislative Assembly encourages citizens of the State of Oregon to avail themselves of
42 post-secondary education opportunities.

43 (3) The Legislative Assembly finds:

44 (a) For the benefit of its citizens, the state supports a system of common schools, public uni-
45 versities and community colleges.

1 (b) A post-secondary education advances a citizen's ability to pursue life, liberty and happiness
2 through a wide range of employment opportunities.

3 (c) A well-educated citizenry contributes to the economic well-being of the state and nation.

4 (d) A well-trained and skilled citizenry enhances economic development of the state.

5 (e) While students have just begun their education upon completion of a formal education, a
6 lifetime pursuit of learning contributes to a well-informed citizenry and to Oregon's cherished qual-
7 ity of life.

8 (f) Citizens educated in Oregon are more likely to pursue careers in Oregon.

9 (g) It is in the interest of this state to encourage its citizens to plan and save for a post-
10 secondary education.

11 (h) An Oregon Baccalaureate Bond program that provides citizens an opportunity to save for a
12 post-secondary education for their children, themselves or any citizen is in the social and economic
13 interest of the State of Oregon.

14 (i) A systematic way to save for post-secondary education can assist all of Oregon's higher ed-
15 ucation, community college and career schools to better project enrollments, thereby permitting the
16 prudent allocation of scarce resources.

17 (4) At the request of the Higher Education Coordinating Commission, the State Treasurer may:

20 (e) An elected city official from a coastal city bordering the territorial sea to be appointed by
21 the Governor with advice from an Oregon coastal zone management association;

22 (f) A representative of each of the following ocean interests, to be appointed by the Governor,
23 and subject to confirmation by the Senate pursuant to section 4, Article III, Oregon Constitution:

24 (A) Commercial ocean fisheries of the North Coast from Newport north;

25 (B) Commercial ocean fisheries of the South Coast south of Newport;

26 (C) Charter, sport or recreation ocean fisheries of the North Coast from Newport north;

27 (D) Charter, sport or recreation ocean fisheries of the South Coast south of Newport;

28 (E) Ports marine navigation or transportation;

29 (F) Coastal nonfishing recreation interests of surfing, diving, kayaking or windsurfing;

35 ment that strengthen minority and women participation in the economic life of this state.

36 **SECTION 61.** ORS 200.055 is amended to read:

37 200.055. (1) Any disadvantaged, minority, women or emerging small business enterprise is enti-
38 tled to be certified as such upon application to the Oregon Business Development Department. If the
39 application is approved by the department, the department shall certify the applicant as a disad-
40 vantaged, minority, women or emerging small business enterprise. The enterprise shall be considered
41 so certified by any public contracting agency.

12 (1) "Appropriate bargaining unit" means the unit designated by the Employment Relations Board
13 or voluntarily recognized by the public employer to be appropriate for collective bargaining. How-
14 ever, an appropriate bargaining unit may not include both academically licensed and unlicensed or
15 nonacademically licensed school employees. Academically licensed units may include but are not
16 limited to teachers, nurses, counselors, therapists, psychologists, child development specialists and
17 similar positions. This limitation does not apply to any bargaining unit certified or recognized prior
18 to June 6, 1995, or to any school district with fewer than 50 employees.

19 (2) "Board" means the Employment Relations Board.

20 (3) "Certification" means official recognition by the board that a labor organization is the ex-
21 clusive representative for all of the employees in the appropriate bargaining unit.

22 (4) "Collective bargaining" means the performance of the mutual obligation of a public employer
23 and the representative of its employees to meet at reasonable times and confer in good faith with
24 respect to employment relations for the purpose of negotiations concerning mandatory subjects of

26 concerning the interpretation or application of a collective bargaining agreement, and to execute
27 written contracts incorporating agreements that have been reached on behalf of the public employer
28 and the employees in the bargaining unit covered by such negotiations. The obligation to meet and
29 negotiate does not compel either party to agree to a proposal or require the making of a concession.
30 This subsection may not be construed to prohibit a public employer and a certified or recognized
31 representative of its employees from discussing or executing written agreements regarding matters
32 other than mandatory subjects of bargaining that are not prohibited by law as long as there is mu-
33 tual agreement of the parties to discuss these matters, which are permissive subjects of bargaining.

34 (5) "Compulsory arbitration" means the procedure whereby parties involved in a labor dispute
35 are required by law to submit their differences to a third party for a final and binding decision.

36 (6) "Confidential employee" means one who assists and acts in a confidential capacity to a per-
37 son who formulates, determines and effectuates management policies in the area of collective bar-
38 gaining.

39 (7)(a) "Employment relations" includes, but is not limited to, matters concerning direct or indi-
40 rect monetary benefits, hours, vacations, sick leave, grievance procedures and other conditions of

42 (b) "Employment relations" does not include subjects determined to be permissive, nonmanda-
43 tory subjects of bargaining by the Employment Relations Board prior to June 6, 1995.

2 (d) "Employment relations" does not include subjects that have an insubstantial or de minimis

4 (e) For school district bargaining, "employment relations" excludes class size, the school or ed-
5 ucational calendar, standards of performance or criteria for evaluation of teachers, the school cur-
6 riculum, reasonable dress, grooming and at-work personal conduct requirements respecting smoking,
7 gum chewing and similar matters of personal conduct, the standards and procedures for student
8 discipline, the time between student classes, the selection, agendas and decisions of 21st Century
9 Schools Councils established under ORS 329.704, requirements for expressing milk under ORS
10 653.077, and any other subject proposed that is permissive under paragraphs (b), (c) and (d) of this
11 subsection.

12 (f) For employee bargaining involving employees covered by ORS 243.736, "employment
13 relations" includes safety issues that have an impact on the on-the-job safety of the employees or
14 staffing levels that have a significant impact on the on-the-job safety of the employees.

15 (g) For all other employee bargaining except school district bargaining and except as provided
16 in paragraph (f) of this subsection, "employment relations" excludes staffing levels and safety issues

28 or more impartial individuals who review the positions of the parties, resolve factual differences and
29 make recommendations for settlement of the dispute.

31 nized or certified bargaining representative of public employees whereby employees who are not
32 members of the employee organization are required to make an in-lieu-of-dues payment to an em-

10 (16) "Managerial employee" means an employee of the State of Oregon or [*the Oregon University*
11 *System*] **a public university listed in ORS 352.002** who possesses authority to formulate and carry
12 out management decisions or who represents management's interest by taking or effectively recom-
13 mending discretionary actions that control or implement employer policy, and who has discretion in
14 the performance of these management responsibilities beyond the routine discharge of duties. A
15 "managerial employee" need not act in a supervisory capacity in relation to other employees.
16 Notwithstanding this subsection, "managerial employee" does not include faculty members at a

18 (17) "Mediation" means assistance by an impartial third party in reconciling a labor dispute
19 between the public employer and the exclusive representative regarding employment relations.

20 (18) "Payment-in-lieu-of-dues" means an assessment to defray the cost for services by the exclu-
21 sive representative in negotiations and contract administration of all persons in an appropriate
22 bargaining unit who are not members of the organization serving as exclusive representative of the
23 employees. The payment must be equivalent to regular union dues and assessments, if any, or must
24 be an amount agreed upon by the public employer and the exclusive representative of the employees.

25 (19) "Public employee" means an employee of a public employer but does not include elected
26 officials, persons appointed to serve on boards or commissions, incarcerated persons working under
27 section 41, Article I of the Oregon Constitution, or persons who are confidential employees, super-
28 visory employees or managerial employees.

29 (20) "Public employer" means the State of Oregon, and the following political subdivisions:
30 Cities, counties, community colleges, school districts, special districts, mass transit districts, metro-

29 or interests in or obligations of any other entity. Separate funds may be established for such in-
30 vestments. The State of Oregon shall have no proprietary or other interest in such investments or
31 such funds.

32 (20) Make available, by lease or otherwise, or control access to any health care facilities or
33 services or other of its properties and assets to such persons, firms, partnerships, associations or
34 corporations and on such terms as considered appropriate, charge and collect rent or other fees or
35 charges therefor and terminate or deny any such access or any such lease or other agreement for
36 such reasons as considered appropriate and as may be consistent with its obligations under any such
37 lease or other agreement.

38 (21) Contract for the operation of any department, section, equipment or holdings of the uni-
39 versity and enter into any agreements with any person, firm or corporation for the management by
40 said person, firm or corporation on behalf of the university of any of its properties or for the more
41 efficient or economical performance of clerical, accounting, administrative and other functions re-
42 lating to its health care facilities.

43 (22) Select and appoint faculty as medical and dental staff members and others licensed to
44 practice the healing arts, delineate and define the privileges granted each such individual, adopt and
45 direct a plan for faculty clinical income and set the terms and conditions of that plan (including

2 (A) Represents or attempts to represent a student athlete for the purpose of marketing the stu-
3 dent athlete's athletic ability or reputation for financial gain; or

4 (B) Seeks to obtain a type of financial gain or benefit from securing a prospective student
5 athlete's enrollment at an educational institution or from a student athlete's potential earnings as
6 a professional athlete.

7 (b) "Athlete agent" does not include a spouse, parent, sibling, grandparent or legal guardian of
8 the student athlete or an individual acting solely on behalf of a professional sports team or profes-
9 sional sports organization.

10 (3) "Athletic director" means:

11 (a) An individual responsible for administering the overall athletic program of an educational
12 institution or, if an educational institution has separately administered athletic programs for male
13 students and female students, the athletic program for males or the athletic program for females,
14 as appropriate;

15 (b) If the educational institution is a public or private elementary school or secondary school
16 and the educational institution does not have a person responsible for administering the overall
17 athletic program:

18 (A) The principal of the educational institution; or

19 (B) If the educational institution does not have a principal, the person designated by the gov-
20 erning body of the school district, education service district or charter school to manage the edu-
21 cational institution; or

22 (c) If the educational institution is a community college or university and the educational in-
23 stitution does not have a person responsible for administering the overall athletic program:

7 United States.

8 (13) "Student athlete" means an individual attending an educational institution within this state

20 (b) Governing bodies of education entities identified in subsection (1)(b)(A) to (C) of this section

21 shall enter into achievement compacts as part of the budgeting process under ORS 294.305 to 294.565

22 and shall submit achievement compacts to the board prior to:

23 (A) October 15 of each year for governing bodies of education entities identified in subsection

24 (1)(b)(A) or (B) of this section; or

25 (B) July 1 of each year for governing bodies of education entities identified in subsection

26 (1)(b)(C) of this section.

27 (c) The board shall specify a process for adoption and a timeline for submission of achievement

28 compacts for education entities identified in subsection (1)(b)(D) *[to (F)]* **and (E)** of this section.

29 (d) The board shall provide to each school district a number quantifying the district’s estimated

30 level of funding for the next fiscal year compared to the determination of funding needed to ensure

31 that the state’s system of kindergarten through grade 12 public education meets the quality goals

32 specified under ORS 327.506.

33 (3)(a) The board shall establish the terms for achievement compacts.

34 (b) The terms of an achievement compact may include:

35 (A) A description of goals for outcomes that are consistent with the educational goals identified

36 in ORS 329.015, the findings described in ORS 351.003 and the mission of education provided in ORS

37 351.009.

38 (B) A description of the outcomes and measures of progress that will allow each education entity

39 to quantify:

40 (i) Completion rates for:

41 (I) Critical stages of learning and programs of study;

42 (II) The attainment of diplomas, certificates and degrees; and

43 (III) Achieving the high school and post-secondary education goals established in ORS 351.009

44 and a projection of the progress needed to achieve those goals by 2025;

45 (ii) Validations of the quality of knowledge and skills acquired by students of the education en-

1 tity; and

2 (iii) The relevance of the knowledge and skills acquired by the students of the education entity
3 and the means by which those skills and knowledge will contribute to the workforce, the economy
4 and society as described in state policy.

5 (C) Other information suggested by the governing body of an education entity and approved by
6 the board.

7 (c) Notwithstanding the terms described in paragraph (b) of this subsection, for an achievement
8 compact entered into by an education entity identified in subsection [(1)(b)(F)] (1)(b)(E) of this sec-
9 tion, the terms of the achievement compact shall be limited to the enrollment of, and attainment of
10 degrees by, Oregon residents in programs for which the state provides funding.

11 (4)(a) The governing body of each education entity shall identify a target number and percentage
12 of students for achievement of the outcomes, measures of progress and goals specified in the
13 achievement compact for the fiscal year.

14 (b) The governing body of each education entity shall provide a target number and percentage
15 of students for the aggregate of all disadvantaged subgroups, as defined by federal law or specified
16 by rules adopted by the board. The target number and percentage of students must reflect the edu-
17 cation entity's goals of improving education outcomes for disadvantaged student groups and closing
18 any student achievement gaps between disadvantaged student groups and other student groups.

19 (5) As part of the process of entering into an achievement compact, the governing body of an
20 education entity shall ensure that open communications are provided to parents, students, teachers
21 or faculty, employees, exclusive bargaining representatives and community representatives, as ap-
22 propriate for the type of education entity represented by the governing body of the education entity.
23 The purposes of the open communications are to explain and discuss the outcomes, measures of
24 progress, goals and targets specified in the achievement compact for the fiscal year. The open
25 communications must be provided during each education entity's public budget process.

26 (6) The board shall specify the format of the achievement compacts and provide model achieve-
27 ment compacts to the governing body of each education entity.

28 (7) The board may adopt a timeline and method for governing bodies of education entities to
29 provide the board with a report at the end of a fiscal year that describes the achievements made
30 by the education entities during the fiscal year. The report:

31 (a) Must include disaggregated data for each disadvantaged student group specified by the
32 board; and

33 (b) May state achievements in numbers and percentages and in relation to the outcomes, meas-
34 ures of progress, goals and targets specified in the achievement compact for the fiscal year.

35 **SECTION 218.** ORS 348.900 is amended to read:

36 348.900. (1) The Employment Department, in consultation with health care industry employers,
37 shall perform a statewide and regional needs assessment for health care occupations to identify
38 emerging occupations and occupations for which there is high demand or a shortage of workers. The
39 assessment shall be performed as necessary on a periodic basis, as determined by the department,
40 in consultation with industry employers. To perform the needs assessment, the department may
41 consider any reliable data sources available to the department.

42 (2) Based on the needs assessment, the Higher Education Coordinating Commission shall inform
43 the community colleges, public universities listed in ORS 352.002, Oregon Health and Science Uni-
44 versity and health care industry employers of the identified statewide needs and invite the devel-
45 opment of health care education programs that are responsive to those needs.

1 (3) When approving health care education programs, the commission, the governing board of a
 2 public university [*with a governing board listed in ORS 352.054*] **listed in ORS 352.002** and the
 3 Oregon Health and Science University Board of Directors shall use the statewide needs assessment
 4 to evaluate whether a program fulfills statewide needs. If the commission or the board determines
 5 there is a statewide need, the commission or the board shall facilitate the:

6 (a) Coordination of new health care education programs and existing health care education
 7 programs that are similar to the new health care education programs to address the statewide need;
 8 and

9 (b) Alignment of health care education programs relating to statewide access, student
 10 transferability between programs, course articulation and common student learning outcomes for
 11 health care education programs.

12 (4) In the development and approval of health care education programs, community colleges,
 13 public universities, Oregon Health and Science University, the commission, the governing board of
 14 a public university [*with a governing board listed in ORS 352.054*] **listed in ORS 352.002** and the
 15 Oregon Health and Science University Board of Directors shall consider issues related to statewide
 16 access, student transferability between programs, course articulation and common student learning
 17 outcomes for health care education programs. The community colleges, public universities, Oregon
 18 Health and Science University and commission shall continue to provide and improve upon an ef-
 19 fective articulation and transfer framework for students in Oregon's post-secondary sectors.

20 **SECTION 219.** Section 44, chapter 1, Oregon Laws 2015, is amended to read:

21 **Sec. 44.** (1) There is established the Oregon Marijuana Account, separate and distinct from the
 22 General Fund.

23 (2) At the end of each month, the Oregon Liquor Control Commission shall certify the amount
 24 of moneys available for distribution in the Oregon Marijuana Account and, after withholding such
 25 moneys as it may deem necessary to carry out its obligations under sections 3 to 70, **chapter 1,**

 34 **Oregon Laws 2015, 10** [*this Act, ten*] percent [*shall*] **must** be transferred to the cities of [*the*] **this**
 35 state in the following shares:

36 (A) For all distributions made from the Oregon Marijuana Account before July 1, 2017, in such
 37 shares as the population of each city bears to the population of the cities of [*the*] **this** state, as de-
 38 termined by [*the State Board of Higher Education*] **Portland State University** last preceding such
 39 apportionment, under ORS 190.510 to 190.610; and

40 (B) For all distributions made from the Oregon Marijuana Account on or after July 1, 2017:

41 (i) Fifty percent of [*such ten*] **the 10** percent [*shall*] **must** be transferred in such shares as the
 42 number of licenses issued by the commission under sections 19 to 21, **chapter 1, Oregon Laws 2015,**
 43 [*of this Act*] during the calendar year preceding the date of the distribution for premises located in
 44 each city bears to the number of such licenses issued by the commission during such calendar year
 45 for all premises in [*the*] **this** state; and

1 (ii) Fifty percent of [*such ten*] **the 10** percent [*shall*] **must** be transferred in such shares as the
 2 number of licenses issued by the commission under section 22, **chapter 1, Oregon Laws 2015**, [*of*
 3 *this Act*] during the calendar year preceding the date of the distribution for premises located in each
 4 city bears to the number of such licenses issued by the commission during such calendar year for
 5 all premises in [*the*] **this** state;

6 (e) To assist local law enforcement in performing its duties under **sections 3 to 70, chapter 1,**
 7 **Oregon Laws 2015, 10** [*this Act, ten*] percent [*shall*] **must** be transferred to counties in the following
 8 shares:

9 (A) For all distributions made from the Oregon Marijuana Account before July 1, 2017, in such
 10 shares as their respective populations bear to the total population of [*the*] **this** state, as estimated
 11 from time to time by [*the State Board of Higher Education*] **Portland State University**; and

12 (B) For all distributions made from the Oregon Marijuana Account on or after July 1, 2017:

13 (i) Fifty percent of [*such ten*] **the 10** percent [*shall*] **must** be transferred in such shares as the
 14 number of licenses issued by the commission under sections 19 to 21, **chapter 1, Oregon Laws 2015**,
 15 [*of this Act*] during the calendar year preceding the date of the distribution for premises located in
 16 each county bears to the number of such licenses issued by the commission during such calendar
 17 year for all premises in [*the*] **this** state; and

18 (ii) Fifty percent of [*such ten*] **the 10** percent [*shall*] **must** be transferred in such shares as the
 19 number of licenses issued by the commission under section 22, **chapter 1, Oregon Laws 2015**, [*of*
 20 *this Act*] during the calendar year preceding the date of the distribution for premises located in each
 21 county bears to the number of such licenses issued by the commission during such calendar year for
 22 all premises in [*the*] **this** state; and

23 (f) Five percent [*shall*] **must** be transferred to the Oregon Health Authority to be used for the
 24 establishment, operation[,] and maintenance of alcohol and drug abuse prevention, early intervention
 25 and treatment services.

26 (3) It is the intent of this section that the moneys distributed from the Oregon Marijuana Ac-
 27 count to the distributees in subsection (2) of this section are in addition to any other available
 28 moneys to such distributees and do not supplant moneys available from any other source.

29 **SECTION 220. For purposes of Article XI-M, section 1, of the Oregon Constitution, a**
 30 **building owned by the State Board of Higher Education includes a building owned by:**

31 (1) **The State Board of Higher Education on the date before August 14, 2013, that, as a**
 32 **result of sections 2 and 3 of this 2015 Act and the amendments to ORS 352.054 by section 1**
 33 **of this 2015 Act, is on the effective date of this 2015 Act owned by another agency or public**
 34 **corporation of this state and used for purposes within the authority of the board on the date**
 35 **before the effective date of this 2015 Act.**

36 (2) **An agency or public corporation of this state on or after the effective date of this 2015**
 37 **Act and used for purposes within the authority of the board before the effective date of this**
 38 **2015 Act.**

39 **SECTION 221. For purposes of Article XV, section 8, of the Oregon Constitution, a person**
 40 **employed by the State Board of Higher Education includes a person who:**

41 (1) **Was employed by the board on the date before August 14, 2013, and who, as a result**
 42 **of any provision of this 2015 Act, is employed by any board or commission established by law**
 43 **to supervise and coordinate the activities of Oregon's institutions of post-secondary educa-**
 44 **tion, a public university listed in ORS 352,002, a public agency or a public corporation of this**
 45 **state in a capacity that was within the authority of the board on the date before the effective**

1 **date of this 2015 Act.**

2 (2) **On or after the effective date of this 2015 Act, is employed by any board or commis-**
3 **sion established by law to supervise and coordinate the activities of Oregon's institutions of**
4 **post-secondary education, a public university listed in ORS 352,002, a public agency or a**
5 **public corporation of this state in a capacity that was within the authority of the board be-**
6 **fore August 14, 2013.**

10 **SECTION 222.** Section 11, chapter 519, Oregon Laws 2011, as amended by section 2, chapter
11 37, Oregon Laws 2012, is amended to read:

12 **Sec. 11.** (1) On March 15, 2016, the Chief Education Officer of the Oregon Education Investment
13 Board shall deliver to the [*Chancellor of the Oregon University System*] **Higher Education Coordi-**
14 **nating Commission** all records and property within the jurisdiction of the Chief Education Officer
15 that relate to the duties, functions and powers of the Oregon Education Investment Board. The
16 [*Chancellor of the Oregon University System*] **Higher Education Coordinating Commission** shall
17 take possession of the records and property.

18 (2) On March 15, 2016, the Chief Education Officer shall deliver to the Early Learning System
19 Director all records and property within the jurisdiction of the Chief Education Officer that relate
20 to the duties, functions and powers of the Early Learning Council. The Early Learning System Di-

34 (C) One member who shall be a current or former business leader with fast-growth business
35 experience.

36 (b) The Speaker of the House of Representatives shall appoint:

37 (A) Two members from among members of the House of Representatives who shall be from dif-
38 ferent political parties.

39 (B) Two members representing municipal or regional economic development organizations.

40 (C) One member who shall be a current or former business leader with fast-growth business
41 experience.

42 (D) One member representing a nonprofit business development organization.

43 (c) The [*Chancellor of the Oregon University System*] **executive director of the Higher Educa-**
44 **tion Coordinating Commission** shall appoint:

45 (A) One member representing [*the system*] **public universities listed in ORS 352.002** who shall

1 be a current or former business leader.

2 **(B) One member representing the community colleges in this state.**

3 (d) The Director of the Oregon Business Development Department shall appoint:

4 (A) One member representing the department.

5 (B) One member representing a small business development center who shall be a current or
6 former business leader.

7 *[(e) The Department of Community Colleges and Workforce Development shall appoint one member*
8 *representing the community colleges in this state.]*

9 *[(f)]* (e) The Governor shall appoint:

10 (A) Two members who are currently principals of Oregon-based companies, or have been prin-
11 cipals of Oregon-based companies within the past five years; and

12 (B) Two members who represent trade associations.

13 *[(g)]* (f) At least two of the nonlegislative members appointed should have knowledge of ad-
14 vanced market research tools and their application.

15 (2) The council shall:

16 (a) Identify and assess Oregon's continuum of business development services with particular at-
17 tention to the needs of stage two, high-growth businesses, advanced market research, including but
18 not limited to connectivity among business service providers, and infrastructure to support
19 entrepreneurship and growth company capacity building.

20 (b) Collaborate with state and local governments and their departments, community colleges,
21 institutions of higher education and business and economic development organizations to identify
22 areas for program modification, enhancement, coordination and creation to deliver a more robust
23 continuum of services for stage two, high-growth businesses consistent with the principles of eco-
24 nomic gardening.

25 (c) Make recommendations to the Seventy-seventh Legislative Assembly for program modifica-
26 tion, enhancement, coordination and creation to deliver a more robust continuum of services for
27 stage two, high-growth businesses consistent with the principles of economic gardening.

28 (d) Recommend program areas in which *[Oregon University System]* **public university** graduate
29 programs and community colleges may choose to participate in order to assist in providing a more
30 robust continuum of services for stage two, high-growth businesses consistent with the principles
31 of economic gardening, including but not limited to courses of study and internships.

32 (e) Make recommendations for criteria for stage two, high-growth businesses as the criteria re-
33 late to recommended strategies for fast-growth stage-two business development.

34 (f) Make recommendations for key metrics and outcomes to be measured should the state create
35 an economic gardening program.

36 (g) Make recommendations for how an economic gardening program may fit within efforts under
37 way to support the development of the state's minority, women and emerging small business enter-
38 prises.

39 (h) Explore opportunities for connecting market research and economic gardening services to
40 capital access programs, including but not limited to the Building Opportunities for Oregon Small
41 Business Today (BOOST) Account.

42 (i) Explore opportunities for facilitating the access of stage two, high-growth businesses to
43 international markets.

44 (j) Advise the Oregon Business Development Department or other administering entity on a pilot
45 program providing economic gardening services, if such a pilot program is authorized.

1 (3) A majority of the members of the council constitutes a quorum for the transaction of busi-
2 ness.

3 (4) Official action by the council requires the approval of a majority of the members of the
4 council.

5 (5) The council shall elect one of its members to serve as chairperson.

6 (6) If there is a vacancy for any cause, the appointing authority shall make an appointment to
7 become immediately effective.

8 (7)(a) The council shall meet at least once every three months, at times and places specified by
9 the call of the chairperson or of a majority of the members of the council.

10 (b) The Grow Oregon Council shall cease meeting once the council:

11 (A) Completes its evaluation of the implementation of the pilot program providing economic
12 gardening services, if such a program is authorized; or

13 (B) Recommends against implementation of a pilot program.

14 (8) The council may adopt rules necessary for the operation of the council.

15 (9) Notwithstanding ORS 171.072, members of the council who are members of the Legislative
16 Assembly are not entitled to mileage expenses or a per diem and serve as volunteers on the council.
17 Other members of the council are not entitled to compensation or reimbursement for expenses and
18 serve as volunteers on the council.

19 (10) All agencies of state government, as defined in ORS 174.111, are directed to assist the
20 council in the performance of its duties and, to the extent permitted by laws relating to
21 confidentiality, to furnish such information and advice as the members of the council consider nec-
22 essary to perform their duties.

23 **SECTION 224. The unit captions used in this 2015 Act are provided only for the conven-**
24 **ience of the reader and do not become part of the statutory law of this state or express any**
25 **legislative intent in the enactment of this 2015 Act.**

26 **SECTION 225. Sections 2, 3, 5 to 7, 220 and 221 of this 2015 Act, the amendments to**
27 **statutes and session laws by sections 1, 8 to 161, 164 to 219, 222 and 223 of this 2015 Act and**
28 **the repeal of statutes and session laws by section 4 of this 2015 Act become operative on July**
29 **1, 2015.**

30 **SECTION 226. This 2015 Act being necessary for the immediate preservation of the public**
31 **peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect**
32 **on its passage.**
