27 (a) Construction.--This chapter shall not be construed to  
28 confer any legal right upon an individual to:

29 (1) Participate in an earned vocational training or  
30 education credit program.

31 (2) Continue participation in an earned vocational  
32 training or education credit program.

33 (3) File a cause of action in any court to challenge the  
34 department's determination regarding participation or  
35 completion of any earned vocational training or education  
36 credit program.
