RELATING TO CRIMINAL OFFENSES - WEAPONS

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 11-47-9 of the General Laws in Chapter 11-47 entitled "Weapons"
2 is hereby amended to read as follows:
3 **11-47-9. Persons exempt from restrictions.** -- (a) The provisions of section 11-47-8
4 shall not apply to sheriffs, deputy sheriffs, the superintendent and members of the state police,
5 members of the Rhode Island airport police department, members of the Rhode Island state
6 marshals, Rhode Island state fire marshal, chief deputy state fire marshals, deputy state fire
7 marshals assigned to the bomb squad, and those assigned to the investigation unit, [Providence fire](#)
8 [department arson investigators; provided that the investigator receiving the permit is a graduate of](#)
9 [a police-training academy](#), correctional officers, within the department of corrections, members of
10 the city or town police force, capitol police investigators of the department of attorney general
11 appointed pursuant to section 42-9-8.1, the witness protection coordinator for the witness
12 protection review board as set forth in chapter 30 of title 12 and subject to the minimum
13 qualifications of section 42-9-8.1, and automobile theft investigators of the Rhode Island state
14 police pursuant to section 31-50-1, railroad police while traveling to and from official
15 assignments or while on assignments, conservation officers, or other duly appointed law
16 enforcement officers, nor to members of the Army, Navy, Air Force, and Marine Corps of the
17 United States, the National Guard, or organized reserves, when on duty, nor to members of
18 organizations by law authorized to purchase or receive firearms from the United States or this
19 state, provided these members are at or going to or from their places of assembly or target

1 practice, nor to officers or employees of the United States authorized by law to carry a concealed
2 firearm, nor to any civilian guard or criminal investigator carrying sidearms or a concealed
3 firearm in the performance of his or her official duties under the authority of the commanding
4 officer of the military establishment in the state of Rhode Island where he or she is employed by
5 the United States, nor to any civilian guard carrying sidearms or a concealed firearm in the
6 performance of his or her official duties under the authority of the adjutant general where he or
7 she is employed guarding a national guard facility, provided, that the commanding officer of the
8 military establishment shall have on file with the attorney general of this state a list of the names
9 and addresses of all civilian guards and criminal investigators so authorized, nor to duly
10 authorized military organizations when on duty, nor to members when at or going to or from their
11 customary places of assembly, nor to any individual employed in the capacity of warden,
12 associate warden, major, captain, lieutenant, sergeant, correctional officer or investigator at any
13 project owned or operated by a municipal detention facility corporation, including the Donald W.
14 Wyatt Detention Facility, nor to the regular and/or ordinary transportation of pistols or revolvers
15 as merchandise, nor to any person while transporting a pistol, or revolvers, unloaded from the
16 place of purchase to their residence, or place of business, from their residence to their place of
17 business or from their place of business to their residence, or to a Federal Firearms licensee for
18 the purpose of sale, to or from a bona fide gunsmith, or firearms repair facility, to any police
19 station or other location designated as a site of a bona fide "gun buy-back" program but only if
20 said pistol or revolver is unloaded and any ammunition for said pistol or revolver is not readily or
21 directly accessible from the passenger compartment of such vehicle while transporting same and
22 further provided that in the case of a vehicle without a compartment separate from the passenger
23 compartment the firearm or the ammunition shall be stored in a locked container.

24 (b) Persons exempted by the provisions of this section from the provisions of section 11-
25 47-8 shall have the right to carry concealed firearms everywhere within this state; provided, that
26 this shall not be construed as giving the right to carry concealed firearms to a person transporting
27 firearms as merchandise or as household or business goods.

28 SECTION 2. This act shall take effect upon passage.
