A BILL

To modernize the Undetectable Firearms Act of 1988.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Undetectable Firearms
5 Modernization Act”.

6 **SEC. 2. MODERNIZATION OF THE PROHIBITION ON**
7 **UNDETECTABLE FIREARMS.**

8 Section 922(p) of title 18, United States Code, is
9 amended—

10 (1) in paragraph (1)—

1 (A) in subparagraph (A), by striking
2 “grips, stocks, and magazines” and inserting
3 “all parts other than major components”; and

4 (B) in subparagraph (B), by striking
5 “when subjected to inspection by the types of x-
6 ray machines commonly used at airports, does
7 not generate” and inserting the following: “if
8 subjected to inspection by the types of detection
9 devices commonly used at airports for security
10 screening, would not generate”;

11 (2) in paragraph (2)—

12 (A) by striking subparagraph (B) and in-
13 serting the following:

14 “(B) the term ‘major component’, with respect
15 to a firearm—

16 “(i) means the slide or cylinder, or the
17 frame or receiver of the firearm; and

18 “(ii) in the case of a rifle or shotgun, in-
19 cludes the barrel of the firearm; and”;

20 (B) by striking subparagraph (C) and the
21 proviso that follows and inserting the following:

22 “(C) the term ‘Security Exemplar’ means an
23 object, to be fabricated at the direction of the Attor-
24 ney General, that is—

1 “(i) constructed of 3.7 ounces of material
2 type 17–4 PH stainless steel in a shape resem-
3 bling a handgun; and

4 “(ii) suitable for testing and calibrating
5 metal detectors.”;

6 (3) in paragraph (3)—

7 (A) in the first sentence, by inserting
8 after “of a firearm” the following: “, in-
9 cluding a prototype,”; and

10 (B) by striking the second sentence;

11 and

12 (4) in paragraph (5), by striking “shall not
13 apply to any firearm which” and all that follows and
14 inserting the following: “shall not apply to—

15 “(A) any firearm received by, in the possession
16 of, or under the control of the United States; or

17 “(B) the manufacture, importation, possession,
18 transfer, receipt, shipment, or delivery of a firearm
19 by a licensed manufacturer or licensed importer pur-
20 suant to an existing contract with the United
21 States.”.
