A BILL

To amend title 49, United States Code, to provide for private lactation areas in the terminals of large and medium hub airports, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Friendly Airports for
5 Mothers Act of 2015”.

1 **SEC. 2. LACTATION AREAS IN COMMERCIAL SERVICE AIR-**
2 **PORTS.**

3 (a) LACTATION AREA DEFINED.—Section 47102 of
4 title 49, United States Code, is amended—

5 (1) by redesignating paragraphs (10) through
6 (28) as paragraphs (11) through (29), respectively;
7 and

8 (2) by inserting after paragraph (9) the fol-
9 lowing:

10 “(10) ‘lactation area’ means a room or other lo-
11 cation in a commercial service airport that—

12 “(A) provides a location for members of
13 the public to express breast milk that is shield-
14 ed from view and free from intrusion from the
15 public;

16 “(B) has a door that can be locked;

17 “(C) includes a place to sit, a table or
18 other flat surface, and an electrical outlet;

19 “(D) is readily accessible to and usable by
20 individuals with disabilities, including individ-
21 uals who use wheelchairs; and

22 “(E) is not located in a restroom.”.

23 (b) PROJECT GRANT WRITTEN ASSURANCES FOR
24 LARGE AND MEDIUM HUB AIRPORTS.—

25 (1) IN GENERAL.—Section 47107(a) of such
26 title is amended—

1 (A) in paragraph (20) by striking “and” at
2 the end;

3 (B) in paragraph (21) by striking the pe-
4 riod at the end and inserting “; and”; and

5 (C) by adding at the end the following:

6 “(22) with respect to a large hub or medium
7 hub airport, the airport owner or operator will main-
8 tain a lactation area at each passenger terminal
9 building of the airport behind the airport security
10 screening area.”.

11 (2) APPLICABILITY.—The amendment made by
12 paragraph (1) shall apply to a project grant applica-
13 tion submitted for a fiscal year beginning on or after
14 the date that is 2 years after the date of enactment
15 of this Act.

16 (c) TERMINAL DEVELOPMENT COSTS.—Section
17 47119(a) of such title is amended by adding at the end
18 the following:

19 “(3) LACTATION AREAS.—In addition to the
20 projects described in paragraph (1), the Secretary
21 may approve a project for terminal development for
22 the construction or installation of a lactation area at
23 a commercial service airport.”.
