## **A BILL**

To repeal the Protection of Lawful Commerce in Arms Act,  
and provide for the discoverability and admissibility of  
gun trace information in civil proceedings.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Equal Access to Justice*  
5 *for Victims of Gun Violence Act of 2022”.*

6 **SEC. 2. REPEAL OF CERTAIN PROVISIONS OF THE PROTEC-**  
7 **TION OF LAWFUL COMMERCE IN ARMS ACT.**

8        *Sections 2 through 4 of the Protection of Lawful Com-*  
9 *merce in Arms Act (15 U.S.C. 7901–7903) are repealed.*

10 **SEC. 3. DISCOVERABILITY AND ADMISSIBILITY OF GUN**  
11 **TRACE INFORMATION IN CIVIL PRO-**  
12 **CEEDINGS.**

13        *The contents of the Firearms Trace System database*  
14 *maintained by the National Trace Center of the Bureau of*  
15 *Alcohol, Tobacco, Firearms and Explosives shall not be im-*  
16 *muned from legal process, shall be subject to subpoena or*  
17 *other discovery, shall be admissible as evidence, and may*  
18 *be used, relied on, or disclosed in any manner, and testi-*  
19 *mony or other evidence may be permitted based on the data,*  
20 *on the same basis as other information, in a civil action*  
21 *in any State (including the District of Columbia) or Fed-*  
22 *eral court or in an administrative proceeding.*
