1       AN ACT Relating to concealed pistol license renewal notices;  
2 amending RCW 9.41.070; and adding a new section to chapter 43.79 RCW.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4       **Sec. 1.** RCW 9.41.070 and 2011 c 294 s 1 are each amended to read  
5 as follows:

6       (1) The chief of police of a municipality or the sheriff of a  
7 county shall within thirty days after the filing of an application of  
8 any person, issue a license to such person to carry a pistol  
9 concealed on his or her person within this state for five years from  
10 date of issue, for the purposes of protection or while engaged in  
11 business, sport, or while traveling. However, if the applicant does  
12 not have a valid permanent Washington driver's license or Washington  
13 state identification card or has not been a resident of the state for  
14 the previous consecutive ninety days, the issuing authority shall  
15 have up to sixty days after the filing of the application to issue a  
16 license. The issuing authority shall not refuse to accept completed  
17 applications for concealed pistol licenses during regular business  
18 hours.

19       The applicant's constitutional right to bear arms shall not be  
20 denied, unless:

1 (a) He or she is ineligible to possess a firearm under the  
2 provisions of RCW 9.41.040 or 9.41.045, or is prohibited from  
3 possessing a firearm under federal law;

4 (b) The applicant's concealed pistol license is in a revoked  
5 status;

6 (c) He or she is under twenty-one years of age;

7 (d) He or she is subject to a court order or injunction regarding  
8 firearms pursuant to RCW 9A.46.080, 10.14.080, 10.99.040, 10.99.045,  
9 26.09.050, 26.09.060, 26.10.040, 26.10.115, 26.26.130, 26.50.060,  
10 26.50.070, or 26.26.590;

11 (e) He or she is free on bond or personal recognizance pending  
12 trial, appeal, or sentencing for a felony offense;

13 (f) He or she has an outstanding warrant for his or her arrest  
14 from any court of competent jurisdiction for a felony or misdemeanor;  
15 or

16 (g) He or she has been ordered to forfeit a firearm under RCW  
17 9.41.098(1)(e) within one year before filing an application to carry  
18 a pistol concealed on his or her person.

19 No person convicted of a felony may have his or her right to  
20 possess firearms restored or his or her privilege to carry a  
21 concealed pistol restored, unless the person has been granted relief  
22 from disabilities by the attorney general under 18 U.S.C. Sec.  
23 925(c), or RCW 9.41.040 (3) or (4) applies.

24 (2)(a) The issuing authority shall conduct a check through the  
25 national instant criminal background check system, the Washington  
26 state patrol electronic database, the department of social and health  
27 services electronic database, and with other agencies or resources as  
28 appropriate, to determine whether the applicant is ineligible under  
29 RCW 9.41.040 or 9.41.045 to possess a firearm, or is prohibited from  
30 possessing a firearm under federal law, and therefore ineligible for  
31 a concealed pistol license.

32 (b) The issuing authority shall deny a permit to anyone who is  
33 found to be prohibited from possessing a firearm under federal or  
34 state law.

35 (c) This subsection applies whether the applicant is applying for  
36 a new concealed pistol license or to renew a concealed pistol  
37 license.

38 (3) Any person whose firearms rights have been restricted and who  
39 has been granted relief from disabilities by the attorney general  
40 under 18 U.S.C. Sec. 925(c) or who is exempt under 18 U.S.C. Sec.

1 921(a)(20)(A) shall have his or her right to acquire, receive,  
2 transfer, ship, transport, carry, and possess firearms in accordance  
3 with Washington state law restored except as otherwise prohibited by  
4 this chapter.

5 (4) The license application shall bear the full name, residential  
6 address, telephone number at the option of the applicant, date and  
7 place of birth, race, gender, description, a complete set of  
8 fingerprints, and signature of the licensee, and the licensee's  
9 driver's license number or state identification card number if used  
10 for identification in applying for the license. A signed application  
11 for a concealed pistol license shall constitute a waiver of  
12 confidentiality and written request that the department of social and  
13 health services, mental health institutions, and other health care  
14 facilities release information relevant to the applicant's  
15 eligibility for a concealed pistol license to an inquiring court or  
16 law enforcement agency.

17 The application for an original license shall include two  
18 complete sets of fingerprints to be forwarded to the Washington state  
19 patrol.

20 The license and application shall contain a warning substantially  
21 as follows:

22 CAUTION: Although state and local laws do not differ, federal  
23 law and state law on the possession of firearms differ. If  
24 you are prohibited by federal law from possessing a firearm,  
25 you may be prosecuted in federal court. A state license is  
26 not a defense to a federal prosecution.

27 The license shall contain a description of the major differences  
28 between state and federal law and an explanation of the fact that  
29 local laws and ordinances on firearms are preempted by state law and  
30 must be consistent with state law.

31 The application shall contain questions about the applicant's  
32 eligibility under RCW 9.41.040 and federal law to possess a pistol,  
33 the applicant's place of birth, and whether the applicant is a United  
34 States citizen. If the applicant is not a United States citizen, the  
35 applicant must provide the applicant's country of citizenship, United  
36 States issued alien number or admission number, and the basis on  
37 which the applicant claims to be exempt from federal prohibitions on  
38 firearm possession by aliens. The applicant shall not be required to  
39 produce a birth certificate or other evidence of citizenship. A

1 person who is not a citizen of the United States shall, if  
2 applicable, meet the additional requirements of RCW 9.41.173 and  
3 produce proof of compliance with RCW 9.41.173 upon application. The  
4 license may be in triplicate or in a form to be prescribed by the  
5 department of licensing.

6 The original thereof shall be delivered to the licensee, the  
7 duplicate shall within seven days be sent to the director of  
8 licensing and the triplicate shall be preserved for six years, by the  
9 authority issuing the license.

10 The department of licensing shall make available to law  
11 enforcement and corrections agencies, in an on-line format, all  
12 information received under this subsection.

13 (5) The nonrefundable fee, paid upon application, for the  
14 original five-year license shall be thirty-six dollars plus  
15 additional charges imposed by the federal bureau of investigation  
16 that are passed on to the applicant. No other state or local branch  
17 or unit of government may impose any additional charges on the  
18 applicant for the issuance of the license.

19 The fee shall be distributed as follows:

20 (a) Fifteen dollars shall be paid to the state general fund;

21 (b) Four dollars shall be paid to the agency taking the  
22 fingerprints of the person licensed;

23 (c) Fourteen dollars shall be paid to the issuing authority for  
24 the purpose of enforcing this chapter; ~~((and))~~

25 (d) ~~((Three dollars))~~ Two dollars and sixteen cents to the  
26 firearms range account in the general fund; and

27 (e) Eighty-four cents to the concealed pistol license renewal  
28 notification account created in section 2 of this act.

29 (6) The nonrefundable fee for the renewal of such license shall  
30 be thirty-two dollars. No other branch or unit of government may  
31 impose any additional charges on the applicant for the renewal of the  
32 license.

33 The renewal fee shall be distributed as follows:

34 (a) Fifteen dollars shall be paid to the state general fund;

35 (b) Fourteen dollars shall be paid to the issuing authority for  
36 the purpose of enforcing this chapter; ~~((and))~~

37 (c) ~~((Three dollars))~~ Two dollars and sixteen cents to the  
38 firearms range account in the general fund; and

39 (d) Eighty-four cents to the concealed pistol license renewal  
40 notification account created in section 2 of this act.

1 (7) The nonrefundable fee for replacement of lost or damaged  
2 licenses is ten dollars to be paid to the issuing authority.

3 (8) Payment shall be by cash, check, or money order at the option  
4 of the applicant. Additional methods of payment may be allowed at the  
5 option of the issuing authority.

6 (9)(a) A licensee may renew a license if the licensee applies for  
7 renewal within ninety days before or after the expiration date of the  
8 license. A license so renewed shall take effect on the expiration  
9 date of the prior license. A licensee renewing after the expiration  
10 date of the license must pay a late renewal penalty of ten dollars in  
11 addition to the renewal fee specified in subsection (6) of this  
12 section. The fee shall be distributed as follows:

13 ((+a)) (i) Three dollars shall be deposited in the state  
14 wildlife account and used exclusively first for the printing and  
15 distribution of a pamphlet on the legal limits of the use of  
16 firearms, firearms safety, and the preemptive nature of state law,  
17 and subsequently the support of volunteer instructors in the basic  
18 firearms safety training program conducted by the department of fish  
19 and wildlife. The pamphlet shall be given to each applicant for a  
20 license; and

21 ((+b)) (ii) Seven dollars shall be paid to the issuing authority  
22 for the purpose of enforcing this chapter.

23 (b) Beginning with concealed pistol licenses that expire on or  
24 after August 1, 2018, the department of licensing shall mail a  
25 renewal notice approximately ninety days before the license  
26 expiration date to the licensee at the address listed on the  
27 concealed pistol license application, or to the licensee's new  
28 address if the licensee has notified the department of licensing of a  
29 change of address. The notice must contain the date the concealed  
30 pistol license will expire, the amount of renewal fee, the penalty  
31 for late renewal, and instructions on how to renew the license.

32 (10) Notwithstanding the requirements of subsections (1) through  
33 (9) of this section, the chief of police of the municipality or the  
34 sheriff of the county of the applicant's residence may issue a  
35 temporary emergency license for good cause pending review under  
36 subsection (1) of this section. However, a temporary emergency  
37 license issued under this subsection shall not exempt the holder of  
38 the license from any records check requirement. Temporary emergency  
39 licenses shall be easily distinguishable from regular licenses.

1 (11) A political subdivision of the state shall not modify the  
2 requirements of this section or chapter, nor may a political  
3 subdivision ask the applicant to voluntarily submit any information  
4 not required by this section.

5 (12) A person who knowingly makes a false statement regarding  
6 citizenship or identity on an application for a concealed pistol  
7 license is guilty of false swearing under RCW 9A.72.040. In addition  
8 to any other penalty provided for by law, the concealed pistol  
9 license of a person who knowingly makes a false statement shall be  
10 revoked, and the person shall be permanently ineligible for a  
11 concealed pistol license.

12 (13) A person may apply for a concealed pistol license:

13 (a) To the municipality or to the county in which the applicant  
14 resides if the applicant resides in a municipality;

15 (b) To the county in which the applicant resides if the applicant  
16 resides in an unincorporated area; or

17 (c) Anywhere in the state if the applicant is a nonresident.

18 (14) Any person who, as a member of the armed forces, including  
19 the national guard and armed forces reserves, is unable to renew his  
20 or her license under subsections (6) and (9) of this section because  
21 of the person's assignment, reassignment, or deployment for out-of-  
22 state military service may renew his or her license within ninety  
23 days after the person returns to this state from out-of-state  
24 military service, if the person provides the following to the issuing  
25 authority no later than ninety days after the person's date of  
26 discharge or assignment, reassignment, or deployment back to this  
27 state: (a) A copy of the person's original order designating the  
28 specific period of assignment, reassignment, or deployment for out-  
29 of-state military service, and (b) if appropriate, a copy of the  
30 person's discharge or amended or subsequent assignment, reassignment,  
31 or deployment order back to this state. A license so renewed under  
32 this subsection (14) shall take effect on the expiration date of the  
33 prior license. A licensee renewing after the expiration date of the  
34 license under this subsection (14) shall pay only the renewal fee  
35 specified in subsection (6) of this section and shall not be required  
36 to pay a late renewal penalty in addition to the renewal fee.

37 NEW SECTION. **Sec. 2.** A new section is added to chapter 43.79  
38 RCW to read as follows:

1       The concealed pistol license renewal notification account is  
2 created in the state treasury. All funds collected under RCW 9.41.070  
3 (5)(e) and (6)(d) must be deposited into the account. Expenditures  
4 from the account may be used only by the department of licensing for  
5 creation of a concealed pistol license renewal notification system  
6 and compliance with the notification requirement established in RCW  
7 9.41.070(9)(b).
